
Re: Corrected Request for No Review Letter –

Dear Ms. Mitchell:

On October 18, 2022, I provided correspondence regarding a proposed transaction including a request to confirm that the transaction would not require certificate of need review. In my letter, I referenced Triangle Springs as a licensed 43-bed psychiatric facility at 10901 World Trade Boulevard in Raleigh (License No: MHH0979) (“the Facility”). My description of the Facility mistakenly omitted reference to the Facility’s additional beds which consist of thirty-four (34) chemical dependency treatment beds. Please allow this letter to serve as a correction of my prior correspondence and please note that Triangle Springs is a 77-bed Facility, licensed for operation of forty-three (43) psychiatric beds and thirty-four (34) chemical dependency treatment beds. Please accept my apologies for any inconvenience in this regard.
