Dear Ms. Mitchell:

Our firm represents Greens at Weaverville LLC ("Weaverville"). This letter is intended to provide the Healthcare Planning and Certificate of Need Section (the "Agency") with prior written notice that our client plans to become the licensee of the skilled nursing facility licensed by SSC Weaverville Operating Company LLC d/b/a Brian Center Health & Rehabilitation/Weaverville, License No. NH0532 (the "Facility"), which is located at 78 Weaver Boulevard, Weaverville, North Carolina 28787. The change in licensure is scheduled to occur on July 1, 2022. Weaverville will be the operator and licensee of the Facility. The ownership of the bricks and mortar of the building will not change.

We understand that under North Carolina law, a change in the licensee does not require a CON and that by providing this notice, Weaverville's acquisition of the rights to operate the Facility is exempt from any review by the CON Section.
