This is Renee Mullings from Affect Therapeutics, Inc. I am the one with the 951 area code that moved from CA to KY lol. Thank you for speaking to me on the phone earlier today! Below are some bullet points regarding what Affect Therapeutics does and is regarding SUD treatment:

- Affect Therapeutics is a telehealth stimulant use disorder treatment organization.
- All groups and one on ones are conducted through HIPAA compliant video sharing.
- We are in the process of becoming certified through CARF
- We are a non-residential, ASAM Level 1 Outpatient only.
- Services are provided on a regularly scheduled basis through 2 one hour group sessions and 1 half hour counseling session per week.
- All clinical services are provided by licensed counselors.
- Affect Therapeutics' program model utilizes two tools for recovery: group therapy using the Matrix Curriculum, and community support, and contingency management.
- Group size will not go over 12 individuals per group
- All services shall be provided in accordance with the needs of the individual as identified in the assessment and treatment plan, as follows: (a) Individual counseling; (b) Group counseling; (c) Counseling with families or support system; (d) Substance-related and recovery-focused education, such as strategies for avoiding substance use or relapse, health problems related to substance use, motivational enhancement and strategies for achieving a substance-free lifestyle; and (e) Crisis intervention.
