Changes in a project include but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

### Re: Davie Medical Center (FID # 080175 Lic # H0171) Request for No Review Determination; Minor Procedure Room Development

Dear Ms. Mitchell and Mr. Yakaboski,

I am writing to request confirmation that the project described below for Davie Medical Center ("DMC") is not subject to certificate of need ("CON") review and that DMC does not need to obtain a CON prior to developing this project.

Davie Medical Center plans to develop a third minor procedure room, located within the main campus of DMC. The expected capital cost to develop this minor procedure room is \$2.3 million. Please reference **Exhibit 1** for the capital cost and **Exhibit 2** for line drawings of the proposed project.

NC General Statute § 131E-178 (a) states that "no person shall offer or develop a *new institutional health service* without first obtaining a certificate of need from the Department". NC General Statute § 131E-176 (16) provides the definition of a *new institutional health service*. The development of minor procedure rooms is not explicitly considered a new institutional health service pursuant to § 131E-176 (16); however, capital expenditures exceeding four million dollars to develop or expand a health service do require a certificate of need.

While the addition of a minor procedure room at DMC complies with the definition of a health service in § 131E-176 (9a), it does not meet the definition of a *new institutional health service* in § 131E-176 (16), as the capital cost is below the four-million-dollar threshold set forth in the statute. As such, DMC believes this project is not subject to CON review and that DMC does not need to obtain a CON prior to developing the third minor procedure room.

DMC respectfully requests that the CON Section confirm that, based on the facts stated above as well as the information included in the Exhibits, the development of a third minor procedure room at DMC does not require a CON.


