RE: Proposed 2009 State Medical Facilities Plan: Updates to Novant Health Operating Room

Inventory in Mecklenburg County

Dear Ms. McClanahan:

Since the Proposed 2009 State Medical Facilities Plan was published, two changes have occurred in the Novant Health operating room inventory in Charlotte which are not reflected in the operating room inventory included in the Proposed SMFP. First, on 4/15/08 the CON Section approved the consolidation of the three operating rooms and one endoscopy room at Presbyterian Same Day Surgery Center (PSDSC) located in downtown Charlotte with The Presbyterian Hospital (TPH) under the TPH acute care hospital license. As a result, the number of licensed operating rooms inventory at TPH increased by three, the number of endoscopy rooms at TPH increased by one. PSDSC has ceased to exist as a separately licensed ambulatory surgery facility.

Second, on June 26, 2008 the CON Section approved the relocation of four operating rooms from Presbyterian Orthopaedic Hospital to TPH. (TPH G-Wing CON application, Project I.D. # F-8040-08). The following table reflects the current licensed and CON approved operating rooms inventory for Novant's Mecklenburg County surgical facilities.
