Re: Data Reporting Errors in July 2013 SDR

Dear Mr. Smith and Ms. Pfeiffer

I am writing in connection with an inadvertent data reporting error by several dialysis facilities operated by Bio-Medical Applications of North Carolina ("BMA"), which was previously brought to the attention of the Medical Facilities Planning Section of DCSR by BMA. BMA submits this follow-up correspondence to avoid further confusion or errors in the CON process as a result of the reporting errors, and to ensure the integrity of the data in the Semiannual Dialysis report.

Summary

BMA previously notified the Division of Health Service Regulation that recent self-reported dialysis utilization data provided to the Medical Facilities Planning Section contained inadvertent errors as to the counties of residence of patients receiving dialysis from three BMA facilities located in Nash, Edgecombe and Scotland Counties. The data reporting errors resulted in erroneous need determinations for new dialysis stations in Nash and Scotland Counties in the July 2013 Semiannual Dialysis Report ("SDR").

BMA is concerned that the erroneous data may be relied upon by CON applicants and/or the CON Section in the upcoming September 2013 certificate of need application cycle that resulted from the need determinations for dialysis stations in Nash and Scotland Counties, and that the incorrect data may undermine the integrity of future SDRs if not corrected. Therefore, the purposes of this letter are (1) to notify the CON Section and potential applicants of the data reporting errors and provide the correct data that have been previously submitted to the Medical Facilities Planning Section, and (2) to respectfully request that the January 2014 SDR and subsequent SDRs incorporate the corrected data.

Background

Under Chapter 14 of the SMFP, the methodology for determining need for additional dialysis stations statewide is based on data contained in the Semiannual Dialysis Report (SDR). In the past, the data upon which need determinations were made was provided and reported by the Southeastern Kidney Council. However, beginning with the July 2013 SDR, the Medical Facilities Planning Section began utilizing utilization data that was self-reported by dialysis providers statewide. (See July 2013 SDR).

BMA made extensive efforts to ensure accurate reporting of data by all of its facilities statewide in anticipation of the first cycle of self-reporting data for the SDR, and 97% of its facilities accurately reported the relevant data. However, the data reported by three BMA facilities inadvertently contained errors. Those facilities were:

- Rocky Mount Kidney Center/BMA of Rocky Mount (Nash Co.)
- BMA of East Rocky Mount (Edgecombe Co.)
- BMA of Laurinburg (Scotland Co.)

Although the total utilization figures reported by those three facilities were correct, the three facilities erroneously reported that 100% of their dialysis patients were residents of the county in which each facility was located. In fact, all three facilities served residents of multiple counties. Consequently, BMA reported inaccurately high numbers of dialysis patients as residents of Nash, Edgecombe and Scotland Counties, and inaccurately low numbers of dialysis patients as residents of other nearby counties. The erroneous data reporting forms submitted by these three facilities are attached hereto as Appendix A.

The erroneous totals of dialysis patients reported by BMA were incorporated by the Medical Facilities Planning Section into (1) the totals of dialysis patients by county of residence, and (2) the resultant 5-year average annual change rate of each county's total ESRD patient population, both of which are used to calculate need for additional dialysis stations. Consequently, the accidental over-reporting of total dialysis patients in Nash and Scotland Counties resulted in erroneously high projected future populations of dialysis patients in those three counties, and erroneously low dialysis populations in other counties. (See July 2013 SDR, Table B). In the case of Nash and Scotland Counties, the erroneous data resulted in projected deficits of dialysis stations and therefore triggered need determinations for new dialysis stations in Nash County (19 stations) and Scotland County (11 stations). (See July 2013 SDR, Table B).

BMA Efforts to Correct Errors

BMA first discovered the reporting errors upon the release of the July 2013 SDR. BMA then promptly brought the reporting error to the attention of the Medical Facilities Planning Section and provided the corrected data from the relevant three facilities. Copies of the corrected data reporting forms containing the correct patient origin data are attached hereto as Appendix B. BMA requested that the SDR be amended to correct the erroneously reported data. The Agency has acknowledged that the data was reported in error, but responded on July 15 that it could not legally amend the SDR following its public release, and that only the Governor could do so. DHSR has declined BMA's request to seek an amendment of the SDR by the Governor, and therefore the need determinations in Nash and Scotland Counties remain in the SDR. CON applications for proposals in response to the need determinations are due on 16 September 2013.

Notification of CON Section and Applicants

Because utilization data in the SDR are commonly relied on by the CON applicants and by the CON Section, the data that was inadvertently misreported could result in confusion or inaccurate assumptions or projections in the upcoming CON review. Accordingly, BMA provides the attached information to ensure that potential applicants and the CON Section receive notice of the accurate data.

Request to Correct Errors in Subsequent SDR

Regardless of the inclusion of need determinations in the July 2013 SDR, the inadvertent data reporting errors will undermine the integrity of future SDRs if not corrected. Among other things, the excessive dialysis patient population figures for the period ending December 31, 2012 will skew the 5-year average growth rate figures upward for Nash, Edgecombe and Scotland Counties, which will inflate projections of future dialysis patient populations for several years to come. And as noted, the under-reported census data could potentially preclude true Need Determinations for other nearby counties.


Therefore, BMA respectfully requests that the Medical Facilities Planning Section revise its data in accordance with the corrected data previously provided (also provided with this letter) to ensure that the January 2014 SDR and all future SDRs rely on the accurate data.

Conclusion

BMA regrets the errors by its facilities in the first cycle of self-reporting utilization data, and is confident that its accuracy will improve in subsequent reporting cycles. Although it may not be possible to rectify the erroneous need determinations for Nash and Scotland Counties in the July 2013 SDR, BMA hopes that the information provided herein will help avoid any further confusion or inaccuracy as a result of the reporting errors, both in the CON application and review processes, and in future SDRs. 
