MEMORANDUM

TO: Interested Parties

RE: Proposed Adoption of Overnight Respite in Adult Day Care Rules

GS 150B-21.2, as amended by Session Law 2011-398, requires a rule-making body to notify certain individuals of its intent to adopt a permanent rule. It also requires notification of the date, time and location of the public hearing on the rule and any fiscal note that has been prepared in connection with the proposed rule.

Today, the Division of Health Service Regulation submitted form OAH 0300 to the Codifier of Rules, Office of Administrative Hearings, indicating our intent to adopt the following Overnight Respite in Adult Day Care rules, 10A NCAC 14D .0101, .0102, .0201, .0202, .0203, .0204, .0205, .0206, .0207, .0208, .0209, .0210, .0211, .0212, .0213, .0214, .0215, .0216, .0217, .0218, .0219, .0301, .0302, .0303, .0401, .0402, .0501, .0502, .0601, .0602, .0603, .0701, .0702, .0703, .0704, .0705, .0706, .0707, and .0801.

The public hearing is scheduled for August 7, 2012 at 10:00 a.m. in Room 131, Wright Building, 1201 Umstead Drive, Raleigh, NC 27603. The building is located on the Dorothea Dix Hospital campus. The Division is accepting public comments on this rule and fiscal note from June 30, 2012 – August 14, 2012. Comments can also be made at the public hearing. The proposed effective date of this rule is January 1, 2013.
