RE: CLIA and Public Health Requirements

Last week we sent information addressing infection control and CMS directives to assist in you in your infection control efforts. This week I am enclosing information regarding the Clinical Laboratory Improvement Amendments (CLIA) and how to apply for a waived certificate. Additionally, we are providing information regarding infection prevention as specified in General Statute 10A NCAC 41A. 0206.

Please note that both the statutory requirements as well as the waived CLIA certificate apply to adult care homes if you perform any invasive procedure including the use of needles to puncture skin (i.e. finger sticks).
