REVIEW CRITERIA FOR NEW INSTITUTIONAL HEALTH SERVICES

G.S. 131E-183(a) The Agency shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

 \mathbf{C}

DVA Renal Healthcare, Inc. (DVA) d/b/a Roxboro Dialysis ("the applicant") proposes to add two dialysis stations for a total of 37 stations upon project completion.

Need Determination

The 2015 State Medical Facilities Plan (2015 SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis stations. According to the July 2015 Semiannual Dialysis Report (SDR), the county need methodology shows there is a surplus of 2 dialysis stations in Person County, thus the applicant cannot apply to add additional stations based on the county need methodology. However, an applicant is eligible to apply for additional dialysis stations based on the facility need methodology if the utilization rate for the dialysis center, as reported in the most recent SDR, is at least 3.2 patients per station per week, or 80%. The applicant is eligible to apply for additional stations in its existing facility based on the

facility need methodology because the utilization rate reported for Roxboro Dialysis in the July 2015 SDR is 3.2 patients per station, or 80% (3.2 / 4 patients per station = 0.80). This utilization rate was calculated based on 112 in-center dialysis patients and 35 certified dialysis stations (112 patients / 35 stations = 3.2 patients per station).

Application of the facility need methodology indicates additional stations are needed for this facility, as illustrated in the following table:

As shown in the table above, based on the facility need methodology for dialysis stations, the potential number of stations needed is two stations. Step (C) of the facility need methodology states, "The facility may apply to expand to meet the need established ..., up to a maximum of ten stations." The applicant proposes to add two new stations, therefore the application is consistent with the facility need determination for dialysis stations.

Policies

There is one policy in the 2015 SMFP which is applicable to this review. POLICY GEN-3: BASIC PRINCIPLES on page 38 of the 2015 SMFP is applicable to this review because the facility need methodology is applicable to this review. Policy GEN -3 states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and maximizing healthcare value for

resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

Promote Safety and Quality

The applicant describes how it believes the proposed project would promote safety and quality in Section B-4(a), pages 9-10, Section O, page 52, and referenced exhibits. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote safety and quality.

Promote Equitable Access

The applicant describes how it believes the proposed project would promote equitable access in Section B-4(b), page 10, Section C, page 15, Section L, pages 45-49 and referenced exhibits. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote equitable access.

Maximize Healthcare Value

The applicant describes how it believes the proposed project would maximize healthcare value in Section B-4(c), page 11, Section F, pages 24-29, and Section N, page 51. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would maximize healthcare value.

Conclusion

In summary, the applicant adequately demonstrates that the proposal is consistent with the facility need methodology in the July 2015 SDR and Policy GEN-3. Therefore, the application is conforming to this criterion.

- (3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and, in particular, low income persons, racial and ethnic minorities, women, handicapped persons, the elderly, and other underserved groups are likely to have access to the services proposed.

The applicant proposes to add two new stations at Roxboro Dialysis, an existing facility located at 1005 Ridge Road in Roxboro. Upon completion of the proposed project, Roxboro Dialysis will be certified for 37 dialysis stations.

Population to be Served

On page 361, the 2015 SMFP defines the service area for dialysis services as the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining North Carolina counties is a separate dialysis station planning area. Thus, the service area for this facility consists of Person County. Facilities may also serve residents of counties not included in their service area.

In Section C-8, page 19, the applicant identifies the population served as of December 31, 2014, as illustrated below in the table:

The applicant does not project to serve any home hemodialysis patients. The applicant provides the assumptions and methodology for the projections above on pages 13-15.

The applicant adequately identifies the population it proposes to serve.

Analysis of Need

In Section C-2, page 15, the applicant refers the reader to Section B-2, page 7, where the applicant states the need for the proposed project is based on the facility need methodology. The discussion regarding the need determination found in Criteria (1) is incorporated herein by reference.

Projected Utilization

The applicant projects to serve 130 in-center dialysis patients at the end of the first operating year, which is 3.51 patients per station per week or an 87.8% utilization rate.

In Section C, pages 13-15, the applicant provides the assumptions and methodology used to project utilization which are summarized below:

- Based on information in the July 2015 SDR, Roxboro Dialysis had 112 in-center patients with a station utilization rate of 80%. This utilization was based on 112 in-center patients dialyzing on 35 stations. Ninety-three of the 112 patients were residents of Person County.
- The applicant used the Five Year Average Annual Change Rate (AACR) for Person County (6.6%) as reported in the July 2015 SDR to project future growth at Roxboro Dialysis from January 1, 2015 December 31, 2018.
- The applicant projects to serve 19 patients who reside outside of Person County. The applicant did not project growth for those 19 patients.

- The applicant projects to have 130 in-center patients by the end of Operating Year 1 (OY1) with a utilization rate of 87.8% or 3.51 patients per station per week and 138 in-center patients by the end of OY2, for a projected utilization rate of 93.2% or 3.73 patients per station per week.
- OY1 is Calendar Year 2017
- OY2 is Calendar Year 2018

The following table illustrates application of the assumptions and methodology.

As shown in the table above, the applicant projects to serve 111 Person County in-center patients in OY1 (2017) and 119 Person County in-center patients in OY2 (2018). The following table includes the total in-center patient projections, including the 19 in-center patients from other counties and states.

As shown in the previous table, at the end of OY1 (2017), the applicant projects an in-center patient census of 130 patients, which is a utilization rate of 87.8% or 3.51 patients per station per week (130 patients / 37 stations = 3.51; 3.51/4 = .8775 or 87.8%). At the end of OY2 (2018), the applicant projects an in-center patient census of 138 patients which is a utilization rate of 93.2% or 3.73 patients per station per week per week. The projected utilization of 3.2 patients per station per week for OY1 satisfies the 3.2 in-center patients per station per week threshold as required by 10A NCAC 14C .2203(b).

The applicant adequately demonstrates that projected utilization is based on reasonable and adequately supported assumptions regarding continued growth in the dialysis patient population in Person County.

Peritoneal Dialysis

The applicant currently provides peritoneal dialysis (PD) but this project proposes additional incenter dialysis stations. See Section C, pages 14-15 for the applicant's discussion of its PD services.

Access

In Section C-3, page 15, the applicant states:

"By policy, the proposed services will be made available to all residents in its service area without qualifications. The facility will serve patients without regard to race, sex, age, or handicap ... regardless of ethnic or socioeconomic situation."

In Section L, page 49, the applicant provides its historical payor mix which indicates that Medicare and Medicaid represented 77.6% of all dialysis services in calendar year 2014. The applicant confirms that low income and medically underinsured persons will continue to have access to all services provided by DVA and that the facility will conform to all federal, state and local codes and standards for handicapped access.

The applicant adequately demonstrates the extent to which all residents of the area, including underserved groups, are likely to have access to the proposed services.

Conclusion

In summary, the applicant adequately identifies the population to be served, adequately demonstrates the need that population has for the proposed project and the extent to which all residents of the area, including underserved groups, are likely to have access to the proposed services. Therefore, the application is conforming to this criterion.

(3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, handicapped persons, and other underserved groups and the elderly to obtain needed health care.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

In Section E-1, page 23, the applicant discusses the two alternatives considered prior to submitting this application, which include:

- 1. Maintain the Status Quo the applicant states that this option would not support the growth rate at the facility.
- 2. Apply to add two stations the applicant states the two-station expansion would help to meet the growing demand for dialysis services at Roxboro Dialysis Center.

The applicant also considered a third shift but determined that a third shift would be inconvenient for patients; and a facility at maximum capacity eliminates patient choice. After considering the alternatives above, the applicant believes the most effective alternative is to add two stations to the existing facility to ensure adequate access for the dialysis patients of Person County.

Furthermore, the application is conforming to all other statutory and regulatory review criteria, and thus, is approvable. A project that cannot be approved cannot be an effective alternative.

In summary, the applicant adequately demonstrates that this proposal is the least costly or most effective alternative to meet the identified need. Therefore, the application is conforming to this criterion and approved subject to the following conditions:

- 1. DVA Renal Healthcare, Inc. d/b/a Roxboro Dialysis shall materially comply with all representations made in the certificate of need application.
- 2. DVA Renal Healthcare, Inc. d/b/a Roxboro Dialysis shall add no more than two dialysis stations at Roxboro Dialysis for a total of no more than 37 certified dialysis stations which shall include any home hemodialysis training or isolation stations upon project completion.
- 3. DVA Renal Healthcare, Inc. d/b/a Roxboro Dialysis shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Agency in writing prior to issuance of the certificate of need.
- (5) Financial and operational projections for the project shall demonstrate the availability of funds for capital and operating needs as well as the immediate and long-term financial feasibility of the proposal, based upon reasonable projections of the costs of and charges for providing health services by the person proposing the service.

The applicant proposes to add two dialysis stations to Roxboro Dialysis, for a total of 37 dialysis stations at Roxboro Dialysis upon project completion.

Capital and Working Capital Costs

In the table in Section F-1, page 24 and supplemental information, the applicant provides the capital cost of the proposed project as summarized in the table below:

In Section F, pages 26-27, the applicant states that there are no working capital needs for the proposed project as Roxboro Dialysis Center is an existing facility.

Availability of Funds

In Section F, page 25, the applicant states that cash reserves/owner's equity is being used to finance the proposed project.

Exhibit F-5 contains a September 10, 2015 letter from the Vice President of Tax of DaVita HealthCare Partners, which states,

"We are submitting a Certificate of Need Application to expand our Roxboro Dialysis by two ESRD dialysis stations. The project calls for a capital expenditure of \$33,858. This letter will confirm that DaVita HealthCare Partners, Inc. has committed cash reserves in the total sum of \$33,858 for the project [sic] capital expenditure. DaVita HealthCare Partners, Inc. will make these funds, along with any other funds that are necessary for the development of the project, available to DVA Renal Healthcare."

In Section F, page 26, the applicant states:

"The financial strength of the company precludes any financial impact upon the operation and performance of the expansion that this application proposes. Therefore, there is no appreciable impact on either this application or from any that has been approved previously or is currently under review."

In Section F, page 26, the applicant refers to Exhibit F-7 for a copy of the most recent audited financial statements for DaVita HealthCare Partners, Inc. for years ended December 31, 2013 and 2014. As of December 31, 2014, DaVita HealthCare Partners, Inc. had \$965,241,000 in cash and cash equivalents, \$17,942,715,000 in total assets and \$5,360,311,000 in net equity (total assets less total liabilities). The applicant adequately demonstrates the availability of funds for the capital needs of the project.

Financial Feasibility

In Section R, Form B, page one, the applicant projects revenues and expenses for the first two full operating years of the project (2017-2018) and provides the assumptions used to project revenues and expenses in Section R, Form B, page two, as summarized in the table below.

The applicant projects that revenues will exceed operating expenses in each of the first two operating years. The applicant's projections of treatments and revenues are reasonable based on the number of in-center and PD patients projected for the first two operating years. The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference.

In Section H, page 31, the applicant provides projected staffing and salaries. Form A in Section R, page one, shows budgeted operating costs adequate to cover the projected staffing. The discussion regarding staffing found in Criterion (7) is incorporated herein by reference.

Conclusion

In summary, the applicant adequately demonstrates availability of sufficient funds for the capital needs of the project and adequately demonstrates the financial feasibility of the project is based on reasonable projections of revenues and operating costs. Therefore, the application is conforming to this criterion.

(6) The applicant shall demonstrate that the proposed project will not result in unnecessary duplication of existing or approved health service capabilities or facilities.

The applicant proposes to add two stations to Roxboro Dialysis using the facility need methodology. There will be 37 certified dialysis station at Roxboro Dialysis upon project completion.

On page 361, the 2015 SMFP defines the service area for dialysis services as the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining North Carolina counties is a separate dialysis station planning area. Thus, the service area for this facility consists of Person County. Facilities may also serve residents of counties not included in their service area.

Table A in the July 2015 SDR indicates there is only one existing dialysis facility in Person County, which is Roxboro Dialysis Center. According to the July 2015 SDR, Roxboro Dialysis operated at 80% capacity or 3.2 patients per station per week as of December 31, 2014.

In Section C, page 13, the applicant provides the total projected patients by county of residence for the proposed project, as shown in the following table:

As shown in the previous table, at the end of OY1 2017, the applicant is projecting an in-center patient census of 130 patients, for a utilization rate of 88% or 3.5 patients per station per week (130 patients / 37 stations = 3.51; 3.51 / 4 = .8783 or 88%). At the end of OY2 2018, the applicant is projecting an in-center patient census of 138 patients for a utilization rate of 93% or 3.72 patients per station per week. The projected utilization of 3.72 patients per station per week for OY1 satisfies the 3.2 in-center patients per station per week threshold as required by 10A NCAC 14C .2203(b).

The applicant adequately demonstrates that projected utilization is based on growth of in-center patients at the facility.

The applicant adequately demonstrates the need to add two stations to Roxboro Dialysis Center based on the number of in-center patients it proposes to serve. The discussion of analysis of need found in Criterion (3) is incorporated herein by reference. The discussion of competition found in Criterion (18a) is incorporated herein by reference.

The applicant adequately demonstrates that the proposal will not result in the unnecessary duplication of existing or approved health service capabilities or facilities in Person County. Consequently, the application is conforming to this criterion.

(7) The applicant shall show evidence of the availability of resources, including health manpower and management personnel, for the provision of the services proposed to be provided.

C

In Section H, page 31, the applicant provides the following table to illustrate current and projected staffing in full time equivalents (FTEs) for Roxboro Dialysis Center. The applicant states the Medical Director is not employed by the facility, and thus is not reflected on the staffing chart.

In Section I-3(a), page 37, the applicant identifies Dr. Eugene Kovalik as the Medical Director of the facility. In Exhibit I-3, the applicant provides a copy of an August 2015 letter signed by Dr. Kovalik of Duke University Medical Center, supporting the project and confirming his commitment to serve as Medical Director. In Section H-3, pages 32-33, the applicant states that vacant staff positions are filled by one or more of the following: the DaVita Teammate Recruiter, Teammate Referral Program and/or Student Internship Program.

The applicant documents the availability of adequate health manpower and management personnel, including the Medical Director, for the provision of the proposed dialysis services. Therefore, the application is conforming to this criterion.

(8) The applicant shall demonstrate that the provider of the proposed services will make available, or otherwise make arrangements for, the provision of the necessary ancillary and support services. The applicant shall also demonstrate that the proposed service will be coordinated with the existing health care system.

In Section I-1, page 36, the applicant lists the providers of the necessary ancillary and support services to be provided at the existing facility. The applicant discusses coordination with the existing health care system on pages 36-38. Exhibits I-1, and I-3 contain documents from Southern Pines Dialysis and Dr. Kovalik (Medical Director), respectively, as evidence of the necessary ancillary and support services. The applicant adequately demonstrates that the necessary ancillary and support services will be available and that the proposed services will be coordinated with the existing health care system. The information in Section I and corresponding exhibits is reasonable and supports a finding of conformity to this criterion.

(9) An applicant proposing to provide a substantial portion of the project's services to individuals not residing in the health service area in which the project is located, or in adjacent health service areas, shall document the special needs and circumstances that warrant service to these individuals.

- (12) Applications involving construction shall demonstrate that the cost, design, and means of construction proposed represent the most reasonable alternative, and that the construction project will not unduly increase the costs of providing health services by the person proposing the construction project or the costs and charges to the public of providing health services by other persons, and that applicable energy saving features have been incorporated into the construction plans.

(13) The applicant shall demonstrate the contribution of the proposed service in meeting the healthrelated needs of the elderly and of members of medically underserved groups, such as medically indigent or low income persons, Medicaid and Medicare recipients, racial and ethnic minorities, women, and handicapped persons, which have traditionally experienced difficulties in obtaining

equal access to the proposed services, particularly those needs identified in the State Health Plan as deserving of priority. For the purpose of determining the extent to which the proposed service will be accessible, the applicant shall show:

In Section L-1, pages 45-46, the applicant states, "Roxboro Dialysis, by policy, makes dialysis services available to all residents in its service area. ... Roxboro Dialysis helps uninsured, underinsured patients with identifying and applying for financial assistance; therefore, services are available to all patients including low income persons, racial and ethnic minorities, women, handicapped persons, elderly and other under-served persons."

In addition, on pages 46-48, the applicant discusses its financial policies to help the above named classification of persons. In Section L-7, page 49, the applicant states that Medicare/Medicaid represented 77.6% of all dialysis services provided at Roxboro Dialysis in calendar year 2014. The following table illustrates the historical payor sources for Roxboro Dialysis:

Although the majority of Medicaid eligibles are children under the age of 21, they represent a very small percentage of those persons who utilize the services offered by dialysis facilities. In 2014, over 85% of dialysis patients in North Carolina were 45 years of age and older. (Southeastern Kidney Council Network 6 Inc. 2014 Annual Report, page 59).

The Office of State Budget & Management (OSBM) maintains a website which provides historical and projected population data for each county in North Carolina, as well as data sorted by age, race or gender. But it does not include information on the number of elderly, handicapped, minorities or women utilizing health services.

However, the *Southeastern Kidney Council Network 6 Inc. 2014 Annual Report*, provides prevalence data on North Carolina dialysis patients by age, race and gender, and is summarized as follows, on page 59:

The applicant demonstrates that it currently provides adequate access to medically underserved populations. Therefore, the application is conforming to this criterion.

(b) Its past performance in meeting its obligation, if any, under any applicable regulations requiring provision of uncompensated care, community service, or access by minorities and handicapped persons to programs receiving federal assistance, including the existence of any civil rights access complaints against the applicant;

In Section L-3(d), page 48, the applicant states:

"Roxboro Dialysis has no obligation under any applicable federal regulation to provide uncompensated care, community service or access by minorities and handicapped persons except those obligations which are placed upon all medical facilities under Section 504 of the Rehabilitation Act of 1973 and its subsequent amendment in 1993. The facility has no obligation under the Hill Burton Act."

In Section L-6, page 48, the applicant states, "There have been no civil rights equal access filed within the last five years."

The application is conforming to this criterion.

(c) That the elderly and the medically underserved groups identified in this subdivision will be served by the applicant's proposed services and the extent to which each of these groups is expected to utilize the proposed services; and

C

In Section C-3, page 15, the applicant states:

"By policy, the proposed services will be made available to all residents in its service area without qualifications. ...

Payment will not be required upon admission. Therefore, services are available to all patients including low income persons, racial and ethnic minorities, women, handicapped persons, elderly and other under-served persons."

In Section L-3(c), page 48, the applicant states:

"Roxboro Dialysis makes no effort to categorize patients into groups according to their financial ability to obtain medical care. Physicians identify the patients in need of dialysis services and only then will a financial counselor and/or social worker evaluate their medical insurance and financial status."

In Section L-1(b), page 46, the applicant reports that it expects 77.6% of the patients who receive services at Roxboro Dialysis to have all or part of their services paid for by Medicare and Medicaid, as indicated below in the table.

On page 44, the applicant states it assumes the payor mix for Roxboro Dialysis will remain the same as its historical payor mix.

The applicant demonstrates that medically underserved populations will have adequate access to the proposed services. Therefore, the application is conforming to this criterion.

(d) That the applicant offers a range of means by which a person will have access to its services. Examples of a range of means are outpatient services, admission by house staff, and admission by personal physicians.

 \mathbf{C}

In Section L-4, page 48, the applicant states:

"Patients with End Stage Renal Disease have access to dialysis services upon referral by a nephrologist with privileges at Roxboro Dialysis. ... Patients from outside the facility catchment area requesting transfer to this facility will be processed in accordance with the facility transfer and transient policies, found at Exhibit L-3..."

The applicant adequately demonstrates that it will offer a range of means by which patients will have access to the proposed services. Therefore, the application is conforming to this criterion.

(14) The applicant shall demonstrate that the proposed health services accommodate the clinical needs of health professional training programs in the area, as applicable.

 \mathbf{C}

In Section M-1, page 48, the applicant states that Roxboro Dialysis has been offered as a clinical training site for student nurses attending Piedmont Community College.

Exhibit M-2 contains a copy of the student training agreement with Piedmont Community College. The information provided in Section M and referenced exhibits is reasonable and supports a finding of conformity to this criterion.

- (18a) The applicant shall demonstrate the expected effects of the proposed services on competition in the proposed service area, including how any enhanced competition will have a positive impact upon the cost effectiveness, quality, and access to the services proposed; and in the case of applications for services where competition between providers will not have a favorable impact on cost-effectiveness, quality, and access to the services proposed, the applicant shall demonstrate that its application is for a service on which competition will not have a favorable impact.

The applicant proposes to add two stations to Roxboro Dialysis using the facility need methodology. There will be 37 certified dialysis station at Roxboro Dialysis upon project completion.

On page 361, the 2015 SMFP defines the service area for dialysis services as the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of

the 94 remaining North Carolina counties is a separate dialysis station planning area. Thus, the service area for this facility consists of Person County. Facilities may also serve residents of counties not included in their service area.

Table A in the July 2015 SDR indicates there is only one existing dialysis facility in Person County, which is Roxboro Dialysis Center. According to the July 2015 SDR, Roxboro Dialysis operated at 80% of capacity or 3.2 patients per station per week as pf December 31, 2014.

In Section N-1, page 51, the applicant discusses how any enhanced competition in the service area will promote cost-effectiveness, quality and access to the proposed services. The applicant states:

"The expansion of Roxboro Dialysis will have no effect on competition in Person County. The project serves to address the needs of a population already served (or projected to be served, based on historical growth rates) by DVA Renal Healthcare, Inc.

The expansion of Roxboro Dialysis will enhance accessibility to dialysis for our patients, and by reducing the economic and physical burdens on our patients, this project will enhance the quality and cost effectiveness of our services because it will make it easier for patients, family members and others involved in the dialysis process to receive services."

See also Sections C, F, G, H, L and P where the applicant discusses the impact of the project on cost-effectiveness, quality and access.

The information provided by the applicant in the sections referenced above is reasonable and adequately demonstrates that any enhanced competition in the service area includes a positive impact on cost-effectiveness, quality and access to the proposed services. This determination is based on the information in the application, and the following analysis:

- The applicant adequately demonstrates the need for the proposed project and that it is an effective alternative. The discussions regarding analysis of need and alternatives found in Criteria (3) and (4), respectively, are incorporated herein by reference.
- The applicant adequately demonstrates that Roxboro Dialysis will continue to provide quality dialysis services. The discussions regarding quality found in Criteria (1) and (20) are incorporated herein by reference.
- The applicant demonstrates that Roxboro Dialysis will continue to provide adequate access to medically underserved populations. The discussions regarding access found in Criteria (1), (3) and (13) are incorporated herein by reference.

Therefore, the application is conforming to this criterion.

- (19) Repealed effective July 1, 1987.
- (20) An applicant already involved in the provision of health services shall provide evidence that quality care has been provided in the past.

In Section O, page 52, the applicant refers the reader to Section B-4(a), for its discussion regarding the methods it uses to ensure and maintain quality. In Section O-3, page 52, the applicant states:

"Exhibit O-3 lists facilities located in NC owned by the parent company DaVita HealthCare Partners Inc. that did not operate in compliance with the Medicare conditions of participation during the 18 month look back period. Each facility is currently in compliance."

In Exhibit O-3, the applicant states that three facilities were cited for deficiencies that resulted in a finding of Immediate Jeopardy during the 18 months immediately preceding the submittal of the application, as illustrated the table below:

Based on a review of this certificate of need application and publicly available information, the applicant adequately demonstrates that it has provided quality care during the 18 months immediately preceding the submittal of the application through the date of the decision. The application is conforming to this criterion.

- (b) The Department is authorized to adopt rules for the review of particular types of applications that will be used in addition to those criteria outlined in subsection (a) of this section and may vary according to the purpose for which a particular review is being conducted or the type of health service reviewed. No such rule adopted by the Department shall require an academic medical center teaching hospital, as defined by the State Medical Facilities Plan, to demonstrate that any facility or service at another hospital is being appropriately utilized in order for that academic medical center teaching hospital to be approved for the issuance of a certificate of need to develop any similar facility or service.

 - -C- In Section P, page 54, the applicant refers the reader to Section C-10, page 19, and states the number of transplants performed or referred by Roxboro Dialysis in 2014 was 0.
- .2202(a)(5) The number of patients currently on the transplant waiting list;
 - -C- In Section P, page 54, the applicant refers the reader to Section C-10, page 19, and states that Roxboro Dialysis had six patients on the transplant waiting list.
- .2202(a)(6) Hospital admission rates, by admission diagnosis, i.e., dialysis related versus non-dialysis related;
 - -C- In Section P, page 54, the applicant refers the reader to Section C-11, page 19 and states hospital admission rates as: Dialysis related 50 or 24.6%; Non-dialysis related 153 or 75.4%.

- .2202(a)(7) The number of patients with infectious disease, e.g., hepatitis, and the number converted to infectious status during the last calendar year.
 - -C- In Section P, page 55, the applicant refers the reader to Section C-10, page 19 and states that at Roxboro Dialysis, there were five persons with infectious disease and zero patients converted to an infectious status during the last calendar year.

 - -C- In Section P, page 56, the applicant refers the reader to Section C-1, page 13, where the applicant provides projected patient origin by county for Roxboro Dialysis, based on the patients who currently dialyze there. The applicant's assumptions and methodology for its projections are provided on pages 13-15 of the application. The discussion regarding population to be served found in Criterion (3) is incorporated herein by reference.
- .2202(b)(8) For new facilities, documentation that at least 80 percent of the anticipated patient population resides within 30 miles of the proposed facility.
 - -NA- This application is to add stations and does not propose a new facility.

 - -C- In Section P-1, page 57, the applicant refers the reader to Section H-4, page 33, where the applicant discusses its training at DVA facilities.
