REVIEW CRITERIA FOR NEW INSTITUTIONAL HEALTH SERVICES

G.S. 131E-183(a) The Agency shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

 \mathbf{C}

DVA Renal Healthcare, Inc. (DVA) d/b/a Forest Hills Dialysis ("the applicant") proposes to add five dialysis stations for a total of 31 stations at Forest Hills Dialysis upon completion of this project and Project I.D. # L-11132-16 (relocate five existing stations from Forest Hills Dialysis and five stations from Wilson Dialysis to develop Sharpsburg Dialysis).

Need Determination

The 2016 State Medical Facilities Plan (2016 SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis stations. According to the January 2016 Semiannual Dialysis Report (SDR), the county need methodology shows there is a deficit of two dialysis stations in Wilson County, thus the applicant could not apply to add two additional stations based on the county need methodology. However, the applicant can apply for

additional stations based on the facility need methodology. An applicant is eligible to apply for additional dialysis stations based on the facility need methodology if the utilization rate for the dialysis center, as reported in the most recent SDR, is at least 3.2 patients per station per week, or 80%. The applicant is eligible to apply for additional stations in its existing facility based on the facility need methodology because the utilization rate reported for Forest Hills Dialysis in the January 2016 SDR is 3.5806 patients per station per week, or 89.52% (3.5806 / 4 patients per station = 0.89515). This utilization rate was calculated based on 111 in-center dialysis patients and 31 certified dialysis stations (111 patients / 31 stations = 3.5806 patients per station per week).

Application of the facility need methodology indicates additional stations are needed for this facility, as illustrated in the following table:

As shown in the table above, based on the facility need methodology for dialysis stations, the potential number of stations needed is eight stations. Step (C) of the facility need methodology states, "The facility may apply to expand to meet the need established ..., up to a maximum of ten stations." The applicant proposes to add five new stations, therefore the application is consistent with the facility need determination for dialysis stations.

Policies

There is one policy in the 2016 SMFP which is applicable to this review. POLICY GEN-3: BASIC PRINCIPLES on page 39 of the 2016 SMFP is applicable to this review because the facility need methodology is applicable to this review. Policy GEN -3 states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

Promote Safety and Quality

The applicant describes how it believes the proposed project would promote safety and quality in Section B-4(a), pages 9-10, Section O, page 50, and referenced exhibits. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote safety and quality.

Promote Equitable Access

The applicant describes how it believes the proposed project would promote equitable access in Section B-4(b), page 10, Section C, page 15, Section L, pages 46-47 and referenced exhibits. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote equitable access.

Maximize Healthcare Value

The applicant describes how it believes the proposed project would maximize healthcare value in Section B-4(c), page 11 and Section N, page 49. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would maximize healthcare value

Conclusion

In summary, the applicant adequately demonstrates that the proposal is consistent with the facility need methodology in the January 2016 SDR and Policy GEN-3. Therefore, the application is conforming to this criterion.

(3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and, in particular, low income persons, racial and ethnic minorities, women, handicapped persons, the elderly, and other underserved groups are likely to have access to the services proposed.

The applicant proposes to add five new stations at Forest Hills Dialysis, an existing facility located at 1605 Medical Park Drive West in Wilson. Upon completion of this project and Project I.D. #L-11132-16 (relocate five stations from Forest Hills Dialysis and five stations from Wilson Dialysis to develop Sharpsburg Dialysis), Forest Hills Dialysis will be certified for a total of 31 dialysis stations.

Peritoneal and Home Hemodialysis

The applicant does not currently provide peritoneal dialysis (PD) or home hemodialysis (HHD) nor does the applicant propose to add those services in this project. The applicant states in Section I.1, page 34, that PD and HHD services will be provided at Wilson Dialysis. This application proposes the addition of in-center dialysis stations.

Population to be Served

On page 369, the 2016 SMFP defines the service area for dialysis services as the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining North Carolina counties is a separate dialysis station planning area. Thus, the service area for this facility consists of Wilson County. Facilities may also serve residents of counties not included in their service area.

In Section C-8, page 18, the applicant identifies the population served as of June 30, 2015, as illustrated below in the table:

The applicant provides the assumptions and methodology for the projections above on pages 13-15.

The applicant adequately identifies the population it proposes to serve.

Analysis of Need

In Section B-2, page 7, where the applicant states the need for the proposed project is based on the facility need methodology. The discussion regarding the need determination found in Criterion (1) is incorporated herein by reference.

Projected Utilization

The applicant projects to serve 120 in-center dialysis patients dialyzing on 31 stations at the end of the first operating year, which is 3.87 patients per station per week or an 96.8% utilization rate.

In Section C-1, pages 13-15, the applicant provides the assumptions and methodology used to project in-center utilization, which are summarized below.

- Based on information in the January 2016 SDR, as of June 30, 2015, Forest Hills Dialysis had 111 in-center patients which is 3.58 patients per station per week with a station utilization rate of 89.52%. This utilization was based on 111 in-center patients dialyzing on 31 stations. Ninety four of the 111 patients were residents of Wilson County.
- The applicant proposed in Project I.D. # L-11132-16 to relocate five stations from Forest Hills Dialysis and five stations from Wilson Dialysis. to develop the new ten station dialysis facility in Sharpsburg.
- The applicant projects that upon certification of Sharpsburg Dialysis in January 2018, nine
 patients currently receiving dialysis services at Forest Hills Dialysis will transfer their care
 to Sharpsburg Dialysis.
- The applicant projects that after the growth period beginning July 1, 2015 and ending December 31, 2017 that Forest Hills Dialysis will have 124 in-center patients with 107 of those patients being from Wilson County. Four of the 107 Wilson County residents are projected to transfer their care to the proposed Sharpsburg Dialysis facility. Additionally, five patients who reside outside of Wilson County are also projected to transfer their care to Sharpsburg Dialysis for a total of nine patients that will transfer their care from Forest Hills Dialysis to Sharpsburg Dialysis at the beginning of calendar year 2018.
- The applicant assumes that the in-center patients who are residents of Wilson County will increase at a rate commensurate with Wilson County's Five Year Average Annual Change Rate (AACR) of 5.4%, as published in Table B of the January 2016 Semi-Annual Dialysis Report (SDR), through the second operating year.
- OY1 is Calendar Year 2018
- OY2 is Calendar Year 2019

In Section C.1, page 14, the applicant provides the calculations used to arrive at the projected incenter patient census for Operating Years 1 and 2, as follows:

The applicant states, on page 14 that the number of projected patients for OY1 and OY2 are rounded down to the nearest whole number. Therefore, at the end of OY1 (CY 2018) the facility is projected to serve 120 in-center patients and at the end of OY2 (CY2019) the facility is projected to serve 126 in-center patients.

The projected utilization rates for the first two operating years are as follows:

- OY1: 3.87 patients per station per week, or 96.8% (120 patients / 31 stations = 3.87/4 = 0.9677 or 96.8%).
- OY2: 4.06 patients per station per week, or 101.6% (126 patients / 31 stations = 4.06/4 = 1.015 or 101.6%).

The projected utilization of 3.8 patients per station per week at the end of OY1 exceeds the minimum standard of 3.2 in-center patients per station per week required by 10A NCAC 14C .2203(b).

The applicant adequately demonstrates that projected utilization is based on reasonable and adequately supported assumptions regarding continued growth.

Peritoneal and Home Hemodialysis

The applicant does not currently provide peritoneal dialysis (PD) or home hemodialysis (HHD) nor does the applicant propose to add those services in this project. The applicant states in Section I.1, page 34, that PD and HHD services will be provided at Wilson Dialysis. This application proposes the addition of in-center dialysis stations.

Access

In Section C-3, page 15, the applicant states:

"By policy, the proposed services will be made available to all residents in its service area without qualifications. The facility will serve patients without regard to race, sex, age, or handicap ... regardless of ethnic or socioeconomic situation."

In Section L, page 47, the applicant provides its historical payor mix which indicates that Medicare and Medicaid represented 87.4% of all dialysis services in calendar year 2015. In Section L, page 44, the applicant projects that 87.4% of its patients will be Medicare or Medicaid recipients.

The applicant adequately demonstrates the extent to which all residents of the area, including underserved groups, are likely to have access to the proposed services.

Conclusion

In summary, the applicant adequately identifies the population to be served, adequately demonstrates the need that population has for the proposed project and the extent to which all residents of the area, including underserved groups, are likely to have access to the proposed services. Therefore, the application is conforming to this criterion.

(3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, handicapped persons, and other underserved groups and the elderly to obtain needed health care.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

CA

In Section E-1, page 22, the applicant discusses the three alternatives considered prior to submitting this application, which include:

- 1. Maintain the Status Quo the applicant states that this option would not support the growth rate at the facility.
- 2. Operating a third shift the applicant considered a third shift but determined that a third shift would be inconvenient for patients; and a facility at maximum capacity eliminates patient choice.
- 3. Apply to add five stations the applicant states the five-station expansion would help to meet the growing demand for dialysis services at Forest Hills Dialysis.

Furthermore, the application is conforming to all other statutory and regulatory review criteria, and thus, is approvable. A project that cannot be approved cannot be an effective alternative.

In summary, the applicant adequately demonstrates that this proposal is the least costly or most effective alternative to meet the identified need. Therefore, the application is conforming to this criterion and approved subject to the following conditions:

- 1. DVA Renal Healthcare, Inc. d/b/a Forest Hills Dialysis shall materially comply with all representations made in the certificate of need application.
- 2. DVA Renal Healthcare, Inc. d/b/a Forest Hills Dialysis shall add no more than five dialysis stations at Forest Hills Dialysis for a total of no more than 31 certified dialysis stations upon completion of this project and Project I.D. # L-11132-16 (relocate five stations from Forest Hills Dialysis and five stations from Wilson Dialysis to develop Sharpsburg Dialysis), which shall include any home hemodialysis training or isolation stations.
- 3. DVA Renal Healthcare, Inc. d/b/a Forest Hills Dialysis shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Agency in writing prior to issuance of the certificate of need.
- (5) Financial and operational projections for the project shall demonstrate the availability of funds for capital and operating needs as well as the immediate and long-term financial feasibility of the proposal, based upon reasonable projections of the costs of and charges for providing health services by the person proposing the service.

The applicant proposes to add five dialysis stations to Forest Hills Dialysis, for a total of 31 dialysis stations at Forest Hills Dialysis upon completion of this project and Project I.D. # L-11132-16.

Capital and Working Capital Costs

In the table in Section F-1, page 23, the applicant states there are no capital costs associated with the proposed project. Additionally, in Section F-10, pages 25-26, the applicant states that there are no working capital needs as Forest Hills Dialysis is an existing facility.

Financial Feasibility

The applicant projects revenues and expenses and provides assumptions in Section R, Form B, as summarized below in the table:

The applicant projects that revenues will exceed operating expenses in each of the first two operating years. The assumptions used in preparation of the pro formas, including the number of projected treatments are reasonable and adequately supported. The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference.

In Section H, page 30, the applicant provides projected staffing and salaries. Form A in Section R, page 1, shows budgeted operating costs adequate to cover the projected staffing. The discussion regarding staffing found in Criterion (7) is incorporated herein by reference.

Conclusion

In summary, the applicant adequately demonstrates the financial feasibility of the project is based on reasonable projections of revenues and operating costs. Therefore, the application is conforming to this criterion.

(6) The applicant shall demonstrate that the proposed project will not result in unnecessary duplication of existing or approved health service capabilities or facilities.

The applicant proposes to add five new stations at Forest Hills Dialysis, an existing facility located at 1605 Medical Park Drive West in Wilson. Upon completion of this project and Project I.D. #L-11132-16 (relocate five stations from Forest Hills Dialysis and five stations from Wilson Dialysis to develop Sharpsburg Dialysis), Forest Hills Dialysis will be certified for a total of 31 dialysis stations.

On page 369, the 2016 SMFP defines the service area for dialysis services as the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining North Carolina counties is a separate dialysis station planning area. Thus, the

service area for this facility consists of Wilson County. Facilities may also serve residents of counties not included in their service area.

The January 2016 SDR indicates there are two dialysis facilities in Wilson County, as follows:

As illustrated above, both of the existing facilities are owned and operated by the applicant and have a utilization rate over 85.0%. Therefore, all of the operational dialysis facilities in the county are well utilized.

In Section C-1, page 13, the applicant identifies the patient population it proposes to serve during the first two years of operation following completion of this project and Project I.D. # L-11132-16, as illustrated below in the table:

As shown in the previous table, at the end of OY1 2018, the applicant is projecting an in-center patient census of 120 patients, for a utilization rate of 96.8% or 3.87 patients per station per week (120 patients / 31 stations = 3.87; 3.87/4 = 0.9677 or 96.8%). At the end of OY2 2019, the applicant is projecting an in-center patient census of 126 patients for a utilization rate of 101.6% or 4.06 patients per station per week. The projected utilization of 3.87 patients per station per week for OY1 exceeds the 3.2 in-center patients per station per week threshold as required by 10A NCAC 14C .2203(b).

The applicant adequately demonstrates that projected utilization is based on growth of in-center patients at the facility.

The applicant adequately demonstrates the need to add five stations to Forest Hills Dialysis Center based on the number of in-center patients it proposes to serve. The discussion of analysis of need found in Criterion (3) is incorporated herein by reference.

The applicant adequately demonstrates that the proposal will not result in the unnecessary duplication of existing or approved health service capabilities or facilities in Wilson County. Consequently, the application is conforming to this criterion.

(7) The applicant shall show evidence of the availability of resources, including health manpower and management personnel, for the provision of the services proposed to be provided.

In Section H, page 30, the applicant provides a table to illustrate the current and projected staffing in full time equivalents (FTEs) for Forest Hills Dialysis Center, as illustrated below. The applicant states the Medical Director is not employed by the facility, and thus is not reflected on the staffing chart.

In Section I-3(a), page 35, the applicant identifies Dr. Will Bynum, as the Medical Director of the facility. In Exhibit I-3, the applicant provides a copy of a February 2016 letter signed by Dr. Bynum supporting the project and confirming his commitment to serve as Medical Director. In

Forest Hills Dialysis Project ID #L-11153-16 Page 13

Section H-3, pages 31-32, the applicant states that vacant staff positions are filled by one or more of the following: the DaVita Teammate Recruiter, Teammate Referral Program and/or Student Internship Program.

The applicant documents the availability of adequate health manpower and management personnel, including the Medical Director, for the provision of the proposed dialysis services. Therefore, the application is conforming to this criterion.

(8) The applicant shall demonstrate that the provider of the proposed services will make available, or otherwise make arrangements for, the provision of the necessary ancillary and support services. The applicant shall also demonstrate that the proposed service will be coordinated with the existing health care system.

 \mathbf{C}

In Section I-1, page 34, the applicant list the providers of the necessary ancillary and support services to be provided at the existing facility. The applicant discusses coordination with the existing health care system on pages 35-36. Exhibits I-1, and I-3 contain documents from DaVita, DaVita Laboratory Services, Inc., the home dialysis training agreement with Wilson Dialysis and Dr. Bynum (Medical Director), respectively, documenting availability of the necessary ancillary and support services. The applicant adequately demonstrates that the necessary ancillary and support services will be available and that the proposed services will be coordinated with the existing health care system. The information in Section I and corresponding exhibits is reasonable and supports a finding of conformity to this criterion.

(9) An applicant proposing to provide a substantial portion of the project's services to individuals not residing in the health service area in which the project is located, or in adjacent health service areas, shall document the special needs and circumstances that warrant service to these individuals.

- (10) When applicable, the applicant shall show that the special needs of health maintenance organizations will be fulfilled by the project. - (13) The applicant shall demonstrate the contribution of the proposed service in meeting the health-related needs of the elderly and of members of medically underserved groups, such as medically indigent or low income persons, Medicaid and Medicare recipients, racial and ethnic minorities, women, and handicapped persons, which have traditionally experienced difficulties in obtaining equal access to the proposed services, particularly those needs identified in the State Health Plan as deserving of priority. In Section L-1, pages 43-44, the applicant states, "Forest Hills Dialysis, by policy, makes dialysis services available to all residents in its service area. ... Forest Hills Dialysis helps uninsured/underinsured patients with identifying and applying for financial assistance; therefore, services are available to all patients including low income persons, racial and ethnic minorities, women, handicapped persons, elderly and other underserved persons."

In addition, on pages 44-46, the applicant discusses its financial policies to help the above named classification of persons. In Section L-7, page 47, the applicant states that Medicare/Medicaid represented 87.4% of all dialysis services provided at Forest Hills Dialysis in calendar year 2015. The following table illustrates the historical payor sources for Forest Hills Dialysis:

In 2014, over 85% of dialysis patients in North Carolina were 45 years of age and older and over 63% were non-Caucasian. (Southeastern Kidney Council Network 6 Inc. 2014 Annual Report, page 59).

The applicant demonstrates that it currently provides adequate access to medically underserved populations. Therefore, the application is conforming to this criterion.

(b) Its past performance in meeting its obligation, if any, under any applicable regulations requiring provision of uncompensated care, community service, or access by minorities and handicapped persons to programs receiving federal assistance, including the existence of any civil rights access complaints against the applicant;

In Section L-3(d), page 46, the applicant states:

"Forest Hills Dialysis has no obligation under any applicable federal regulation to provide uncompensated care, community service or access by minorities and handicapped persons except those obligations which are placed upon all medical facilities under Section 504 of the Rehabilitation Act of 1973 and its subsequent amendment in 1993. The facility has no obligation under the Hill Burton Act."

In Section L-6, page 46, the applicant states, "There have been no civil rights equal access filed within the last five years."

The application is conforming to this criterion.

(c) That the elderly and the medically underserved groups identified in this subdivision will be served by the applicant's proposed services and the extent to which each of these groups is expected to utilize the proposed services; and

In Section C-3, page 15, the applicant states:

"By policy, the proposed services will be made available to all residents in its service area without qualifications. ...

Payment will not be required upon admission. Therefore, services are available to all patients including low income persons, racial and ethnic minorities, women, handicapped persons, elderly and other under-served persons."

In Section L-3(c), page 46, the applicant states:

"Forest Hills Dialysis makes no effort to categorize patients into groups according to their financial ability to obtain medical care. Physicians identify the patients in need of dialysis services and only then will a financial counselor and/or social worker evaluate their medical insurance and financial status."

In Section L-1(b), page 44, the applicant reports that it expects 87.4% of the in-center patients who receive treatments at Forest Hills Dialysis to have all or part of their services paid for by Medicare and Medicaid, as indicated below in the table.

On page 44, the applicant states the projected payor mix for Forest Hills Dialysis will remain the same as its historical payor mix.

The applicant demonstrates that medically underserved populations will have adequate access to the proposed services. Therefore, the application is conforming to this criterion.

(d) That the applicant offers a range of means by which a person will have access to its services. Examples of a range of means are outpatient services, admission by house staff, and admission by personal physicians.

In Section L-4, page 46, the applicant states:

"Patients with End Stage Renal Disease have access to dialysis services upon referral by a nephrologist with privileges at Forest Hills Dialysis. ... Patients from outside the facility catchment area requesting transfer to this facility will be processed in accordance with the facility transfer and transient policies, found at Exhibit L-3. ..."

The applicant adequately demonstrates that it will offer a range of means by which patients will have access to the proposed services. Therefore, the application is conforming to this criterion.

(14) The applicant shall demonstrate that the proposed health services accommodate the clinical needs of health professional training programs in the area, as applicable.

In Section M-1, page 48, the applicant states that Forest Hills Dialysis has been offered as a clinical training site for student nurses attending Wilson Community College.

Exhibit M-2 contains a copy of the student training agreement with Wilson Community College. The information provided in Section M and referenced exhibits is reasonable and supports a finding of conformity to this criterion.

- (18a) The applicant shall demonstrate the expected effects of the proposed services on competition in the proposed service area, including how any enhanced competition will have a positive impact upon the cost effectiveness, quality, and access to the services proposed; and in the case of applications for services where competition between providers will not have a favorable impact on cost-effectiveness, quality, and access to the services proposed, the applicant shall demonstrate that its application is for a service on which competition will not have a favorable impact.

The applicant proposes to add five dialysis stations to Forest Hills Dialysis for a total of 31 stations upon completion of this project and Project I.D. # L-11132-16 (relocate five stations from Forest Hills Dialysis and five stations from Wilson Dialysis to develop Sharpsburg Dialysis).

On page 369, the 2016 SMFP defines the service area for dialysis services as the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining North Carolina counties is a separate dialysis station planning area. Thus, the service area for this facility consists of Wilson County. Facilities may also serve residents of counties not included in their service area.

The January 2016 SDR indicates there are two dialysis facilities in Wilson County, as follows:

As illustrated above, both of the existing facilities are owned and operated by the applicant and have a utilization rate over 85.0%. Therefore, all of the operational dialysis facilities in the county are well utilized.

In Section N-1, page 49, the applicant discusses how any enhanced competition in the service area will promote cost-effectiveness, quality and access to the proposed services. The applicant states:

"The expansion of Forest Hills Dialysis will have no effect on competition in Wilson County. Although the addition of stations at this facility serve to provide more patients another option to select a provider that gives them the highest quality service and better meets their needs, this project primarily serves to address the needs of a population already served (or projected to be served, based on historical growth rates) by DVA Healthcare Renal Care, Inc.

The expansion of Forest Hills Dialysis will enhance accessibility to dialysis for our patients, and by reducing the economic and physical burdens on our patients, this project will enhance the quality and cost effectiveness of our services because it will make it easier for patients, family members and others involved in the dialysis process to receive services."

See also Sections B, C, D, F, G, L and P where the applicant discusses the impact of the project on cost-effectiveness, quality and access.

The information provided by the applicant in the sections referenced above is reasonable and adequately demonstrates that any enhanced competition in the service area includes a positive impact on cost-effectiveness, quality and access to the proposed services. This determination is based on the information in the application, and the following analysis:

- The applicant adequately demonstrates the need for the proposed project and that it is an effective alternative. The discussions regarding analysis of need and alternatives found in Criteria (3) and (4), respectively, are incorporated herein by reference.
- The applicant adequately demonstrates that Forest Hills Dialysis will continue to provide quality dialysis services. The discussions regarding quality found in Criteria (1) and (20) are incorporated herein by reference.
- The applicant demonstrates that Forest Hills Dialysis will continue to provide adequate access to medically underserved populations. The discussions regarding access found in Criteria (1), (3) and (13) are incorporated herein by reference.

Therefore, the application is conforming to this criterion.

Based on a review of the information in the application and publicly available information, the applicant adequately demonstrates that it has provided quality care during the 18 months immediately preceding the submittal of the application through the date of the decision. The application is conforming to this criterion.

- (b) The Department is authorized to adopt rules for the review of particular types of applications that will be used in addition to those criteria outlined in subsection (a) of this section and may vary according to the purpose for which a particular review is being conducted or the type of
