### REVIEW CRITERIA FOR NEW INSTITUTIONAL HEALTH SERVICES

N.C. Gen. Stat. §131E-183(a) The Agency shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte proposes to add one dialysis station for a total of 26 stations upon completion of this project, Project I.D. #F-11092-15 (add four stations), and Project I.D. #F-10369-15 (relocate four stations to FMC Regal Oaks).

# **Need Determination**

The 2017 State Medical Facilities Plan (SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis stations. According to the January 2017 Semiannual Dialysis Report (SDR), the county need methodology shows there is no county need determination for Mecklenburg County. However, the applicant is eligible to apply for additional stations in its existing facility based on the facility need

methodology because the utilization rate reported for BMA of East Charlotte in the January 2017 SDR is 3.6 patients per station per week. This utilization rate was calculated based on 90 in-center dialysis patients and 25 certified dialysis stations as of June 30, 2016 (90 patients /25 stations = 3.60 patients per station per week). Application of the facility need methodology indicates that one additional station is needed for this facility, as illustrated in the following table.

As shown in the table above, based on the facility need methodology for dialysis stations, the potential number of stations needed is one station. Rounding to the nearest whole number is allowed in Step (v) of the facility need methodology, as stated in the January 2017 SDR. Step (C) of the facility need methodology states, "The facility may apply to expand to meet the need established ..., up to a maximum of ten stations." The applicant proposes to add one new station and, therefore, is consistent with the facility need determination for dialysis stations.

### **Policies**

There is one policy in the 2017 SMFP which is applicable to this review: *Policy GEN-3: Basic Principles. Policy GEN-3*, on page 33, states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and

maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

The applicant addresses *Policy GEN-3* as follows:

<u>Promote Safety and Quality</u> – The applicant describes how it believes the proposed project would promote safety and quality in Section B.4(a), page 12, Section O, pages 63-65, and Exhibit O-1. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote safety and quality.

<u>Promote Equitable Access</u> – The applicant describes how it believes the proposed project would promote equitable access in Section B.4(b), page 13, Section L, pages 55-56, and Exhibit L-1. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote equitable access.

<u>Maximize Healthcare Value</u> – The applicant describes how it believes the proposed project would maximize healthcare value in Section B.4(c) and (d), pages 14-15, Section C, pages 18-20, and Section N, page 61. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would maximize healthcare value.

The applicant adequately demonstrates how its projected volumes incorporate the concepts of quality, equitable access and maximum value for resources expended in meeting the facility need as identified by the applicant.

### Conclusion

In summary, the applicant adequately demonstrates that the application is consistent with the facility need determination in the January 2017 SDR and with *Policy GEN-3: Basic Principles*. Therefore, the application is conforming to this criterion.

- (3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and, in particular, low income persons, racial and ethnic minorities, women, handicapped persons, the elderly, and other underserved groups are likely to have access to the services proposed.

Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte proposes to add one dialysis station for a total of 26 stations upon completion of this project, Project I.D. #F-11092-15 (add four stations), and Project I.D. #F-10369-15 (relocate four stations to FMC Regal Oaks).

# Patient Origin

On page 373, the 2017 SMFP defines the service area for dialysis stations as "the planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." Thus, the service area is Mecklenburg County. Facilities may serve residents of counties not included in their service area.

In Section C.8, page 23, the applicant provides the historical in-center patient origin for BMA of East Charlotte as of December 31, 2016, which is summarized in the following table:

In Section C.1, page 18, the applicant provides the projected patient origin for BMA of East Charlotte for operating year one (OY1), Calendar Year (CY) 2019, and OY2, CY2020, following completion of the project, as follows:

The applicant provides the assumptions and methodologies used to project in-center patient origin in Section C.1, pages 18-20. The applicant adequately identifies the population to be served.

## **Analysis of Need**

In Section B.4, page 12, the applicant states the application is filed pursuant to the facility need methodology in the 2017 SMFP, and utilizes data from the January 2017 SDR to apply the facility need methodology, in Section B.2, page 10, to demonstrate how the facility qualifies for one additional station. In Section C.1, pages 18-19, the applicant provides the following assumptions for projecting in-center patients:

- 1. The current patient population at BMA of East Charlotte and who reside in Mecklenburg County are a part of the Mecklenburg County ESRD patient population as a whole and as such will increase at the Five Year Average Annual Change Rate (AACR) for Mecklenburg County of 5.0% as published in the January 2017 SDR.
- 2. Two patients from outside Mecklenburg County, one from Wake County and one from Virginia, are transient patients and therefore will not be projected to dialyze at BMA of East Charlotte.
- 3. Eight patients are projected to transfer from BMA of East Charlotte to Fresenius Medical Care (FMC) Regal Oaks (Project I.D. #F-10369-15) upon completion of that project. Therefore, eight patients will be subtracted from BMA of East Charlotte on June 30, 2017.
- 4. Seven patients are projected to transfer from BMA of East Charlotte to FMC Aldersgate (Project I.D. #F-11099-15) upon completion of that project. Therefore, seven patients will be subtracted from BMA of East Charlotte on December 31, 2017.
- 5. The proposed project is to be completed on December 31, 2018
- 6. The applicant states that OY1 will be Calendar Year (CY) 2019 and OY2 will be CY 2020.

# **Projected Utilization of In-Center Patients**

The applicant provides its methodology for projecting utilization for in-center patients for OY1 and OY2, in Section C.1, page 20, as follows:

The applicant states, on page 20, that it projects to serve 87 in-center patients, rounded down from 87.5 [87.6], or 3.35 patients per station per week (87 patients/ 26 dialysis stations = 3.35) by the end of OY1. Therefore, the applicant's projected utilization exceeds the minimum of 3.2 patients per station per week as of the end of the first operating year as required by 10A NCAC 14C .2203(b).

In summary, the applicant adequately identifies the population to be served and adequately demonstrates the need for seven additional dialysis stations at BMA of East Charlotte. Projected utilization is based on reasonable and adequately supported assumptions regarding continued growth.

# **Access**

In Section C.3, page 21, the applicant states that BMA has a long history of serving the underserved population in the state and that each facility serves "low-income persons, racial and ethnic minorities, women, handicapped persons, elderly, or other traditionally underserved

persons." The applicant further states that BMA will continue to provide access to all persons, including low income and medically underinsured persons. In Section L.7, page 59, the applicant states that 84.15% of BMA of East Charlotte's patients were Medicare or Medicaid recipients in CY2016. In Section L.1, page 58, the applicant projects that 83.13% of all of BMA of East Charlotte's patients will be Medicare or Medicaid recipients. The applicant adequately demonstrates the extent to which all residents of the service area, including underserved groups, are likely to have access to its services.

## Conclusion

In summary, the applicant adequately identifies the population to be served, demonstrates the need the population has for one additional station at BMA of East Charlotte, and demonstrates the extent to which all residents of the area, including underserved groups, are likely to have access to the services proposed. Therefore, the application is conforming to this criterion.

(3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, handicapped persons, and other underserved groups and the elderly to obtain needed health care.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

In Section E.1, page 26, the applicant states it considered one alternative prior to submitting this application for the proposed project, which was to maintain the status quo. The applicant states this alternative was not chosen because the projected utilization of the facility is over 80% and that failure to increase capacity would potentially restrict admissions. Therefore, this was not an effective alternative.

In Section C.2, pages 20-21, the applicant states that the projected population at BMA of East Charlotte has a need for the additional station and that "failure to add this station will lead to higher utilization rates at the facility." Therefore, the proposed alternative represented in the application is the most effective alternative to meet the identified need.

Furthermore, the application is conforming to all other statutory and regulatory review criteria, and thus, is approvable. A project that cannot be approved cannot be an effective alternative.

In summary, the applicant adequately demonstrates that the proposal is the least costly or most effective alternative to meet the identified need. Therefore, the application is conforming to this criterion and approved subject to the following conditions.

- 1. Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte shall materially comply with all representations made in the certificate of need application.
- 2. Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte shall develop and operate no more than one additional dialysis station for a total of no more than 26 certified stations upon completion of the project, Project I.D. #F-11092-15 (add 4 stations), and Project I.D. #F-10369-15 (relocate 4 stations) which shall include any isolation or home hemodialysis stations.
- 3. Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte shall install plumbing and electrical wiring through the walls for one additional dialysis station for a total of no more than 26 dialysis stations which shall include any home hemodialysis training or isolation stations.
- 4. Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Healthcare Planning and Certificate of Need Section in writing prior to issuance of the certificate of need.
- (5) Financial and operational projections for the project shall demonstrate the availability of funds for capital and operating needs as well as the immediate and long-term financial feasibility of the proposal, based upon reasonable projections of the costs of and charges for providing health services by the person proposing the service.

Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte proposes to add one dialysis station for a total of 26 stations upon completion of this project, Project I.D. #F-11092-15 (add four stations), and Project I.D. #F-10369-15 (relocate 4 stations to FMC Regal Oaks).

### **Capital and Working Capital Costs**

In Section F.2, page 28, the applicant projects that the capital costs of the project will be \$3,750 which will consist of \$750 for (RO) water treatment equipment and \$3,000 for other equipment and furniture. In Sections F.10-F.12, page 31, the applicant states there will be no start-up expenses or initial operating expenses incurred for this project since BMA of East Charlotte is an existing facility.

### **Availability of Funds**

In Section F.2, page 29, the applicant states it will finance the capital costs with accumulated reserves/owner's equity. Exhibit F-1 contains a letter dated March 15, 2017 signed by the Senior Vice President and Treasurer of Fresenius Medical Care Holdings, Inc., the parent company of the applicant, which states that it has committed cash reserves in the amount of

\$3,750 for the proposed project. In Exhibit F-2, the applicant provides the consolidated financial statements for Fresenius Medical Care Holdings, Inc. and Subsidiaries which indicates that as of December 31, 2015, it had \$249,300,000 in cash and cash equivalents, \$19,332,539,000 in total assets and \$10,144,288,000 in net assets (total assets less total liabilities). The applicant adequately demonstrates that sufficient funds will be available for the capital needs of the project.

## **Financial Feasibility**

The applicant provides pro forma financial statements for the first two years of the project in Section R. In Section R, Form C of the pro formas, the applicant provides the allowable charges per treatment for each payment source in OY1, as illustrated in the table below:

The applicant provides pro forma financial statements for the first two operating years of the project following completion. In Form B, the applicant projects that revenues will exceed operating expenses in the first two operating years of the project, as shown in the table below.

The assumptions used by the applicant in preparation of the pro forma financial statements are reasonable, including projected utilization, costs and charges. See the financial section of the application for the assumptions used regarding costs and charges. The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference. The applicant adequately demonstrates sufficient funds for the operating needs of the proposal and that the financial feasibility of the proposal is based upon reasonable projections of costs and charges.

# **Conclusion**

In summary, the applicant adequately demonstrates that the financial feasibility of the proposal is based upon reasonable and adequately supported assumptions regarding projected utilization, revenues (charges) and operating costs. Therefore, the application is conforming to this criterion.

(6) The applicant shall demonstrate that the proposed project will not result in unnecessary duplication of existing or approved health service capabilities or facilities.

Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte proposes to add one dialysis station for a total of 26 stations upon completion of this project, Project I.D. #F-11092-15 (add four stations), and Project I.D. #F-10369-15 (relocate four stations to FMC Regal Oaks).

On page 373, the 2017 SMFP defines the service area for dialysis stations as "the planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." Thus, the service area is Mecklenburg County. Facilities may serve residents of counties not included in their service area.

According to the January 2017 SDR, there are 22 dialysis facilities in Mecklenburg County. Of these, 16 are operational and six are under development. The applicant or its parent company owns and operates 11 dialysis facilities, DaVita Healthcare Partners, Inc. (DaVita) operates eight facilities, DSI Renal, Inc. (DSI) operates two facilities, and Carolinas Medical Center (CMC) operates one facility, as shown in the table below.

As shown in the table above, all seven of BMA's operational dialysis facilities are operating above 80% utilization (3.2 patients per station per week). Four of BMA's dialysis facilities are under development. Five of the 16 operational dialysis facilities in the county are operating below 80% utilization, two DSI facilities, one CMC facility, and two DaVita facilities.

The applicant proposes to add one dialysis station for a total of 26 dialysis station upon completion of the project. According to Table B in the January 2017 SDR, there is a surplus of 22 dialysis stations in Mecklenburg County. However, the applicant is applying for additional stations based on the facility need methodology. As of June 30, 2016, BMA of East Charlotte was serving 90 patients on 25 dialysis stations per week, which is 3.6 patients per station per week or 90% of capacity. The applicant does not propose to establish a new facility. In Section C.1, page 18, of the application, the applicant adequately demonstrates that BMA of East Charlotte will serve a total of 87 in-center patients on 26 dialysis stations at the end of OY1 (CY2019), for a utilization rate of 3.35 patients per station per week, or 83.7% of capacity (87/ 26 = 3.35; 3.35/ 4 = 83.7%). Therefore, the facility is expected to

serve more than 3.2 patients per station per week at the end of the first operating year as required by 10A NCAC 14C .2203(b). The applicant adequately demonstrates the need to develop one additional dialysis station at the existing facility based on the number of incenter patients it proposes to serve.

The applicant adequately demonstrates that the proposal will not result in the unnecessary duplication of existing or approved dialysis stations or facilities. Therefore, the application is conforming to this criterion.

(7) The applicant shall show evidence of the availability of resources, including health manpower and management personnel, for the provision of the services proposed to be provided.

In Section H.1, page 40, the applicant provides the current and projected staffing for the facility. The facility is currently staffed with 20.30 full-time equivalent (FTE) positions, including 15.0 Direct Care FTE positions. Upon completion of the project, the facility will add a 0.50 FTE RN position and a 0.50 FTE Patient Care Technician (PCT) for a facility total of 21.30 FTE positions. Projected direct care staff in OY2, from Section H.7, page 43, is shown in the following table:

In Section H.6, page 42, the applicant states that dialysis services will be available from 6:00 AM to 4:00 PM, Monday through Saturday, for a total of 10 hours per day/ 60 hours per week.

In Section H.3, page 41, the applicant states that it does not anticipate any difficulties filling staff positions and that it employs aggressive recruiting and advertising efforts to hire staff, along with providing a range of benefits and competitive salaries to attract and maintain staff. Exhibit I-5 contains a copy of a letter from Todd Griffith, M.D., stating his support for the project and his willingness to continue serving as the Medical Director for the facility. The applicant adequately demonstrates the availability of sufficient health manpower and management personnel to provide the proposed services. Therefore, the application is conforming to this criterion.

(8) The applicant shall demonstrate that the provider of the proposed services will make available, or otherwise make arrangements for, the provision of the necessary ancillary and

support services. The applicant shall also demonstrate that the proposed service will be coordinated with the existing health care system.

In Section I.1, page 44, the applicant includes a list of providers of the necessary ancillary and support services. Exhibits I-1, I-2, I-3 and I-4 contain copies of agreements with providers for home dialysis training services, laboratory services, hospital services, and transplantation services, respectively.

In Section I.3, page 46, the applicant provides a listing of nephrologists at Metrolina Nephrology Associates who have agreed to provide medical coverage at the facility and who have expressed support for the project. In addition, the applicant states, on page 47, that BMA facilities in Charlotte and Mecklenburg County have developed relationships with the area medical community over many years. Moreover, Exhibit I-5 contains a letter from the medical director of the facility that expresses his support for the proposed project.

The applicant adequately demonstrates the availability of sufficient health manpower and management personnel to provide the proposed services. Therefore, the application is conforming to this criterion.

The IPRO ESRD Network of the South Atlantic Network 6 (IPRO SA Network 6) consists of North Carolina, South Carolina and Georgia. IPRO SA Network 6 provides a 2015 Annual Report which includes aggregate ESRD patient data from all three states. However, a comparison of the *Southeastern Kidney Council Network 6 Inc. 2014 Annual Report* percentages for North Carolina and the aggregate data for all three states in IPRO SA Network 6 shows very little variance; therefore the statistics for IPRO SA Network 6 are representative of North Carolina.

The IPRO SA Network 6 provides prevalence data on dialysis patients by age, race, and gender in its 2015 annual report, pages 27-28<sup>2</sup>. In 2015, over 85% of dialysis patients in Network 6 were 45 years of age and older, over 67% were non-Caucasian and 45% were female. (IPRO SA Network 6).

The applicant demonstrates that it currently provides adequate access to medically underserved populations. Therefore, the application is conforming to this criterion.

In Section L.1, page 56, the applicant provides the assumptions used to project payor mix. The applicant states that the projected payor mix is based on the facility's recent performance. The applicant demonstrates that medically underserved groups will have adequate access to the services offered at BMA of East Charlotte. Therefore, the application is conforming to this criterion.

In Section L.4, page 58, the applicant describes the range of means by which a person will have access to the dialysis services at BMA of East Charlotte. Any nephrologist may apply for privileges to admit patients and they make take referrals from other nephrologists, other physicians, or hospital emergency rooms. The applicant adequately demonstrates that the facility will offer a range of means by which patients will have access to dialysis services. Therefore, the application is conforming to this criterion.

Bio-Medical Applications of North Carolina, Inc. d/b/a BMA of East Charlotte proposes to add one dialysis station for a total of 26 stations upon completion of this project, Project I.D. #F-11092-15 (add four stations), and Project I.D. #F-10369-15 (relocate four stations to FMC Regal Oaks).

On page 373, the 2017 SMFP defines the service area for dialysis stations as "the planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." Thus, the service area is Mecklenburg County. Facilities may serve residents of counties not included in their service area.

According to the January 2017 SDR, there are 22 dialysis facilities in Mecklenburg County. Of these, 16 are operational and six are under development. A listing of these facilities is provided below:

As shown in the table above, all seven of BMA's operational dialysis facilities are operating above 80% utilization (3.2 patients per station per week). Four of BMA's dialysis facilities are under development. Five of the 16 operational dialysis facilities in the county are operating below 80% utilization, two DSI facilities, one CMC facility, and two DaVita facilities.

In Section N.1, page 61, the applicant discusses how any enhanced competition will have a positive impact on the cost-effectiveness, quality and access to the proposed services. The applicant states,

"BMA facilities are compelled to operate at maximum dollar efficiency as a result of fixed reimbursement rates from Medicare and Medicaid. ...In this application, BMA

projects that greater than 83% of the In-center patients will be relying upon government payors (Medicare /Medicaid / VA). The facility must capitalize upon every opportunity for efficiency.

...

This proposal will certainly not adversely affect quality, but rather, enhance the quality of the ESRD patients' lives by offering another convenient venue for dialysis care and treatment."

See also Sections A, B, C, H, K, L, N and O where the applicant discusses the impact of the project on cost-effectiveness, quality and access.

The information in the application is reasonable and adequately demonstrates that any enhanced competition in the service area includes a positive impact on the cost-effectiveness, quality and access to the proposed services. This determination is based on the information in the application and the following analysis:

- The applicant adequately demonstrates the need for the project and that it is a cost-effective alternative. The discussions regarding the analysis of need and alternatives found in Criteria (3) and (4), respectively, are incorporated herein by reference.
- The applicant adequately demonstrates it will provide quality services. The

In Exhibit A-4, the applicant identifies the kidney disease treatment centers located in North Carolina that it or an affiliated company owns and operates. In Section O.2, page 65, and Section O.3, pages 66-67, the applicant identifies three of its facilities, BMA of East Charlotte, BMA East Rocky Mount, and RAI West College Warsaw that were cited in the past 18 months for deficiencies in compliance with 42 CFR Part 494, the Centers for Medicare and Medicaid (CMS) Conditions for Coverage of ESRD facilities. The applicant provides documentation regarding the deficiencies and subsequent compliance with CMS Conditions for Coverage in Exhibits O-2, O-3, and in supplemental information. The applicant states, on pages 65 and 67, and in supplemental information, that all three facilities

are back in full compliance with CMS Guidelines as of the date of submission of this application. Based on a review of the certificate of need application and publicly available data, the applicant adequately demonstrates that it has provided quality care during the 18 months immediately preceding the submittal of the application through the date of the decision. The application is conforming to this criterion.
