REVIEW CRITERIA FOR NEW INSTITUTIONAL HEALTH SERVICES

N.C. Gen. Stat. §131E-183(a) The Agency shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

Total Renal Care of North Carolina, LLC (TRC or the applicant), d/b/a Southeastern Dialysis Center Elizabethtown (SEDC-Elizabethtown) proposes to add three stations to the existing facility for a total of 19 stations upon completion of this project and Project I.D. #N-11130-16 (relocate 10 stations to Bladenboro Dialysis). SEDC-Elizabethtown offers a peritoneal dialysis (PD) program; however, the facility does not currently offer a home hemodialysis (HH) program. The parent company of TRC is DaVita, Inc. (DaVita).

Need Determination

The 2018 State Medical Facilities Plan (SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis stations. According to

the July 2018 Semiannual Dialysis Report (SDR), the county need methodology shows there is no county need determination for Bladen County. However, the applicant is eligible to apply for additional stations in its existing facility based on the facility need methodology because the utilization rate reported for SEDC-Elizabethtown in the July 2018 SDR is 3.269 patients per station per week. This utilization rate was calculated based on 85 in-center dialysis patients and 26 certified dialysis stations as of December 31, 2017 (85 patients / 26 stations = 3.269 patients per station per week). Application of the facility need methodology indicates that five additional stations are needed for this facility, as illustrated in the following table.

As shown in the table above, based on the facility need methodology for dialysis stations, the potential number of stations needed is five stations. Rounding to the nearest whole number is allowed in Step (v) of the facility need methodology, as stated in the July 2018 SDR. Step (C) of the facility need methodology states, "The facility may apply to expand to meet the need established ..., up to a maximum of ten stations." The applicant proposes to add three new stations and, therefore, is consistent with the facility need determination for dialysis stations.

Policies

There is one policy in the 2018 SMFP which is applicable to this review: *Policy GEN-3: Basic Principles* on page 233 of the 2018 SMFP is applicable to this review because the facility need methodology is applicable to this review. Policy GEN-3 states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical

Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

The applicant addresses *Policy GEN-3* as follows:

<u>Promote Safety and Quality</u> – The applicant describes how it believes the proposed project would promote safety and quality in Section B.4(a), pages 9-10, Section K.1(g), page 40, Section N, page 50, Section O, page 51, and Exhibits O-2 and O-3. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote safety and quality.

<u>Promote Equitable Access</u> – The applicant describes how it believes the proposed project would promote equitable access in Section B.4(b), page 10, Section C.3, page 16, Section L, pages 44-48, Exhibit L-3 and Section N, page 50. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote equitable access.

<u>Maximize Healthcare Value</u> – The applicant describes how it believes the proposed project would maximize healthcare value in Section B.4(c) and (d), page 11, Section C, pages 13 - 16, Section F, pages 28 - 29, Section K, pages 39 - 40 and Section N, page 50. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would maximize healthcare value.

The applicant adequately demonstrates how its projected volumes incorporate the concepts of quality, equitable access and maximum value for resources expended in meeting the facility need as identified by the applicant. The application is consistent with Policy GEN-3.

The Agency reviewed the:

- Exhibits to the application

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

(3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and, in particular, low income persons, racial and ethnic minorities, women, handicapped persons, the elderly, and other underserved groups are likely to have access to the services proposed.

TRC proposes to add three stations to the existing facility for a total of 19 stations upon completion of this project and Project I.D. #N-11130-16 (relocate 10 stations to Bladenboro Dialysis). SEDC-Elizabethtown offers a peritoneal dialysis program however, the facility does not currently offer a home hemodialysis program.

Patient Origin

On page 365, the 2018 SMFP defines the service area for dialysis stations as "the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." SEDC-Elizabethtown is located in Bladen County. Thus, the service area for this facility consists of Bladen County. Facilities may also serve residents of counties not included in their service area.

The following tables illustrate current and projected patient origin for in-center (IC) patients and peritoneal dialysis (PD) patients.

In Section C, pages 13 - 15, the applicant provides the assumptions and methodology used to project its patient origin. The applicant's assumptions are reasonable and adequately supported.

Analysis of Need

In Section B.2, page 7, the applicant states the application is filed pursuant to the facility need methodology in the 2018 SMFP utilizing data from the January and July 2018 SDRs. The facility need methodology shows a need for five dialysis stations and the proposed project is to add three additional dialysis stations at SEDC-Elizabethtown.

In Section C, pages 13 - 19, the applicant explains why it believes the population projected to utilize the proposed services needs the proposed services. On pages 13 - 15, the applicant describes its need methodology assumptions for projecting utilization of the proposed facility as follows:

- The July 2018 SDR shows that SEDC-Elizabethtown operated at a utilization rate of 81.73% (3.3 patients per station per week) as of December 31, 2017, and had 85 in-center patients. The applicant states that 75 of the 85 patients were residents of Bladen County with 10 patients residing in other counties.
- In Project ID #N-11130-16, the applicant was approved to develop Bladenboro Dialysis by relocating ten stations and transferring 34 in-center patients from SEDC-Elizabethtown. The applicant also projected in that application that 18 PD patients would transfer their care to Bladenboro Dialysis.
- The applicant projects the first full operating year of this project will be January 1, 2020 December 31, 2020 (CY 2020) and the second full operating year will be January 1, 2021 December 31, 2021 (CY 2021).
- TRC assumes the Bladen County in-center patient population will increase at the Bladen County Five Year Average Annual Change Rate (AACR) of 7.0% per year.
- The applicant projects no growth for patients who utilize the facility and live in other counties.

The information is reasonable and adequately supported because the proposed project is consistent with the facility need methodology.

Projected Utilization

In-Center Patients

The applicant's projected utilization methodology, based on its stated assumptions, is provided on page 14 and is summarized in the following table.

The applicant states on page 14 that the number of projected patients for OY 1 and OY 2 is rounded down to the nearest whole number. Therefore, at the end of OY 1 (CY 2020) and OY 2 (CY2021), the facility is projected to serve 62 and 66 in-center patients, respectively.

The projected utilization rates for the first two operating years are as follows:

- OY 1: 3.263 patients per station per week, or 81.6% (62 patients / 19 stations = 3.263; 3.263 / 4 = 0.8158 or 81.6%).
- OY2: 3.474 patients per station per week, or 86.8% (66 patients / 33 stations = 3.474; 3.474 / 4 = 0.868 or 86.8%).

The projected utilization of 3.263 patients per station per week at the end of OY 1 exceeds the minimum standard of 3.2 in-center patients per station per week required by 10A NCAC 14C .2203(b).

Projected utilization is reasonable and adequately supported for the following reasons:

- The applicant starts with the existing Bladen County in-center patients.
- The Bladen County in-center patients are projected to increase based on 7.0% per year which is the Five Year AACR for Bladen County as reported in Table D of the July 2018 SDR.
- The applicant subtracts 34 in-center patients projected to transfer to Bladenboro Dialysis at the appropriate time.

• The applicant projects no growth for patients who utilize the facility and live in other counties, but adds them at the end of each period of growth for Bladen County patients.

PD Patient Utilization

In Section C.1, page 15, the applicant provides the assumptions and the methodology used to project utilization of PD patients for the first two years of operation following the completion of the project.

- The applicant begins with 18 PD patients as of December 31, 2017.
- The applicant projects growth in the PD patient population for one year, assuming growth by one patient. The applicant projects 19 PD patients at the end of CY 2018.
- Bladenboro Dialysis is projected to be certified on January 1, 2019; therefore, that is the time at which the 18 PD patients will be deducted from the SEDC-Elizabethtown patient census, when they transfer their care to Bladenboro Dialysis.
- OY 1 is projected to be CY 2020; and OY 2 is projected to be CY 2021.
- The applicant states it is reasonable to assume that the SEDC-Elizabethtown PD program will grow at a rate of at least one patient per year during the period of growth.
- The applicant projects an increase of one patient per year during the growth period, beginning with one PD patient as of January 1, 2019 and reaching four patients by the end of OY 2.
- The applicant averages the beginning and ending census for each year to reach an average number of patients per year for financial calculations.

The table below summarizes the beginning patient census on January 1, 2018 and its growth through the ending patient census on December 31, 2021, as presented by the applicant on page 15 of the application.

Projected PD patient utilization is reasonable and adequately supported for the following reasons:

- The applicant starts with the existing PD patients utilizing SEDC-Elizabethtown.
- The applicant projects growth at a rate of at least one patient per year during the period of growth. The Project Analyst notes that the facility has averaged 20 PD patients over the last five data reporting periods.
- The applicant subtracts the PD patients who will transfer to Bladenboro Dialysis at the appropriate time.
- The ESRD data collection form for June 30, 2018 states there were 18 PD patients utilizing DC Rowan County as of June 30, 2018.

<u>Access</u>

In Section C.3, page 16, the applicant states "By policy, the proposed services will be made available to all residents in its service area without qualifications. The facility will serve patients without regard to race, sex, age, or handicap. We will serve patients regardless of ethnic or socioeconomic situation." In Section L.1, page 45, the applicant projects the following payor mix for the proposed services during the second full fiscal year of operation following completion of the project, as shown in the table below.

On page 45, the applicant states the projected payor mix is based on the payor mix during the last year of operation. The projected payor mix is reasonable and adequately supported.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application

Based on that review, the Agency concludes that the application is conforming to this criterion for the following reasons:

- The applicant adequately identifies the population to be served.
- The applicant adequately explains why the population to be served needs the services proposed in this application.
- Projected utilization is reasonable and adequately supported.
- The applicant projects the extent to which all residents, including underserved groups, will have access to the proposed services (payor mix) and adequately supports its assumptions.
- (3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, handicapped persons, and other underserved groups and the elderly to obtain needed health care.

The applicant does not propose to reduce or eliminate a service, nor does the applicant propose to relocate a facility or service. Therefore, Criterion (3a) is not applicable to this review.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

TRC proposes to add three stations to the existing facility for a total of 19 stations upon completion of this project and Project I.D. #N-11130-16 (relocate 10 stations to Bladenboro Dialysis). SEDC-Elizabethtown offers a peritoneal dialysis program however, the facility does not currently offer a home hemodialysis program.

In Section E, page 23, the applicant states it considered doing nothing, and explains why that would not be an effective alternative. The applicant states that to do nothing would necessitate adding a third shift to effectively serve its patients. Adding a third shift is inconvenient for patients; and attempting to operate the facility at maximum capacity would not serve its patients.

On page 23, the applicant states that its proposal is the most effective alternative because the proposed project will address both the issues of growth and access to the facility.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above. Therefore, the application is approved subject to the following conditions:

- 1. Total Renal Care of North Carolina, LLC shall materially comply with all representations made in the certificate of need application.
- 2. Pursuant to the facility need determination in the July 2018 SDR, Total Renal Care of North Carolina, LLC shall develop no more than three additional dialysis stations for a total of no more than 19 certified stations at Southeastern Dialysis Center Elizabethtown, which shall include any home hemodialysis training or isolation stations.
- 3. Total Renal Care of North Carolina, LLC shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Agency in writing prior to issuance of the certificate of need.
- (5) Financial and operational projections for the project shall demonstrate the availability of funds for capital and operating needs as well as the immediate and long-term financial feasibility of the proposal, based upon reasonable projections of the costs of and charges for providing health services by the person proposing the service.

C

TRC proposes to add three stations to the existing facility for a total of 19 stations upon completion of this project and Project I.D. #N-11130-16 (relocate 10 stations to Bladenboro Dialysis). SEDC-Elizabethtown offers a peritoneal dialysis program however, the facility does not currently offer a home hemodialysis program.

Capital and Working Capital Costs

In Section F, pages 24 and 26 - 28, the applicant states that the proposed project does not involve any capital expenditures, start-up or initial operating expenses because SEDC-Elizabethtown is an existing facility.

Financial Feasibility

The applicant provided pro forma financial statements for the first two full fiscal years of operation following completion of the project. In Form B, the applicant projects that revenues will exceed operating expenses in the first two operating years of the project, as shown in the table below.

The assumptions used by the applicant in preparation of the pro forma financial statements are reasonable, including projected utilization, costs and charges. See Section R of the application for the assumptions used regarding costs and charges. The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference.

Conclusion

The Agency reviewed the:

- Exhibits to the application

Based on that review, the Agency concludes that the application is conforming to this criterion because the applicant adequately demonstrates sufficient funds for the operating needs of the proposal and that the financial feasibility of the proposal is based upon reasonable projections of costs and charges.

(6) The applicant shall demonstrate that the proposed project will not result in unnecessary duplication of existing or approved health service capabilities or facilities.

TRC proposes to add three stations to the existing facility for a total of 19 stations upon completion of this project and Project I.D. #N-11130-16 (relocate 10 stations to Bladenboro Dialysis). SEDC-Elizabethtown offers a peritoneal dialysis program however, the facility does not currently offer a home hemodialysis program.

On page 365, the 2018 SMFP defines the service area for dialysis stations as "the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." SEDC-Elizabethtown is located in Bladen County. Thus, the service area for this facility consists of Bladen County. Facilities may also serve residents of counties not included in their service area.

There is one existing and one approved dialysis facilities in Bladen County, each of which is operated or proposed to be operated by DaVita, as shown in the table below.

In Section G.2, page 30, the applicant explains why it believes the proposal would not result in the unnecessary duplication of existing or approved dialysis services in Bladen County. The applicant states:

"While adding stations at this facility does increase the number of stations in Bladen County, it is based on the facility need methodology. It ultimately serves to meet the needs of the facility's growing population of patients referred by the facility's admitting nephrologists. The addition of stations, therefore, serves to increase capacity rather than duplicate any existing or approved services in the service area."

The applicant adequately demonstrates that the proposal would not result in an unnecessary duplication of existing or approved services in the service area because the applicant adequately demonstrates that the proposed addition of three dialysis stations at SEDC-Elizabethtown is needed in addition to the existing stations.

Conclusion

The Agency reviewed the:

- information publicly available during the review and used by the Agency.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

In Section H.1, page 31, the applicant provides the current and projected staffing for the facility following the proposed relocation of stations. The applicant projects a decrease in the number of FTEs, because the net number of stations following this project and Project ID #N-11130-16 (develop a new facility by relocating ten stations) will actually decrease, as illustrated in the following table.

In addition, the applicant provides projected direct care staff in OY 2 in Section H.7, page 34.

The assumptions and methodology used to project staffing are provided in Sections H and R. Adequate costs for the health manpower and management positions proposed by the applicant are budgeted in Form A, which is found in Section R. In Sections H.3 and H.4, pages 32 - 33, the applicant describes the methods used to recruit or fill new positions and its existing training and continuing education programs. In Exhibits H-2, H-3 and H-4, the applicant provides supporting documentation. In Section I.3 page 36, the applicant identifies the medical director. In Exhibit I, the applicant provides a letter from the medical director committing to continue to serve as medical director for the proposed services.

The applicant adequately demonstrates the availability of sufficient health manpower and management personnel to provide the proposed services.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

The applicant shall also demonstrate that the proposed service will be coordinated with the existing health care system.

The IPRO ESRD Network of the South Atlantic Network 6 (IPRO SA Network 6) consisting of North Carolina, South Carolina and Georgia, provides an Annual Report which includes aggregate ESRD patient data from all three states. The 2016 Annual Report does not provide state-specific ESRD patient data, but the aggregate data is likely to be similar to North Carolina's based on the Network's recent annual reports which included state-specific data.

The IPRO SA Network 6 2016 Annual Report (pages 25-26¹) provides the following prevalence data on dialysis patients by age, race, and gender. As of December 31, 2016, over 85% of dialysis patients in Network 6 were 45 years of age and older, over 66% were other than Caucasian and 45% were female.

TRC proposes to add three stations to the existing facility for a total of 19 stations upon completion of this project and Project I.D. #N-11130-16 (relocate 10 stations to Bladenboro Dialysis). SEDC-Elizabethtown offers a peritoneal dialysis program however, the facility does not currently offer a home hemodialysis program.

On page 365, the 2018 SMFP defines the service area for dialysis stations as "the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." SEDC-Elizabethtown is located in Bladen County. Thus, the service area for this facility consists of Bladen County. Facilities may also serve residents of counties not included in their service area.

There is one existing and one approved dialysis facility in Bladen County, each of which is operated or proposed to be operated by DaVita, as shown in the table below.

The applicant adequately describes the expected effects of the proposed services on competition in the service area and adequately demonstrates:

- The cost-effectiveness of the proposal (see Sections F and R of the application and any exhibits)
- Quality services will be provided (see Section O of the application and any exhibits)
- Access will be provided to underserved groups (see Section L of the application and any exhibits)

In Section A, page 5, the applicant states DaVita operates more than 85 dialysis facilities in North Carolina. Exhibit A-11 contains a list of the DaVita dialysis facilities located in North Carolina.

In Section O, page 51, and Exhibit O-3 the applicant states that, during the 18 months immediately preceding the submittal of the application, incidents related to quality of care occurred in two of these facilities: Southeastern Dialysis Center-Wilmington and Goldsboro South Dialysis. The applicant states that all of the problems have been corrected and that Southeastern Dialysis Center-Wilmington was back in compliance as of March 21, 2018 and that Goldsboro South Dialysis was back in compliance as of November 20, 2017. After reviewing and considering information provided by the applicant and considering the quality of care provided at all DaVita facilities, the applicant provided sufficient evidence that quality care has been provided in the past. Therefore, the application is conforming to this criterion.
