REVIEW CRITERIA FOR NEW INSTITUTIONAL HEALTH SERVICES

N.C. Gen. Stat. §131E-183(a) The Agency shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

C

Bio-Medical Applications of North Carolina, Inc. (hereinafter referred to as "the applicant" or BMA) proposes to add seven dialysis stations to BMA of Greensboro, an existing facility, for a total of 51 dialysis stations upon completion of this project.

Need Determination

The 2019 State Medical Facilities Plan (2019 SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis stations. According to Table D, page 62, in the July 2019 Semiannual Dialysis Report (SDR), the county need methodology shows there is a deficit of 20 stations in Guilford County, but because there are facilities with a reported utilization of less than 80%, there is no county need determination for new dialysis stations for Guilford County.

However, the applicant is eligible to apply for additional dialysis stations in an existing facility based on the facility need methodology if the utilization rate for the dialysis center, as reported in the most recent SDR, is at least 3.2 patients per station per week, or 80%. The utilization rate reported for BMA of Greensboro in the July 2019 SDR is 3.4 patients per station per week, or 85%, based on 191in-center dialysis patients and 56 certified dialysis stations [191/56 = 3.41; 3.41/4 = 0.8526]. Therefore, BMA of Greensboro is eligible to apply for additional stations based on the facility need methodology.

Application of the facility need methodology indicates up to seven additional stations may be needed at this facility, as illustrated in the following the table:

As shown in the table above, based on the facility need methodology for dialysis stations, the potential number of stations needed at BMA of Greensboro is seven, based on rounding allowed in Step (v). Step (C) of the facility need methodology states, "The facility may apply to expand to meet the need established ..., up to a maximum of ten stations." The applicant proposes to add seven new stations; therefore, the application is consistent with the facility need determination for dialysis stations.

Policies

There are two policies in the 2019 SMFP which is applicable to this review. Policy GEN-3: Basic Principles and Policy GEN-4: Energy Efficiency and Sustainability for Health Service Facilities.

Policy GEN-3, on page 31 of the 2019 SMFP, states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

Promote Safety and Quality

The applicant describes how it believes the proposed project will promote safety and quality in Section B.3 (a and d), pages 11 and 13, respectively; Section N.2(b), page 56; Section O, pages 58-61; and referenced exhibits. The information provided by the applicant is reasonable and supports the determination that the applicant's proposal will promote safety and quality.

Promote Equitable Access

The applicant describes how it believes the proposed project will promote equitable access in Section B.3 (b and d), pages 11-12 and 13, respectively; Section C.7, page 24; Section L, pages 50-53; Section N.2(c), page 56; and referenced exhibits. The information provided by the applicant is reasonable and supports the determination that the applicant's proposal will promote equitable access.

Maximize Healthcare Value

The applicant describes how it believes the proposed project will maximize healthcare value in Section B.3 (c and d), pages 12-13; Section N.2(a), pages 55-56; and referenced exhibits. The information provided by the applicant with regard to its efforts to maximize healthcare

value is reasonable and supports the determination that the applicant's proposal will maximize healthcare value.

The applicant adequately demonstrates how its proposal incorporates the concepts of quality, equitable access, and maximum value for resources expended in meeting the facility need as identified by the applicant. Therefore, the application is consistent with Policy GEN-3.

Policy GEN-4 on page 31 of the 2019 SMFP, states:

"Any person proposing a capital expenditure greater than \$2 million to develop, replace, renovate or add to a health service facility pursuant to G.S. 131E-178 shall include in its certificate of need application a written statement describing the project's plan to assure improved energy efficiency and water conservation.

In approving a certificate of need proposing an expenditure greater than \$5 million to develop, replace, renovate or add to a health service facility pursuant to G.S. 131E-178, Certificate of Need shall impose a condition requiring the applicant to develop and implement an Energy Efficiency and Sustainability Plan for the project that conforms to or exceeds energy efficiency and water conservation standards incorporated in the latest editions of the North Carolina State Building Codes. The plan must be consistent with the applicant's representation in the written statement as described in paragraph one of Policy GEN-4.

Any person awarded a certificate of need for a project or an exemption from review pursuant to G.S. 131E-184 are required to submit a plan of energy efficiency and water conservation that conforms to the rules, codes and standards implemented by the Construction Section of the Division of Health Service Regulation. The plan must be consistent with the applicant's representation in the written statement as described in paragraph one of Policy GEN-4. The plan shall not adversely affect patient or resident health, safety or infection control."

The proposed capital expenditure for this project is greater than \$2 million but less than \$5 million. In Section B.4, pages 14-15, the applicant describes the project's plan to improve energy efficiency and conserve water, including energy efficient lighting, water optimization protocols, sustainable design and building materials, high-performance HVAC systems, and high-efficiency equipment and appliances. The applicant adequately demonstrates that the application includes a written statement describing the project's plan to assure improved energy efficiency and water conservation. Therefore, the application is consistent with Policy GEN-4.

Conclusion

The Agency reviewed the:

- application,
- exhibits to the application, and

• information publicly available during the review and used by the Agency.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

- (2) Repealed effective July 1, 1987.
- (3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and in particular, low income persons, racial and ethnic minorities, women, handicapped persons, the elderly, and other underserved groups are likely to have access to the services proposed.

^{*}The applicant's table shows 44 certified stations, which agrees with the data shown as of May 31, 2019 in the July 2019 SDR. Project ID #G-11303-17 (relocate 14 stations from BMA of Greensboro) was complete as of 7/8/19 and Project ID #G-11482-18 (add two stations) was complete as of 2/21/19.

As outlined in the table above, in this application, the applicant proposes to add seven dialysis stations at BMA of Greensboro for a total of 51 stations.

Patient Origin

On page 369, the 2019 SMFP defines the service area for dialysis stations as "...the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." Thus, the service area for this facility is Guilford County. Facilities may serve residents of counties not included in their service area.

In Section C.2, page 17, the applicant provides the patient origin for BMA of Greensboro incenter (IC), home hemodialysis (HH) and peritoneal dialysis (PD) patients as of December 31, 2018, as summarized in the table below.

Analysis of Need

In-Center Dialysis

The applicant proposes to add seven dialysis stations to BMA of Greensboro for a total of 51 dialysis stations upon completion of this project. In Section C.4, page 22, the applicant states that the need the proposed population has for the proposed services is a function of the individual patient need for dialysis care and treatment.

In Section Q, pages 70-71, the applicant describes its need methodology and assumptions for projecting in-center dialysis utilization at BMA of Greensboro, summarized as follows:

• The applicant provides a table on page 70 that shows the facility in-center census as of December 31, 2018 and June 30, 2019, as summarized below.

- The applicant states that it will begin utilization with the BMA of Greensboro patient census as of June 30, 2019, which was submitted to the Agency on the ESRD Data Collection form in August 2019. The applicant states that the decline in census from December 2018 to June 2019 is due to the opening of FKC Garber-Olin and the resultant patient transfers to the new facility. The applicant further states its belief that this is a temporary decline and the facility will once again have a high utilization.
- The applicant projects growth based on the Guilford County's Five Year Average Annual Change Rate (AACR) published in the July 2019 SDR of 5.4%.
- The applicant states that it assumes the 2 patients from Davidson and Rockingham counties dialyzing at BMA of Greensboro on June 30, 2019 will continue dialyzing at the facility by patient choice. The utilization will remain constant.
- Services will be offered as of December 31, 2020. Therefore, Operating Year (OY) 1 is calendar year (CY) 2021, January 1-December 31, 2021 and OY2 is CY2022, January 1-December 31, 2022.

In Section Q, page 71, the applicant provides its projected utilization methodology, based on its stated assumptions, as illustrated in the following table.

At the end of OY1 (CY2021) BMA of Greensboro is projected to serve 199.4 in-center patients on 51 stations; and at the end of OY2 (CY2022) the facility is projected to serve 210 in-center patients on 51 stations.

The projected utilization rates for the first two operating years are as follows:

- OY1: 3.9 patients per station per week, or 97.7% utilization [199.4 / 51 = 3.91; 3.91 / 4 = 0.97745].
- OY 2: 4.11 patients per station per week, or 102.9% utilization [210 patients / 51 stations = 4.11; 4.11/4 = 1.0294].

The projected utilization of 3.9 patients per station per week at the end of OY1 exceeds the minimum standard of 3.2 in-center patients per station per week required by 10A NCAC 14C .2203(b).

Projected utilization is reasonable and adequately supported for the following reasons:

• BMA of Greensboro was operating at 85.27% capacity as of December 31, 2018, as reported in the July 2019 SDR. This utilization was with 56 stations, which was reduced to 44 stations upon completion of projects under development.

- The applicant projects future utilization based on historical utilization.
- The applicant projects growth in the patient population using the Guilford County AAGR of 5.4%.
- Projected utilization at the end of OY1 exceeds the minimum of 3.2 patients per station per week required by 10A NCAC 14C .2203(b).

Home Dialysis Training

In Section C.4, page 22, the applicant states that the need the proposed population has for the proposed services is a function of the individual patient need for dialysis care and treatment.

In Section Q, pages 72-73, the applicant describes its need methodology and assumptions for projecting home training dialysis utilization at BMA of Greensboro, summarized as follows:

• The applicant states that it will begin utilization with the BMA of Greensboro patient census as of June 30, 2019, which was submitted to the Agency on the ESRD Data Collection form in August 2019 and summarized below.

- The applicant assumes the patients from Caswell, Forsyth, Rockingham and Stokes will continue to dialyze at BMA of Greensboro but with no growth.
- Services will be offered as of December 31, 2020. Therefore, Operating Year (OY) 1 is calendar year (CY) 2021, January 1-December 31, 2021 and OY2 is CY2022, January 1-December 31, 2022.

At the end of OY1 (CY2021) BMA of Greensboro is projected to serve 25 HH patients and 45 PD patients; and at the end of OY2 (CY2022) the facility is projected to serve 26 HH patients and 47 PD patients.

Projected utilization of the home training program is reasonable and adequately supported for the following reasons:

- The applicant adequately demonstrates the need for home training services in Guilford County.
- The applicant projects HH and PD patients based on its historical utilization.
- The applicant projects growth in the Guilford County patient population using the Guilford County Five Year AACR of 5.4%, as published in the July 2019 SDR.
- The applicant does not project growth for patients residing outside of Guilford County.

The total IC, HH, and PD projected utilization is shown on page 73 and summarized below.

Projected utilization of the total proposed IC, HH, and PD program at BMA of Greensboro is reasonable and adequately supported for the reasons stated above.

Access

In Section C.7, pages 23-24, the applicant states:

"Each of our facilities has a patient population which includes low-income persons, racial and ethnic minorities, women, handicapped persons, elderly, or other traditionally underserved persons.

...

Fresenius related facilities in North Carolina have historically provided substantial care and services to all persons in need of dialysis services, regardless of income, racial or ethnic background, gender, handicap, age or any other grouping/category or basis for being an underserved person."

In Section L, page 52, the applicant projects the following payor mix during the second full fiscal year of operation following completion of the project, as summarized in the following table.

The projected payor mix is reasonable and adequately supported.

Conclusion

The Agency reviewed the:

Based on that review, the Agency concludes that the application is conforming to this criterion for the following reasons:

- The applicant adequately identifies the population to be served.
- The applicant adequately explains why the population to be served needs the services proposed in this application.
- Projected utilization is reasonable and adequately supported.
- The applicant projects the extent to which all residents, including underserved groups, will have access to the proposed services (payor mix) and adequately supports its assumptions.
- (3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, handicapped persons, and other underserved groups and the elderly to obtain needed health care.

The applicant does not propose to reduce a service, eliminate a service, or relocate a facility or service. Therefore, Criterion (3a) is not applicable to this review.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

CA

The applicant proposes to add seven dialysis stations to BMA of Greensboro for a total of 51 dialysis stations upon completion of this project.

In Section E, page 29, the applicant states it considered the following three alternatives related to serving the needs of the patients in the area:

- 1. Maintain the status quo the applicant states this was not a reasonable alternative because it fails to recognize the growth of the ESRD patient population residing in Greensboro and Guilford County. The applicant states that failure to add stations will result in higher utilization rates at the facility and fewer opportunities for patient admission.
- 2. Apply for fewer than seven stations the applicant states that applying for fewer stations would only serve to increase projected utilization rates at the facility; thus BMA would be forced to file yet another application to add stations at BMA of Greensboro.
- 3. Relocate stations from another BMA facility in Guilford County the applicant states that its Guilford County facilities are well utilized, with several applying to add stations. The applicant states that it would not be appropriate to relocate stations from any of the facilities given the individual circumstances listed in the application for each facility.

On page 30, the applicant states that it elected to seven stations pursuant to the facility need methodology because this proposal is the most cost-effective approach to providing the necessary services for the patient population projected to be served at BMA of Greensboro.

The applicant adequately demonstrates that the alternative proposed in this application is the most effective alternative to meet the need for the following reasons:

Per the July 2019 SDR, as of December 31, 2018, Fresenius related entities own and operate seven of the nine existing and proposed dialysis facilities in Guilford County with a total of 224 certified stations. - Quality services will be provided (see Sections B and O of the application and any exhibits).
- Access will be provided to underserved groups (see Sections B and L of the application and any exhibits).

Conclusion

The Agency reviewed the:

- application, and
- exhibits to the application.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

- (19) Repealed effective July 1, 1987.
- (20) An applicant already involved in the provision of health services shall provide evidence that quality care has been provided in the past.

In Section Q Form A Facilities, the applicant identifies the kidney disease treatment centers located in North Carolina owned, operated, or managed by the applicant or a related entity. The applicant identifies 127 dialysis facilities owned, operated, or managed by the applicant or a related entity located in North Carolina.

In Section O, page 61, the applicant states that, during the 18 months immediately preceding the submittal of the application, no incidents related to quality of care that resulted in a finding of "Immediate Jeopardy" occurred in any of these facilities. After reviewing and considering information provided by the applicant and publicly available data and considering the quality of care provided at all Fresenius facilities, the applicant provides sufficient evidence that quality care has been provided in the past. Therefore, the application is conforming to this criterion.

- (21) Repealed effective July 1, 1987.
- (b) The Department is authorized to adopt rules for the review of particular types of applications that will be used in addition to those criteria outlined in subsection (a) of this section and may vary according to the purpose for which a particular review is being conducted or the type of health service reviewed. No such rule adopted by the Department shall require an academic medical center teaching hospital, as defined by the State Medical Facilities Plan, to demonstrate that any facility or service at another hospital is being appropriately utilized in order for that academic medical center teaching hospital to be approved for the issuance of a certificate of need to develop any similar facility or service.

The Criteria and Standards for End Stage Renal Disease Services promulgated in 10A NCAC 14C .2200 are applicable to this review. The application is conforming to all applicable criteria, as discussed below.

10 NCAC 14C .2203 PERFORMANCE STANDARDS

- (a) An applicant proposing to establish a new End Stage Renal Disease facility shall document the need for at least 10 stations based on utilization of 3.2 patients per station per week as of the end of the first operating year of the facility, with the exception that the performance standard shall be waived for a need in the State Medical Facilities Plan that is based on an adjusted need determination.
- -NA- BMA of Greensboro is an existing facility.
- (b) An applicant proposing to increase the number of dialysis stations in an existing End Stage Renal Disease facility or one that was not operational prior to the beginning of the review period but which had been issued a certificate of need shall document the need for the additional stations based on utilization of 3.2 patients per station per week as of the end of the first operating year of the additional stations.

- -C- In Section Q Form C, page 69, the applicant projects that BMA of Greensboro will serve 199.4 in-center patients on 51 stations, or a rate of 3.91 patients per station per week, as of the end of the first operating year following project completion. This exceeds the minimum performance standard of 3.2 patient per station per week. The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference.
- (c) An applicant shall provide all assumptions, including the methodology by which patient utilization is projected.
- -C- In Section Q, pages 70-73, the applicant provides the assumptions and methodology it used to project utilization of the facility. The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference.
