### REVIEW CRITERIA FOR NEW INSTITUTIONAL HEALTH SERVICES

N.C. Gen. Stat. §131E-183(a) The Department shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

Total Renal Care of North Carolina, LLC (TRC) proposes to add 5 stations for a total of 38 stations at Southeastern Dialysis Center - Jacksonville (SEDC - Jacksonville) upon completion of this project and Project I.D. # P-11415-17 (add two stations).

### **Need Determination**

The 2019 State Medical Facilities Plan (SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis stations. According to Table D in the January 2019 Semiannual Dialysis Report (SDR), there is a deficit of four dialysis stations in Onslow County. Therefore, there is no county need determination for new dialysis stations in Onslow County. However, the applicant is eligible to apply for additional stations in its existing facility based on the facility need methodology because the utilization rate reported for SDC - Jacksonville in the January 2019 SDR is 3.5484 patients per station

per week. This utilization rate was calculated based on 110 in-center dialysis patients and 31 certified dialysis stations as of June 30, 2018 (110 patients / 31 stations = 3.5484 patients per station per week). The facility need methodology requires a facility's utilization rate in the latest SDR to be at least 3.2 patients per station per week to be eligible to apply for additional stations based on facility need.

Application of the facility need methodology indicates that up to a potential maximum of two additional stations are needed for this facility, as illustrated in the following table.

As shown in the table above, based on the facility need methodology for dialysis stations, the potential number of stations needed is five stations. Step (C) of the facility need methodology states, "The facility may apply to expand to meet the need established ..., up to a maximum of ten stations." The applicant proposes to add five new stations and therefore, is consistent with the facility need determination for dialysis stations.

# **Policies**

There is one policy in the 2019 SMFP which is applicable to this review. *Policy GEN-3: Basic Principles* on page 31 of the 2019 SMFP is applicable to this review because the facility need methodology is applicable to this review. Policy GEN-3 states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the

delivery of health care services while promoting equitable access and maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

The applicant addresses *Policy GEN-3* as follows:

# Promote Safety and Quality

The applicant describes how it believes the proposed project would promote safety and quality in Section B.4(a and d), pages 9 and 11, Section K.1(g), page 39, Section N.1, page 49, Section O, page 50 and referenced exhibits. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote safety and quality.

# Promote Equitable Access

The applicant describes how it believes the proposed project would promote equitable access in Section B.4(b and d), pages 10-11, Section C.3, page 15, Section L, pages 43-47, Section N.1, page 49 and referenced exhibits. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would promote equitable access.

### Maximize Healthcare Value

The applicant describes how it believes the proposed project would maximize healthcare value in Sections B.4(c and d), page 11, Section K.1, pages 38-39 and referenced exhibits. The information provided by the applicant is reasonable and adequately supports the determination that the applicant's proposal would maximize healthcare value.

The applicant adequately demonstrates how its projected volumes incorporate the concepts of quality, equitable access and maximum value for resources expended in meeting the facility need as identified by the applicant. The application is consistent with Policy GEN-3.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

- (3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and, in particular, low income persons, racial and ethnic minorities, women, handicapped persons, the elderly, and other underserved groups are likely to have access to the services proposed.

The applicant proposes to add 5 stations for a total of 38 stations at SEDC - Jacksonville upon completion of this project and Project I.D. # P-11415-17 (add two stations).

# **Patient Origin**

On page 369, the 2019 SMFP defines the service area for dialysis stations as "the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." Thus, the service area for this facility consists of Onslow County. Facilities may also serve residents of counties not included in their service area.

In Section C.8, page 18 and C.1, page 13, the applicant provides the historical and the projected patient origin for in-center (IC) patients, respectively, as illustrated in the tables below.

The applicant does not currently offer hemodialysis (HHD) training and peritoneal dialysis (PD) training and support services at SEDC - Jacksonville, nor does the applicant plan to offer those services as a part of this application.

In Section C, pages 13-14, the applicant provides the assumptions and methodology used to project patient origin for in-center patients.

The applicant's assumptions are reasonable and adequately supported.

# **Analysis of Need**

In Section B.2, page 7, the applicant states the application is filed pursuant to the facility need methodology in the 2019 SMFP utilizing data from the July 2018 SDR and the January 2019 SDR. The facility need methodology shows a need for five dialysis stations and the proposed project is for five dialysis stations.

In Section C.1 pages 13-14, the applicant states:

- The applicant begins the projections for the future patient population of SEDC Jacksonville by using the ending in-center patient census of 110 patients, as of June 30, 2018.
- The two additional stations approved in Project I.D. # P-11415-17 were certified effective August 19, 2018.
- The applicant uses the Five-Year Average Annual Change Rate (AACR) for Onslow County which is 3.9%, as published in the January 2019 SDR, to project the Onslow County patient population forward.
- The applicant does not project an increase in the patient population for patients residing outside of Onslow County.
- Operating Year 1 (OY1) = Calendar Year (CY) 2021
   Operating Year 2 (OY2) = Calendar Year (CY) 2022

The information is reasonable and adequately supported.

# **Projected Utilization**

The applicant's methodology begins with the Onslow County in-center patient census as of June 30, 2018 and applies the Onslow County AACR of 3.9%, as illustrated in the following table, from page 14 of the application:

The applicant rounded down to the nearest whole number for OY1 and OY2. The applicant projects to serve 124 in-center patients at the end of OY1 and 128 in-center patients at the end of OY2. Thus, the applicant projects that SEDC - Jacksonville will have a utilization rate of 81.6% or 3.26 patients per station per week (124 patients / 38 stations = 3.263 / 4 = 0.8158 or 81.58%) at the end of OY1. The projected utilization of 3.263 patients per station per week at the end of OY1 exceeds the minimum standard of 3.2 in-center patients per station per week required by 10A NCAC 14C .2203(b).

Projected utilization is reasonable and adequately supported for the following reasons:

- the applicant begins with the existing in-center patients,
- the applicant grows the Onslow County in-center patients using the Onslow County 5-year AACR (3.9%) and holds the patient population from other counties constant, and
- the utilization rate by the end of OY1 exceeds the minimum standard of 3.2 patients per station per week.

# Home Hemodialysis and Peritoneal Dialysis

The applicant does not currently provide home hemodialysis (HHD) or peritoneal dialysis (PD) nor are those services proposed in this application. In Section I.1, page 34, the applicant states that HHD and PD services will be provided by New River Dialysis.

# Access

In Section C.3, page 15, the applicant states that, by policy, the proposed services will be available to all patients in need of dialysis, without regard to race, sex, age, handicap, socioeconomic status or the ability to pay. In Section L.1, page 44, the applicant provides the projected payor mix during OY2, as illustrated below.

As shown in the table above, OY2, the applicant projects 78.5% of total services will be provided to Medicare patients (includes Medicare, Medicare/Commercial and Medicare/Medicaid) and 7.5% to Medicaid patients.

On page 44, the applicant provides the assumptions and methodology used to project payor mix during OY2. The projected payor mix is reasonable and adequately supported because it is based on the historical utilization at SEDC - Jacksonville.

# **Conclusion**

The Agency reviewed the:

- Application
- Exhibits to the application
- Information publicly available during the review and used by the Agency

Based on that review, the Agency concludes that the application is conforming to this criterion for the following reasons:

- The applicant adequately identifies the population to be served.
- The applicant adequately explains why the population to be served needs the services proposed in this application.
- Projected utilization is reasonable and adequately supported.
- The applicant projects the extent to which all residents, including underserved groups, will have access to the proposed services (payor mix) and adequately supports its assumptions.
- (3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, handicapped persons, and other underserved groups and the elderly to obtain needed health care.

### NA

The applicant does not propose to reduce, eliminate or relocate a facility or a service. The applicant proposes to add six dialysis stations to an existing facility pursuant to the facility need determination. Therefore, Criterion (3a) is not applicable to this review.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

CA

The applicant proposes to add 5 stations for a total of 38 stations at SEDC - Jacksonville upon completion of this project and Project I.D. # P-11415-17 (add two stations).

In Section E.1, page 22, the applicant describes the alternatives it considered and explains why each alternative is either more costly or less effective than the alternative proposed in this application to meet the need. The alternatives considered were:

- Maintain the Status Quo The applicant states that based on the growth rate at SEDC
   Jacksonville this alternative was dismissed.
- Relocate existing stations from another DaVita facility in Onslow County The applicant states that both of its facilities in Onslow County operated with a utilization above 80%. Therefore, this alternative was rejected.

The applicant adequately demonstrates that the alternative proposed in this application is the most effective alternative to meet the need for the following reasons:

- the facility is operating above 80% capacity,
- the applicant's application of the facility need methodology, as published in the January 2019 SDR, indicates a need for five additional stations, and
- maintaining the status quo does not address the high utilization and need for additional stations at the facility.

### Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application
- Information which was publicly available during the review and used by the Agency.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above. Therefore, the application is approved subject to the following conditions:

- 1. Total Renal Care of North Carolina, LLC shall materially comply with all representations made in the certificate of need application.
- 2. Pursuant to the facility need determination in the January 2019 SDR, the applicant shall develop no more than five additional dialysis stations for a total of no more than 38 certified stations at Southeastern Dialysis Center Jacksonville upon completion of this project and Project I.D. # P-11415-17 (add two stations), which shall include any home hemodialysis training or isolation stations.
- 3. Total Renal Care of North Carolina, LLC shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Healthcare Planning and Certificate of Need Section in writing prior to the issuance of the certificate of need.
- (5) Financial and operational projections for the project shall demonstrate the availability of funds for capital and operating needs as well as the immediate and long-term financial feasibility of the proposal, based upon reasonable projections of the costs of and charges for providing health services by the person proposing the service.

The applicant proposes to add 5 stations for a total of 38 stations at SEDC - Jacksonville upon completion of this project and Project I.D. # P-11415-17 (add two stations).

# **Capital and Working Capital Costs**

In Section F.1, pages 23, the applicant projects the total capital cost of the project as shown in the table below.

In Section F, pages 25-26, the applicant states that there will be no start-up or initial operating expenses associated with the proposed project as SEDC - Jacksonville is an existing facility.

In Section F.2, page 24, the applicant states that the capital cost will be funded as shown in the table below.

Exhibit F.1 contains a letter dated March 13, 2019 from the Chief Accounting Officer of DaVita, Inc., which states,

"I am the Chief Accounting Officer of DaVita, the 100% owner of Total Renal Care, Inc. ... This letter will confirm that DaVita has committed cash reserves in the total sum of \$95,039 for the project capital expenditure."

Exhibit F.7 contains a copy of Form 10-K Consolidated Financial Statement from DaVita, Inc., which showed that as of December 31, 2018, DaVita had adequate cash and assets to fund the capital costs of the proposed project.

# **Financial Feasibility**

The applicant provided pro forma financial statements for the first two operating years of the project. In the pro forma financial statement (Form B), the applicant projects that revenues will exceed operating expenses in the first two operating years of the project, as shown in the table below.

The assumptions used by the applicant in preparation of the pro forma financial statements are reasonable, including projected utilization, costs and charges. See Section R of the application for the assumptions used regarding costs and charges. The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference.

Based on that review, the Agency concludes that the application is conforming to this criterion for the following reasons:

- The applicant adequately demonstrates that the capital costs are based on reasonable and adequately supported assumptions.
- The applicant adequately demonstrates that the financial feasibility of the proposal is based upon reasonable projections of costs and charges.
- (6) The applicant shall demonstrate that the proposed project will not result in unnecessary duplication of existing or approved health service capabilities or facilities.

The applicant proposes to add 5 stations for a total of 38 stations at SEDC - Jacksonville upon completion of this project and Project I.D. # P-11415-17 (add two stations).

On page 369, the 2019 SMFP defines the service area for dialysis stations as "the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." Thus, the service area for this facility consists of Onslow County. Facilities may also serve residents of counties not included in their service area.

According to the January 2019 SDR, there are two existing dialysis facilities in Onslow County, both of which are operated by DaVita, Inc., as shown in the table below.

As illustrated in the table above, both facilities operated with a utilization of above 80% with a county utilization of 3.4 patients per station per week, which is based on a total 181 patients dialyzing on 53 stations [181/53=3.4150] or 85.38% [3.4150/4=0.85377], as reported on Table B of the January 2019 SDR.

In Section G, page 29, the applicant explains why it believes its proposal would not result in the unnecessary duplication of existing or approved dialysis services in Onslow County. The applicant states:

"Both DaVita facilities in Onslow County were operating at 80% utilization or greater as reported in the January 2019 SDR. Therefore, each facility has the potential for adding stations, given that they show a need. In Section B-2 and Section C of this application, we demonstrate the need that SEDC - Jacksonville has for adding stations. While adding stations at this facility does increase the number of stations in Onslow County, it is based on the facility need methodology. It ultimately serves to meet the needs of the facility's growing population of patients referred by the facility's admitting nephrologists. The addition of stations, therefore, serves to increase capacity rather than duplicate any existing or approved services in the service area."

The applicant adequately demonstrates that the proposal would not result in an unnecessary duplication of existing or approved services in the service area for the following reasons:

- The applicant demonstrates the need for the additional five stations based on the facility need methodology, and demonstrates in Section C.8, page 18, that the facility served 110 in-center patients as of June 30, 2018 on 31 stations which is a utilization of 3.5484 patients per station per week or 88.71% utilization [110/31=3.5484; 3.584/4=0.88709 or 88.71%].
- The applicant demonstrates that the proposed stations are needed in addition to the existing or approved stations in Onslow County.

- Information which was publicly available during the review and used by the Agency.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

(7) The applicant shall show evidence of the availability of resources, including health manpower and management personnel, for the provision of the services proposed to be provided.

In Section H.1, page 30, the applicant provides current and projected full-time equivalent (FTE) staffing for the proposed services, as illustrated in the following table.

The applicant provides projected direct care staff in OY2 in Section H.7, page 33.

Adequate costs for the health manpower and management positions proposed by the applicant are budgeted in Form A, which is found in Section R. In Section H, page 31, the applicant describes the methods used to recruit or fill new positions and its existing training and continuing education programs. In Exhibit I, the applicant provides a letter from the medical director indicating his interest in continuing to serve as the medical director of SEDC - Jacksonville. In Exhibit H, the applicant provides supporting documentation.

The applicant adequately demonstrates the availability of sufficient health manpower and management personnel to provide the proposed services.

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

(8) The applicant shall demonstrate that the provider of the proposed services will make available, or otherwise make arrangements for, the provision of the necessary ancillary and support services. The applicant does not project to provide the proposed services to a substantial number of persons residing in Health Service Areas (HSAs) that are not adjacent to the HSA in which the services will be offered. Furthermore, the applicant does not project to provide the proposed services to a substantial number of persons residing in other states that are not adjacent to the North Carolina county in which the services will be offered. Therefore, Criterion (9) is not applicable to this review.

The 2016 Annual Report does not provide state-specific ESRD patient data, but the aggregate data is likely to be similar to North Carolina's based on the Network's recent annual reports which included state-specific data.

As shown in the table above, OY2, the applicant projects 78.5% of total services will be provided to Medicare patients (includes Medicare, Medicare/Commercial and Medicare/Medicaid) and 7.5% to Medicaid patients.

The applicant proposes to add 5 stations for a total of 38 stations at SEDC - Jacksonville upon completion of this project and Project I.D. # P-11415-17 (add two stations).

On page 369, the 2019 SMFP defines the service area for dialysis stations as "the dialysis station planning area in which the dialysis station is located. Except for the Cherokee-Clay-Graham Multicounty Planning Area and the Avery-Mitchell-Yancey Multicounty Planning Area, each of the 94 remaining counties is a separate dialysis station planning area." Thus, the service area for this facility consists of Onslow County. Facilities may also serve residents of counties not included in their service area.

According to the January 2019 SDR, there are two existing dialysis facilities in Onslow County, both of which are operated by DaVita, Inc., as shown in the table below.

As illustrated in the table above, both facilities operated with a utilization of above 80% with a county utilization of 3.4 patients per station per week, which is based on a total 181 patients dialyzing on 53 stations [181/53=3.4150] or 85.38% [3.4150/4=0.85377], as reported on Table B of the January 2019 SDR.

In Section N.1, page 49, the applicant describes the expected effects of the proposed services on competition in the service area and discusses how any enhanced competition in the service area will promote the cost-effectiveness, quality and access to the proposed services. The applicant states:

"The expansion of SEDC Jacksonville will have no effect on competition in Onslow County. Although the addition of stations at this facility could serve to provide more patients another option to select a provider that gives them the highest quality service and better meets their needs, this project primarily serves to address the needs of a population already served (or projected to be served, based on historical growth rates) by Total Renal Care of North Carolina, LLC."

The applicant adequately describes the expected effects of the proposed services on competition in the service area and adequately demonstrates:

- The cost-effectiveness of the proposal (see Sections F and R of the application and any exhibits)
- Quality services will be provided (see Section O of the application and any exhibits)
- Access will be provided to underserved groups (see Section L of the application and any exhibits)

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above.

- (20) An applicant already involved in the provision of health services shall provide evidence that quality care has been provided in the past.

In Section A.11, page 5, the applicant states DaVita Inc. owns and operates over 85 dialysis facilities in North Carolina. In Exhibit A-11, the applicant provides a list of those facilities.

In Section O.3, page 50, the applicant states that, during the 18 months immediately preceding the submittal of the application, incidents related to quality of care occurred in two of these facilities, Southeastern Dialysis Center-Wilmington and Goldsboro South Dialysis. The applicant provides documentation regarding the deficiencies and subsequent measures taken by those facilities to ensure compliance with CMS Conditions for Coverage in Exhibit O-3. The applicant states that all of the problems have been corrected and that Southeastern Dialysis Center-Wilmington was back in compliance as of March 21, 2018 and that Goldsboro South Dialysis was back in compliance as of November 20, 2017. After reviewing and considering information provided by the applicant and considering the quality of care provided at all DaVita facilities, the applicant provided sufficient evidence that quality care has been provided in the past. Therefore, the application is conforming to this criterion.

The discussion regarding projected utilization found in Criterion (3) is incorporated herein by reference.
