REVIEW CRITERIA

G.S. 131E-183(a): The Department shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

Bio-Medical Applications of North Carolina, Inc. (hereinafter "BMA" or "the applicant") proposes to add four stations to FMC Services of West Fayetteville (FMC-WF) pursuant to Condition 2 of the facility need methodology for a total of 44 stations upon project completion.

Need Determination

Chapter 9 of the 2021 State Medical Facilities Plan (SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis stations. According to Table 9C, on page 137 of the 2021 SMFP, the county need methodology shows there is not a county need determination for additional dialysis stations in Cumberland County.

However, the applicant is eligible to apply for additional dialysis stations in an existing facility pursuant to Condition 2 of the facility need methodology in the 2021 SMFP, if the utilization rate for the dialysis center as reported in the 2021 SMFP is at least 75 percent or 3.0 patients per station per week, as stated in Condition 2.a. Table 9A on page 121 of the 2021 SMFP shows the utilization rate reported for FMC-WF is 106.25 percent or 4.25 patients per station per week based on 170 in-center dialysis patients and 40 certified dialysis stations (170 patients / 40 stations = 4.25; 4.25 / 4 = 106.25%).

As shown in Table 9D on page 138 of the 2021 SMFP, based on the facility need methodology for dialysis stations, the potential number of stations needed at FMC-WF is up to 18 additional stations; thus, the applicant is eligible to apply to add up to 18 stations during the 2021 SMFP review cycle pursuant to Condition 2 of the facility need methodology.

The applicant proposes to add no more than four new stations to FMC-WF, which is consistent with the 2021 SMFP calculated facility need determination for up to 18 dialysis stations; therefore, the application is consistent with Condition 2 of the facility need determination for dialysis stations.

Policies

There is one policy in the 2021 SMFP which is applicable to this review. *Policy GEN-3: Basic Principles*, on page 29 of the 2021 SMFP, states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

In Section B, pages 21-23, the applicant explains why it believes its application is consistent with Policy GEN-3. On page 23, the applicant states:

"BMA projects utilization will continue to increase while the facility provides dialysis care and treatment in a safe environment, focused on quality patient care, and ensuring access to care for all patients with proper referral from a nephrology physician (patients cannot self-refer for dialysis treatment). The volume projections for this application are realistic and conservative. BMA consistently provides treatment for the medically underserved and does not discriminate in any manner; all patients are accepted at the facility with proper referral from a physician with admitting privileges. The quality of care provided by the applicant is comparable with or exceeds industry standards for care."

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application
- Information publicly available during the review and used by the Agency

Based on that review, the Agency concludes that the application is conforming to this criterion based on the following:

- The applicant adequately demonstrates that the application is consistent with Condition 2 of the facility need methodology as applied from the 2021 SMFP.
- The applicant adequately demonstrates that the application is consistent with Policy GEN-3 because the applicant adequately demonstrates how FMC-WF's projected volumes incorporate the concepts of safety and quality, equitable access, and maximum value for resources expended in meeting the facility need.
- (2) Repealed effective July 1, 1987.
- (3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and in particular, low income persons, racial and ethnic minorities, women, ... persons [with disabilities], the elderly, and other underserved groups are likely to have access to the services proposed.

The applicant proposes to add four dialysis stations to FMC-WF pursuant to Condition 2 of the facility need methodology for a total of 44 stations following project completion.

In Section C, pages 25-26, the applicant documents that FMC-WF did not provide home hemodialysis (HH) or peritoneal dialysis (PD) modalities during its last full fiscal year (CY 2020) and does not project to offer HH or PD modalities through its second full fiscal year following project completion.

Patient Origin

On page 113, the 2021 SMFP defines the service area for dialysis stations as "...the county in which the dialysis station is located. Each county comprises a service area except for two multicounty service areas: Cherokee, Clay and Graham counties and Avery, Mitchell, and Yancey counties." Thus, the service area for this facility consists of Cumberland County. Facilities may serve residents of counties not included in their service area.

In Section C, pages 26-27, and the Form C Utilization subsection of Section Q, the applicant provides the assumptions and methodology used to project patient origin. The applicant's assumptions are reasonable and adequately supported based on the following:

- The applicant clearly explains the growth projections for the Cumberland County patient population.
- The applicant did not project growth in the number of patients at FMC-WF who do not live in Cumberland County.
- It is reasonable for the applicant to project that the one patient from Wake County it had been serving in CY 2020 was a transient patient who would not continue to dialyze at FMC-WF in the future.

Analysis of Need

In Section C, pages 26-28, the applicant explains why it believes the population projected to utilize the proposed services needs the proposed services. On page 28, the applicant states:

"Patients with End Stage Renal Disease require dialysis treatment on a regular and consistent basis in order to maintain life. Patients will normally receive three treatments per week. The NC SMFP recognizes that this patient population requires frequent and regular treatment. The need methodology for dialysis stations is focused on four patient shifts per week and recognizes that patients will generally dialyze on a Monday-Wednesday-Friday, morning or afternoon shift schedule, or on a Tuesday-Thursday-Saturday, morning or afternoon shift schedule. Failure to receive dialysis care will ultimately lead to the patient's demise.

The need that this population has for the proposed services is a function of the individual patient need for dialysis care and treatment."

The information is reasonable and adequately supported for the following reasons:

• According to the 2021 SMFP, as of December 31, 2019, FMC-WF was operating at a rate of 4.25 patients per station per week, or 106.25 percent of capacity.

- FMC-WF has a facility need determination of up to 18 stations. The applicant is applying to add only four additional stations.
- According to the applicant's ESRD Data Collection Form, available to the Agency during this review, as of December 31, 2020, the applicant was serving 173 patients on 40 stations; based on the facility need methodology in the Proposed 2022 SMFP, FMC-WF would potentially have a need determination for up to 20 additional dialysis stations.
- The applicant uses the Cumberland County 5-Year Average Annual Change Rate (AACR), as published in Table 9B on page 133 of the 2021 SMFP, in its projections for Cumberland County patients.

Projected Utilization

In Section C, pages 25-26, and on Form C in Section Q, the applicant provides historical and projected utilization, as shown in the table below.

In Section C, pages 26-27, and in the Form C Utilization subsection of Section Q, the applicant provides the assumptions and methodology used to project patient utilization, which are summarized below.

- The applicant begins its utilization projections with the patient census on December 31, 2020. The applicant states that on December 31, 2020, its in-center patient census was comprised of 151 Cumberland County patients, 16 patients from Hoke County, four patients from Robeson County, one patient from Sampson County, and one patient from Wake County.
- The applicant projects growth in the Cumberland County patient population using the Cumberland County 5-year AACR of 5.2 percent, as published in the 2021 SMFP.
- The applicant assumes no population growth for the patients residing in Hoke, Robeson, and Sampson counties but assumes the patients will continue to dialyze at FMC-WF and adds them to the calculations when appropriate.
- The applicant assumes the one patient from Wake County is a transient patient who will not dialyze at FMC-WF in the future.

• The project is scheduled to begin offering services on January 1, 2023. OY1 is CY 2023. OY2 is CY 2024.

In Section C, page 27, and in the Form C Utilization subsection of Section Q, the applicant provides the calculations used to project the patient census for OY1 and OY2, as summarized in the table below.

The applicant projects to serve 196.8 patients on 44 stations, which is 4.5 patients per station per week (196.8 patients / 44 stations = 4.47, which is rounded to 4.5), by the end of OY1 and 205.9 patients on 44 stations, which is 4.7 patients per station per week (205.9 patients / 44 stations = 4.68, which is rounded to 4.7), by the end of OY2. This meets the minimum of 2.8 patients per station per week as of the end of the first operating year as required by 10A NCAC 14C .2203(b).

Projected utilization is reasonable and adequately supported for the following reasons:

- FMC-WF was operating at a rate of 4.25 patients per station per week, or 106.25 percent of capacity, on December 31, 2019.
- Based on its ESRD Data Collection Form, available to the Agency during this review, FMC-WF was operating at a rate of 4.33 patients per station per week, or 108.13 percent of capacity, on December 31, 2020.
- The applicant projects future utilization based on historical utilization.
- The applicant projects growth in the Cumberland County patient population using the Cumberland County 5-year AACR as published in the 2021 SMFP.

• The applicant projects no growth for patients residing outside of Cumberland County.

Access to Medically Underserved Groups

In Section C, page 31, the applicant states:

".... Each of our facilities has a patient population which includes low-income persons, racial and ethnic minorities, women, [people with disabilities], elderly, or other traditionally underserved persons.

It is corporate policy to provide all services to all patients regardless of income, racial/ethnic origin, gender, physical or mental conditions, age, or health insurer.

Fresenius Medical Care and its related facilities in North Carolina have historically provided substantial care and services to all persons in need of dialysis services, regardless of income, racial or ethnic background, gender, [disability], age or any other grouping/category or basis for being an underserved person."

The applicant provides the estimated percentage of total patients for each medically underserved group during the second full fiscal year, as shown in the following table.

The applicant adequately describes the extent to which all residents of the service area, including underserved groups, are likely to have access to the proposed services based on the following:

- The applicant provides a statement saying it will provide service to all residents of the service area, including underserved groups, without regard for anything other than the need for dialysis services.
- The applicant states the percentages of patients for each group listed above are based on recent facility experience.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application
- Information publicly available during the review and used by the Agency

Based on that review, the Agency concludes that the application is conforming to this criterion for all the reasons described above.

(3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, ... persons [with disabilities], and other underserved groups and the elderly to obtain needed health care.

NA

The applicant does not propose to reduce a service, eliminate a service or relocate a facility or service. Therefore, Criterion (3a) is not applicable to this review.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

CA

The applicant proposes to add four dialysis stations to FMC-WF pursuant to Condition 2 of the facility need methodology for a total of 44 stations following project completion.

In Section E, page 40, the applicant describes the alternatives it considered and explains why each alternative is either more costly or less effective than the alternative proposed in this application to meet the need. The alternatives considered were:

- <u>Maintain the Status Quo</u>: the applicant states maintaining the status quo would result in projected utilization of 4.92 patients per station per week by the end of CY 2023 and 5.15 patients per station per week by the end of CY 2024, based on the Cumberland County 5-year AACR; therefore, this is not an effective alternative.
- <u>Apply for Fewer Than Four Stations</u>: the applicant states that applying for fewer than four stations would result in essentially the same outcome as maintaining the status quo; therefore, this is not an effective alternative.
- <u>Apply for More Than Four Stations</u>: the applicant states that applying for more than four stations would require expansion of the building and higher capital expenditures; therefore, this is not an effective alternative.

The applicant adequately demonstrates that the alternative proposed in this application is the most effective alternative to meet the need for the following reasons:

- The application is conforming to all statutory and regulatory review criteria.
- The applicant provides credible information to explain why it believes the proposed project is the most effective alternative.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application
- Supplemental information requested by the Agency
- Information publicly available during the review and used by the Agency

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above. Therefore, the application is approved subject to the following conditions:

- 1. Bio-Medical Applications of North Carolina, Inc. (hereinafter certificate holder) shall materially comply with all representations made in the certificate of need application and any supplemental responses. If representations conflict, the certificate holder shall materially comply with the last made representation.
- 2. Pursuant to Condition 2 of the facility need determination in the 2021 SMFP, the certificate holder shall develop no more than 4 additional in-center (and home hemodialysis) dialysis stations for a total of no more than 44 in-center (and home hemodialysis) dialysis stations at FMC Services of West Fayetteville upon completion of this project.
- 3. Progress Reports:
 - a. Pursuant to G.S. 131E-189(a), the certificate holder shall submit periodic reports on the progress being made to develop the project consistent with the timetable and representations made in the application on the Progress Report form provided by the Healthcare Planning and Certificate of Need Section. The form is available online at: https://info.ncdhhs.gov/dhsr/coneed/progressreport.html.
 - b. The certificate holder shall complete all sections of the Progress Report form.
 - c. The certificate holder shall describe in detail all steps taken to develop the project since the last progress report and should include documentation to substantiate each step taken as available.
 - d. Progress reports shall be due on the first day of every third month. The first progress report shall be due on April 1, 2022. The second progress report shall be due on July 1, 2022 and so forth.

- 4. The certificate holder shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Agency in writing prior to issuance of the certificate of need.
- (5) Financial and operational projections for the project shall demonstrate the availability of funds for capital and operating needs as well as the immediate and long-term financial feasibility of the proposal, based upon reasonable projections of the costs of and charges for providing health services by the person proposing the service.

The applicant proposes to add four dialysis stations to FMC-WF pursuant to Condition 2 of the facility need methodology for a total of 44 stations following project completion.

Capital and Working Capital Costs

On Form F.1a in Section Q, the applicant projects the total capital cost of the project, as shown in the table below.

On Form F.1a, the applicant provides the assumptions used to project the capital cost. The applicant adequately demonstrates that the projected capital cost is based on reasonable and adequately supported assumptions based on the following:

- The applicant describes each item that makes up the projected capital cost.
- The applicant provided the individual and combined cost of each item that makes up the projected capital cost.

In Section F, page 43, the applicant states there are no projected working capital costs because it is an existing facility that is already operational.

Availability of Funds

In Section F, pages 41-42, the applicant states it will fund the capital cost of the proposed project with accumulated reserves. Exhibit F-2 contains a letter from the applicant on behalf of the Senior Vice President and Treasurer of Fresenius Medical Care Holdings, Inc., the parent company of the applicant, authorizing the use of accumulated reserves for the capital needs of the project. The letter in Exhibit F-2 also states that the 2020 Consolidated Balance Sheet for Fresenius Medical Care Holdings, Inc. shows more than \$446 million in cash and total assets in excess of \$25 billion.

The applicant adequately demonstrates the availability of sufficient funds for the capital needs of the project based on the following:

- The applicant provided a letter from an appropriate company official committing the amount of the projected capital cost to the proposed project.
- The letter from the applicant demonstrates the availability of adequate cash and assets to fund the proposed project.

Financial Feasibility

The applicant provides pro forma financial statements for the first two full fiscal years of operation following completion of the project. On Form F.2 in Section Q, the applicant projects that revenues will exceed operating expenses in the first two full fiscal years following completion of the project, as shown in the table below.

The applicant adequately demonstrates that the financial feasibility of the proposal is reasonable and adequately supported based on the following:

- The applicant adequately explains the assumptions used to project revenue, such as projected reimbursement rates, and operating costs, such as salaries.
- Projected utilization is based on reasonable and adequately supported assumptions. See the discussion regarding projected utilization in Criterion (3) which is incorporated herein by reference.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application

Based on that review, the Agency concludes that the application is conforming to this criterion for the following reasons:

- The applicant adequately demonstrates that the capital costs are based on reasonable and adequately supported assumptions for all the reasons described above.
- The applicant adequately demonstrates availability of sufficient funds for the capital needs of the proposal for all the reasons described above.
- The applicant adequately demonstrates sufficient funds for the operating needs of the proposal and that the financial feasibility of the proposal is based upon reasonable projections of revenues and operating expenses for all the reasons described above.
- (6) The applicant shall demonstrate that the proposed project will not result in unnecessary duplication of existing or approved health service capabilities or facilities.

The applicant proposes to add four dialysis stations to FMC-WF pursuant to Condition 2 of the facility need methodology for a total of 44 stations following project completion.

On page 113, the 2021 SMFP defines the service area for dialysis stations as "...the county in which the dialysis station is located. Each county comprises a service area except for two multicounty service areas: Cherokee, Clay and Graham counties and Avery, Mitchell, and Yancey counties." Thus, the service area for this facility consists of Cumberland County. Facilities may serve residents of counties not included in their service area.

Table 9A on page 121 of the 2021 SMFP lists five existing or approved dialysis facilities in Cumberland County as of December 31, 2019. Information about each of the five facilities is shown in the table below.

In Section G, page 48, the applicant explains why it believes its proposal would not result in the unnecessary duplication of existing or approved dialysis services in Cumberland County. The applicant states:

"This is an application based upon the facility performance and demonstrated need at FMC Services of West Fayetteville. The need addressed by this application is not specific to Cumberland County as a whole."

On page 49, the applicant further states that four of the five facilities operating in Cumberland County are operating above 70 percent utilization and that the only facility which is not – Fresenius Kidney Care Rockfish – has an artificially depressed utilization rate because it is used exclusively for patients with COVID-19.

The applicant adequately demonstrates that the proposal will not result in an unnecessary duplication of existing or approved services in the service area based on the following:

- The applicant proposes to increase the number of dialysis stations in Cumberland County based on Condition 2 of the facility need determination in the 2021 SMFP.
- The applicant adequately demonstrates that the proposed dialysis stations are needed in addition to the existing or approved dialysis stations in Cumberland County.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application
- Information which was publicly available during the review and used by the Agency

Based on that review, the Agency concludes that the application is conforming to this criterion for all the reasons described above.

(7) The applicant shall show evidence of the availability of resources, including health manpower and management personnel, for the provision of the services proposed to be provided.

Adequate operating expenses for the health manpower and management positions proposed by the applicant are budgeted in Form F.4 in Section Q. In Section H, pages 50-51, the applicant describes the methods used to recruit or fill new positions and its existing training and continuing education programs.

The applicant adequately demonstrates the availability of sufficient health manpower and management personnel to provide the proposed services based on the following:

- The applicant projects sufficient operating expenses for the staff proposed by the applicant.

(8) The applicant shall demonstrate that the provider of the proposed services will make available, or otherwise make arrangements for, the provision of the necessary ancillary and support services. The applicant shall also demonstrate that the proposed service will be coordinated with the existing health care system.

The applicant proposes to add four dialysis stations to FMC-WF pursuant to Condition 2 of the facility need methodology for a total of 44 stations following project completion.

Ancillary and Support Services

In Section I, page 52, the applicant identifies the necessary ancillary and support services for the proposed services. In Section I, pages 52-57, the applicant explains how each ancillary and support service is or will be made available. The applicant adequately demonstrates that the necessary ancillary and support services will be made available based on the following:

- The facility is an existing facility already providing the necessary ancillary and support services.
- The applicant describes the structure in place at both the corporate level and the facility level for providing the necessary ancillary and support services.

Coordination

In Section I, page 57, the applicant describes its existing and proposed relationships with other local health care and social service providers and provides supporting documentation in Exhibit H-4. The applicant adequately demonstrates that the proposed services will be coordinated with the existing health care system based on the following:

- The facility is an existing facility that has existing relationships with local health care and social service providers.
- The applicant provides a letter from the medical director of the facility attesting to the relationship between the medical director's physician practice and the facility.

The applicant does not project to provide the proposed services to a substantial number of persons residing in Health Service Areas (HSAs) that are not adjacent to the HSA in which the services will be offered. Furthermore, the applicant does not project to provide the proposed services to a substantial number of persons residing in other states that are not adjacent to the North Carolina county in which the services will be offered. Therefore, Criterion (9) is not applicable to this review.

- (10) When applicable, the applicant shall show that the special needs of health maintenance organizations will be fulfilled by the project. In Section K, pages 60-61, the applicant states that the project involves renovating existing storage space by moving a wall and extending the water treatment system. Line drawings are provided in Exhibit K-2.

On page 60, the applicant adequately explains how the cost, design, and means of construction represent the most reasonable alternative for the proposal based on the following:

• The applicant proposes to develop the project in existing space currently used for storage.

• The applicant states developing the project in existing space is more cost effective than expanding the building.

On page 61, the applicant adequately explains why the proposal will not unduly increase the costs to the applicant of providing the proposed services or the costs and charges to the public for the proposed services based on the following:

- The applicant states the costs are necessary to provide continued convenient access to care for area patients.
- The applicant states the cost of the project is not being passed on to patients and is being absorbed by the applicant.

On pages 61-62, the applicant identifies any applicable energy saving features that will be incorporated into the construction plans.

For the purpose of determining the extent to which the proposed service will be accessible, the applicant shall show:
 - (a) The extent to which medically underserved populations currently use the applicant's existing services in comparison to the percentage of the population in the applicant's service area which is medically underserved;

On page 113, the 2021 SMFP defines the service area for dialysis stations as "...the county in which the dialysis station is located. Each county comprises a service area except for two multicounty service areas: Cherokee, Clay and Graham counties and Avery, Mitchell, and Yancey counties." Thus, the service area for this facility consists of Cumberland County. Facilities may serve residents of counties not included in their service area.

Table 9A on page 121 of the 2021 SMFP lists five existing or approved dialysis facilities in Cumberland County as of December 31, 2019. Information about each of the five facilities is shown in the table below.

Regarding the expected effects of the proposal on competition in the service area, in Section N, page 72, the applicant states:

"The applicant does not expect this proposal to have any effect on the competitive climate in Cumberland County. The applicant does not project to serve dialysis patients currently being served by another provider."

Regarding the impact of the proposal on cost effectiveness, in Section N, page 73, the applicant states:

"This is a proposal to add four stations to the [sic] FMC Services of West Fayetteville. The applicant is serving a significant number of dialysis patients residing in the area of the facility. Approval of this application will allow the facility to continue serving patients who reside in the area. Consequently, these patients will have a shorter commute to and from dialysis treatment. This is an immediate and significantly positive impact to the patients of the area."

See also Sections C, F, and Q of the application and any exhibits.

Regarding the impact of the proposal on quality, in Section N, page 73, the applicant states:

"Quality of care is always in the forefront at Fresenius Medical Care related facilities. Quality care is not negotiable. Fresenius Medical Care, parent organization for this facility, expects every facility to provide high quality care to every patient at every treatment."

See also Sections C and O of the application and any exhibits.

Regarding the impact of the proposal on access by medically underserved groups, in Section N, page 73, the applicant states:

"All Fresenius Medical Care related facilities in North Carolina have a history of providing dialysis services to the underserved populations of North Carolina. Each of those facilities has a patient population which includes low-income persons, racial

and ethnic minorities, women, [people with disabilities], elderly, or other traditionally underserved persons.

It is corporate policy to provide all services to all patients regardless of income, racial/ethnic origin, gender, physical or mental conditions, age, or any other factor that would classify a patient as underserved.

Fresenius related facilities in North Carolina have historically provided substantial care and services to all persons in need of dialysis services, regardless of income, racial or ethnic background, gender, [disability], age or any other grouping/category or basis for being an underserved person. Low income and medically underinsured persons will continue to have access to all services provided by Fresenius related facilities."

See also Sections C and L of the application and any exhibits.

The applicant adequately describes the expected effects of the proposed services on competition in the service area and adequately demonstrates the proposal would have a positive impact on cost-effectiveness, quality, and access because the applicant adequately demonstrates that:

- 1) The proposal is cost effective because the applicant adequately demonstrated: a) the need the population to be served has for the proposal; b) that the proposal would not result in an unnecessary duplication of existing and approved health services; and c) that projected revenues and operating costs are reasonable.
- 2) Quality care would be provided based on the applicant's representations about how it will ensure the quality of the proposed services and the applicant's record of providing quality care in the past.
- 3) Medically underserved groups will have access to the proposed services based on the applicant's representations about access by medically underserved groups and the projected payor mix.

The applicant proposes to add four dialysis stations to FMC-WF pursuant to Condition 2 of the facility need methodology for a total of 44 stations following project completion.

On Form O in Section Q, the applicant identifies the kidney disease treatment centers located in North Carolina owned, operated, or managed by the applicant or a related entity. The applicant identifies a total of 126 existing or approved kidney disease treatment facilities located in North Carolina.

In Section O, page 78, the applicant states that, during the 18 months immediately preceding the submittal of the application, there were no incidents resulting in an Immediate Jeopardy violation that occurred in any of these facilities. After reviewing and considering information provided by the applicant and publicly available data and considering the quality of care provided at all 126 facilities, the applicant provides sufficient evidence that quality care has been provided in the past. Therefore, the application is conforming to this criterion.
