REVIEW CRITERIA

G.S. 131E-183(a): The Department shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

C

Bio-Medical Applications of North Carolina, Inc. (BMA or "the applicant"), proposes to add no more than six in-center (IC) dialysis stations to the BMA of Greensboro facility pursuant to Condition 2 of the facility need methodology for a total of no more than 56 IC dialysis stations upon completion of this project and Project ID# G-12130-21 (develop a new 16 station dialysis facility by relocating no more than four stations from BMA of Greensboro, four stations from FMC High Point and eight stations from BMA of Southwest Greensboro).

Need Determination (Condition 2)

Chapter 9 of the 2022 State Medical Facilities Plan (SMFP) provides a county need methodology and a facility need methodology for determining the need for new dialysis

stations. According to Table 9B, the county need methodology shows there is not a county need determination for additional dialysis stations in Guilford County.

However, the applicant is eligible to apply for additional dialysis stations in an existing facility pursuant to Condition 2 of the facility need methodology in the 2022 SMFP, if the utilization rate for the facility as reported in the 2022 SMFP is at least 75 percent or 3.0 patients per station per week, as stated in Condition 2.a. The utilization rate reported for the facility is 78.92 percent or 3.15 patients per station per week, based on 161 in-center dialysis patients and 51 certified dialysis stations (161 patients / 51 stations = 3.1568; 3.1568 / 4 = 78.92%).

As shown in Table 9D, based on the facility need methodology for dialysis stations, the potential number of stations needed is up to nine additional stations; thus, the applicant is eligible to apply to add up to nine stations during the 2022 SMFP review cycle pursuant to Condition 2 of the facility need methodology.

The applicant proposes to add no more than six new stations to the facility, which is consistent with the 2022 SMFP calculated facility need determination for up to nine stations; therefore, the application is consistent with Condition 2 of the facility need determination for dialysis stations.

Policies

There is one policy in the 2022 SMFP that is applicable to this review, Policy GEN-3: *Basic Principles*.

Policy GEN-3, page 30 of the 2022 SMFP, states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

Promote Safety and Quality

The applicant describes how it believes the proposed project will promote safety and quality in Section B, page 21; Section N, page 77; Section O, pages 79-82; and referenced exhibits. The information provided by the applicant is reasonable and supports the determination that the applicant's proposal will promote safety and quality.

Promote Equitable Access

The applicant describes how it believes the proposed project will promote equitable access in Section B, page 22; Section C, page 34; Section L, pages 69-74; Section N, page 77; and referenced exhibits. The information provided by the applicant is reasonable and supports the determination that the applicant's proposal will promote equitable access.

Maximize Healthcare Value

The applicant describes how it believes the proposed project will maximize healthcare value in Section B, pages 22-23; Section F, pages 45-50; Section N, page 77; and referenced exhibits. The information provided by the applicant is reasonable and supports the determination that the applicant's proposal will maximize healthcare value.

The applicant adequately demonstrates how its proposal incorporates the concepts of quality, equitable access and maximum value for resources expended in meeting the facility need as identified by the applicant. Therefore, the application is consistent with policy GEN-3.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application
- Information publicly available during the review and used by the Agency

Based on that review, the Agency concludes that the application is conforming to this criterion based on the following:

- The applicant adequately demonstrates that the application is consistent with the facility need methodology as applied from the 2022 SMFP.
- The applicant adequately demonstrates that the application is consistent with Policy GEN-3 based on:
 - o Fresenius Medical Care (parent company) facilities encourage all staff to provide quality care to every patient at every treatment as part of their quality care program.
 - o BMA facilities have a history of providing care and services to all persons in need of dialysis services, regardless of income, racial or ethnic background, gender, handicap, age or any other grouping/category defined as underserved. The majority of the kidney disease treatments are reimbursed by Medicaid and Medicare.
 - The applicant takes on the burden of developing the project by seeking funding from its parent company, Fresenius Medical Care, which ensures dialysis treatment is available at a convenient location.
- (2) Repealed effective July 1, 1987.
- (3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which

all residents of the area, and, in particular, low income persons, racial and ethnic minorities, women, ... persons [with disabilities], the elderly, and other underserved groups are likely to have access to the services proposed.

The applicant proposes to add no more than six IC dialysis stations to the BMA of Greensboro facility pursuant to Condition 2 of the facility need methodology for a total of no more than 56 IC dialysis stations upon completion of this project and Project ID# G-12130-21 (develop a new 16 station dialysis facility).

Patient Origin

On page 115, the 2022 SMFP defines the service area for dialysis stations as "the service area is the county in which the dialysis station is located. Thus, the service area for this facility consists of Guilford County. Facilities may also serve residents of counties not included in their service area.

In Section C, pages 26-29 and Section Q, pages 85-91, the applicant provides the assumptions and methodology used to project its patient origin. The applicant's patient origin projections are reasonable and adequately supported because they are based the historical (CY2021) patient origin for the facility and projected forward using the Guilford County Five-Year Average Annual Change Rate (AACR) of 3.3%, as published in the 2022 SMFP.

Analysis of Need

In Section C, page 31, the applicant explains why it believes the population projected to utilize the proposed services needs the proposed services. On page 30, the applicant states:

"The need that this population has for the proposed services is a function of the individual patient need for dialysis care and treatment. This question specifically addresses the need that the population to be served has for the proposed project. The applicant has identified the populations to be served as 156.8 in-center dialysis patients dialyzing with the facility as of the end of the first Operating Year of the project. This equates to a utilization rate of 70.0%, or 2.8 patients per station and exceeds the minimum required by the performance standard."

The information is reasonable and adequately supported based on the following:

- The applicant demonstrates eligibility to add dialysis stations to its facility under Condition 2 of the facility need methodology, as stated in the 2022 SMFP. The discussion regarding need methodology found in Criterion (1) is incorporated herein by reference.
- The applicant adequately demonstrates need based on the facility's historical growth in the patient population.

Projected Utilization

In Section C, pages 27-29, and Section Q, pages 87 and 89-90, the applicant provides projected utilization, as illustrated in the following table.

In Section C, pages 26-29, and Section Q, pages 85-91, the applicant provides the assumptions and methodology used to project utilization, which is summarized below.

- The applicant begins its projections with the facility patient census as of December 31, 2021, as reported in the 2021 ESRD Data Collection Forms submitted to the Agency.
- The applicant projects growth of the Guilford County patient census using the Caldwell [Guilford] County Five-Year AACR of 3.3%, as published in the 2022 SMFP. On page 26, the applicant states that the Caldwell County AACR was used, however, the Project Analyst concludes that this was a typographical error. The analyst's correction is in brackets.
- The applicant assumes that the five IC patients residing in Randolph and Rockingham Counties (contiguous to Guilford County), will continue dialysis at BMA of Greensboro by choice and does not project any growth for this segment of the patient population but adds these patients to projections of future patient populations at the appropriate time.
- The applicant assumes that the 11 Guilford County IC patients will transfer their care to the FKC Sandy Ridge facility on December 31, 2023 (Project ID# G-12130-21) and subtracts these patients to projections of future patient populations at the appropriate time.
- The applicant assumes that the four IC patients and the three PD patients residing in Forsyth, Randolph, and Rockingham Counties (contiguous to Guilford County), will continue dialysis at BMA of Greensboro by choice. The applicant assumes that the three PD patients residing in the State of Virginia will continue dialysis at BMA of Greensboro by choice because PD patients are not required to travel to a dialysis clinic three days a week for treatment. The applicant does not project any growth for this segment of the patient population but adds these patients to projections of future patient populations at the appropriate time.
- The applicant projects the first operating year of the project will be January 1, 2024—December 31, 2024 and the second operating year will be January 1, 2025-December 31, 2025.

At the end of OY1, BMA of Greensboro is projected to serve 156.8 IC patients on 56 stations and at the end of OY2, the facility is projected to serve 161.8 IC patients on 56 stations.

The projected utilization rates for the end of first two operating years are as follows:

- OY1: 2.8 IC patients per station per week or 70.00% (156.8 IC patients / 56 stations = 2.8/4 = 0.7 or 70.00%)
- OY2: 2.9 IC patients per station per week or 72.23% (161.8 IC patients / 56 stations = 2.8892/4 = 0.7223 or 72.23%)

The projected utilization of 2.8 patients per station per week at the end of OY1 meets the minimum standard of 2.8 in-center patients per station per week required by 10A NCAC 14C .2203(b).

Projected utilization is reasonable and adequately supported based on the following:

- The applicant's proposal to add six dialysis stations will meet the need of the projected growth of the facility's patient population.
- Projected utilization at the end of OY1 meets the minimum of 2.8 patients per station per week required by 10A NCAC 14C .2203(b).

Access to Medically Underserved Groups

In Section C, page 34, the applicant states:

"It is corporate policy to provide all services to all patients, regardless of income, racial/ethnic origin, gender, physical or mental conditions, age, or health insurer."

The applicant provides the estimated percentage during the second full fiscal year for each medically underserved group, as shown in the following table.

The applicant adequately describes the extent to which all residents of the service area, including underserved groups, are likely to have access to the proposed services because BMA of Greensboro is an existing dialysis facility in Guilford County currently providing services to medically underserved groups.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application
- Information publicly available during the review and used by the Agency

Based on that review, the Agency concludes that the application is conforming to this criterion for all the reasons described above.

(3a) In the case of a reduction or elimination of a service, including the relocation of a facility or a service, the applicant shall demonstrate that the needs of the population presently served will be met adequately by the proposed relocation or by alternative arrangements, and the effect of the reduction, elimination or relocation of the service on the ability of low income persons, racial and ethnic minorities, women, ... persons [with disabilities], and other underserved groups and the elderly to obtain needed health care.

The applicant does not propose to reduce a service, eliminate a service or relocate a facility or service. Therefore, Criterion (3a) is not applicable to this review.

(4) Where alternative methods of meeting the needs for the proposed project exist, the applicant shall demonstrate that the least costly or most effective alternative has been proposed.

The applicant proposes to add no more than six IC dialysis stations to the BMA of Greensboro facility pursuant to Condition 2 of the facility need methodology for a total of no more than 56 IC dialysis stations upon completion of this project and Project ID# G-12130-21 (develop a new 16 station dialysis facility).

In Section E, page 43, the applicant describes the alternatives it considered and explains why each alternative is either more costly or less effective than the alternative proposed in this application to meet the need. The alternatives considered were:

Do Not File for Additional Stations at BMA of Greensboro-The applicant states that failure to apply for additional stations would result in high utilization rates at the facility. The applicant projects a utilization rate of 3.2 by the second operating year without the additional stations, which can potentially interrupt patient admissions.

Apply for Fewer than Six Stations-The applicant states this alternative would have the same effect as not applying for any stations.

Apply for More Than Six Stations-The applicant states that this alternative would not be cost-effective. The facility cannot accommodate more than 56 dialysis stations.

The applicant adequately demonstrates that the alternative proposed in this application is the most effective alternative to meet the need based on the following:

- Adding the six stations will avoid higher utilization rates that can potentially interrupt patient services.
- The applicant provides reasonable information to explain why it believes the proposed project is the most effective alternative.

• The application is conforming to all other statutory and regulatory review criteria. Therefore, the application can be approved.

Conclusion

The Agency reviewed the:

- Application
- Exhibits to the application

Based on that review, the Agency concludes that the application is conforming to this criterion for the reasons stated above. Therefore, the application is approved subject to the following conditions:

- 1. Bio-Medical Applications of North Carolina, Inc. (hereinafter certificate holder) shall materially comply with all representations made in the certificate of need application.
- 2. Pursuant to Condition 2 of the facility need determination in the 2022 SMFP, the certificate holder shall develop no more than six additional in-center dialysis stations for a total of no more than 56 in-center stations at BMA of Greensboro upon completion of this project and Project ID# G-12130-21 (develop a new 16 station dialysis facility).

3. Progress Reports

- a. Pursuant to G.S. 131E-189(a), the certificate holder shall submit periodic reports on the progress being made to develop the project consistent with the timetable and representations made in the application on the Progress Report form provided by the Healthcare Planning and Certificate of Need Section. The form is available online at: https://info.ncdhhs.gov/dhsr/coneed/progressreport.html.
- b. The certificate holder shall complete all sections of the Progress Report form.
- c. The certificate holder shall describe in detail all steps taken to develop the project since the last progress report and should include documentation to substantiate each step taken as available.
- d. The first progress report shall be due on September 1, 2023.
- 4. The certificate holder shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Agency in writing prior to issuance of the certificate of need.
- (5) Financial and operational projections for the project shall demonstrate the availability of funds for capital and operating needs as well as the immediate and long-term financial feasibility of the proposal, based upon reasonable projections of the costs of and charges for providing health services by the person proposing the service.

The applicant proposes to add no more than six IC dialysis stations to the BMA of Greensboro facility pursuant to Condition 2 of the facility need methodology for a total of no more than 56 IC dialysis stations upon completion of this project and Project ID# G-12130-21 (develop a new 16 station dialysis facility).

Capital and Working Capital Costs

In Section Q, page 93, the applicant projects the total capital cost of the project, as shown in the table below.

In Section Q, page 94, the applicant provides the assumptions used to project the capital cost. The applicant adequately demonstrates that the projected capital cost is based on the cost of what is required to add the six additional stations. The applicant states that this includes patient chairs and TVs and office furniture.

In Section F, page 47, the applicant states that there will be no start-up or initial operating expenses associated with the proposed project because BMA of Greensboro is an existing facility.

Availability of Funds

In Section F, page 45, the applicant states that the capital cost will be funded, as shown in the table below.

Exhibit F-2 contains a letter dated March 15, 2022, from the Senior Vice President and Treasurer for Fresenius Medical Care Holdings, Inc., parent company to Bio-Medical Applications of North Carolina, Inc., authorizing the use of accumulated reserves for the capital needs of the project. The letter states that in their 2020 Consolidated Balance Sheets,

Fresenius Medical Care Holdings, Inc. had over \$446 million in cash and over \$25 billion in assets to fund the capital cost of the proposed project.

Financial Feasibility

The applicant provided pro forma financial statements for the first two full fiscal years of operation following completion of the project. In Form F.2, the applicant projects that revenues will exceed operating expenses in the first two full fiscal years following completion of the project, as shown in the table below.

- The applicant provides reasonable assumptions in determining revenue and operating expenses in preparation of Form F.2, F.3 and F.4.
- Projected utilization is based on reasonable and adequately supported assumptions. See the discussion regarding projected utilization in Criterion (3) which is incorporated herein by reference.

Based on that review, the Agency concludes that the application is conforming to this criterion for the following reasons:

- The applicant adequately demonstrates that the capital costs are based on reasonable and adequately supported assumptions for all the reasons described above.
- The applicant adequately demonstrates availability of sufficient funds for the capital needs of the proposal for all the reasons described above.

- The applicant adequately demonstrates sufficient funds for the operating needs of the proposal and that the financial feasibility of the proposal is based upon reasonable projections of revenues and operating expenses for all the reasons described above.
- (6) The applicant shall demonstrate that the proposed project will not result in unnecessary duplication of existing or approved health service capabilities or facilities.

In Section G, page 53, the applicant explains why it believes its proposal would not result in the unnecessary duplication of existing or approved dialysis services in Guilford County. The applicant states:

"This is an application based upon the facility performance and demonstrated need at BMA Greensboro facility...The applicant has not projected to serve patients currently served in another facility, or served by another provider."

The applicant adequately demonstrates that the proposal would not result in an unnecessary duplication of existing or approved services in the service area based on the following:

- The applicant adequately demonstrates that the proposed dialysis stations are needed in addition to the existing or approved dialysis station.
- There is a facility need determination in the 2022 SMFP for the proposed six dialysis stations.

Conclusion

Based on that review, the Agency concludes that the application is conforming to this criterion for all the reasons described above.

(7) The applicant shall show evidence of the availability of resources, including health manpower and management personnel, for the provision of the services proposed to be provided.

The applicant proposes to add no more than six IC dialysis stations to the BMA of Greensboro facility pursuant to Condition 2 of the facility need methodology for a total of no more than 56 IC dialysis stations upon completion of this project and Project ID# G-12130-21 (develop a new 16 station dialysis facility).

The assumptions and methodology used to project staffing are provided in Section Q, page 106. Adequate operating expenses for the health manpower and management positions proposed by the applicant are budgeted in F.4. In Section H, pages 54-55, the applicant describes the methods used to recruit or fill new positions and its existing training and continuing education programs.

The applicant adequately demonstrates the availability of sufficient health manpower and management personnel to provide the proposed services based on the following:

- BMA of Greensboro is an existing facility in Guilford County that has demonstrated its ability to attract qualified staff by offering a wide range of personnel benefits and maintain competitive salaries.
- In response to the pandemic's impact on staffing, Fresenius Medical Care, parent company to BMA, has implemented initiatives such as, sign-on and retention bonuses, increased starting salaries and intensified recruiting efforts.
- New employees are required to complete a 10-week training program that includes safety precautions in addition to clinical training.

Based on that review, the Agency concludes that the application is conforming to this criterion for all the reasons described above.

In Section I, page 61, the applicant describes its existing and proposed relationships with other local health care and social service providers. The applicant adequately demonstrates that the proposed services will be coordinated with the existing health care system based on its established relationships with other physicians and hospitals in the area and its agreements for lab services, hospital affiliation and transplant.

As shown in the table above, during the second full fiscal year of operation, the applicant projects that 2.27% of total IC dialysis services will be provided to self-pay patients, 77.65% of total IC dialysis services to Medicare patients and 5.05% of total IC dialysis services to Medicaid patients.

On page 115, the 2022 SMFP defines the service area for dialysis stations as "the service area is the county in which the dialysis station is located. Thus, the service area for this facility consists of Guilford County. Facilities may also serve residents of counties not included in their service area.

Regarding the impact of the proposal on quality, in Section N, page 77, the applicant states:

"Fresenius Medical Care, parent organization for this facility, expects every facility to provide high quality care to every patient at every treatment."

Regarding the impact of the proposal on access by medically underserved groups, in Section N, page 77, the applicant states:

"It is corporate policy to provide all services to all patients regardless of income, racial/ethnic origin, gender, physical or mental conditions, age, or any other factor that would classify a patient as underserved."

See also Sections B, L and C of the application and any exhibits.

The applicant adequately describes the expected effects of the proposed services on competition in the service area and adequately demonstrates the proposal would have a positive impact on cost-effectiveness, quality, and access because the applicant adequately demonstrates that:

- 1) The proposal is cost effective because the applicant adequately demonstrated: a) the need the population to be served has for the proposal; b) that the proposal would not result in an unnecessary duplication of existing and approved health services; and c) that projected revenues and operating costs are reasonable.
- 2) Quality care would be provided based on the applicant's representations about how it will ensure the quality of the proposed services.
- 3) Medically underserved groups will have access to the proposed services based on the applicant's representations about access by medically underserved groups and the projected payor mix.

In Section O, page 82, the applicant states that, during the 18 months immediately preceding the submittal of the application, incidents related to immediate jeopardy had not occurred in any of these facilities. After reviewing and considering information provided by the applicant, the applicant provided sufficient evidence that quality care has been provided in the past. Therefore, the application is conforming to this criterion.
