Each application was reviewed independently against the applicable statutory review criteria found in G.S. 131E-183(a) and the regulatory review criteria found in 10A NCAC 14C. After completing an independent analysis of each application, the Healthcare Planning and Certificate of Need Section (CON Section) also conducted a comparative analysis of all the applications. The Decision, which can be found at the end of the Required State Agency Findings (Findings), is based on the independent analysis and the comparative analysis.

REVIEW CRITERIA

G.S. 131E-183(a): The Department shall review all applications utilizing the criteria outlined in this subsection and shall determine that an application is either consistent with or not in conflict with these criteria before a certificate of need for the proposed project shall be issued.

(1) The proposed project shall be consistent with applicable policies and need determinations in the State Medical Facilities Plan, the need determination of which constitutes a determinative limitation on the provision of any health service, health service facility, health service facility beds, dialysis stations, operating rooms, or home health offices that may be approved.

C Both Applications

Need Determination

The 2022 State Medical Facilities Plan (SMFP) includes a need methodology for determining the need for additional fixed Magnetic Resonance Imaging (MRI) scanners in North Carolina by service area. Application of the need methodology in the 2022 SMFP identified a need for one fixed MRI scanner in the Pitt/Greene/Hyde/Tyrrell County service area. Two applications were received by the Healthcare Planning and Certificate of Need Section (CON Section) with each proposing to acquire one fixed MRI scanner. However, pursuant to the need determination, only one fixed MRI scanner may be approved in this review.

Policies

Policy GEN-3: Basic Principles of the 2022 SMFP is applicable to both applications.

Policy GEN-3

Policy GEN-3 on page 30 of the 2022 SMFP states:

"A certificate of need applicant applying to develop or offer a new institutional health service for which there is a need determination in the North Carolina State Medical Facilities Plan shall demonstrate how the project will promote safety and quality in the delivery of health care services while promoting equitable access and maximizing healthcare value for resources expended. A certificate of need applicant shall document its plans for providing access to services for patients with limited financial resources and demonstrate the availability of capacity to provide these services. A certificate of need applicant shall also document how its projected volumes incorporate these concepts in meeting the need identified in the State Medical Facilities Plan as well as addressing the needs of all residents in the proposed service area."

Q-12286-22/ Orthopaedics East and Sports Medicine Center / Acquire no more than one fixed MRI scanner pursuant to the 2022 SMFP need determination Orthopaedics East and Sports Medicine Center, Inc. and Orthopaedics East Properties, hereinafter referred to as "the applicant" or "OrthoEast", proposes to add one fixed MRI scanner to the existing medical clinic in Pitt County, pursuant to the 2022 SMFP need determination. The applicant is proposing to add an addition to the medical clinic to house the proposed fixed MRI scanner. The clinic currently offers MRI services via a leased mobile MRI scanner.

Need Determination. The applicant does not propose to develop more fixed MRI scanners than are determined to be needed in the Pitt/Greene/Hyde/Tyrrell County service area. *Policy GEN-3.* In Section B.2, pages 25-26, the applicant explains why it believes its application is conforming to Policy GEN-3.

 - The applicant adequately documents how the project will promote equitable access to MRI services in Pitt County; and
 - The applicant adequately documents how the project will maximize healthcare value for the resources expended.

Q-12294-22/ Greenville MRI / Acquire no more than one fixed MRI scanner pursuant to the 2022 SMFP need determination

Greenville MRI, LLC, hereinafter referred to as "the applicant" or "Greenville MRI," proposes to add one fixed MRI scanner pursuant to the 2022 SMFP need determination for a total of three MRI scanners, located at Greenville MRI, a physician practice.

Need Determination. The applicant does not propose to develop more fixed MRI scanners than are determined to be needed in the Pitt/Greene/Hyde/Tyrrell County service area.

Policy GEN-3. In Section B.2, pages 28-30, the applicant explains why it believes its application is conforming to Policy GEN-3.

- (3) The applicant shall identify the population to be served by the proposed project, and shall demonstrate the need that this population has for the services proposed, and the extent to which all residents of the area, and, in particular, low income persons, racial and ethnic minorities, women, ... persons [with disabilities], the elderly, and other underserved groups are likely to have access to the services proposed.

Q-12286-22/ Orthopaedics East and Sports Medicine Center / Acquire no more than one fixed MRI scanner pursuant to the 2022 SMFP need determination

The applicant proposes to add one fixed MRI scanner to the existing medical clinic in Pitt County, pursuant to the 2022 SMFP need determination.

The applicant is proposing to acquire a fixed MRI scanner and add an addition to the medical clinic to house the proposed scanner. In Section C, page 27, the applicant states that the projected total capital cost will be \$2,313,519.

Designation as a Diagnostic Center

N.C. Gen. Stat. 131E-176(7a) states:

"Diagnostic center. – a freestanding facility, program, or provider, including but not limited to, physicians' offices, clinical laboratories, radiology centers, and mobile diagnostic programs, in which the total cost of all the medical diagnostic equipment utilized by the facility which cost ten thousand dollars (\$10,000) or more exceeds one million five hundred dollars (\$1,500,000). In determining whether the medical diagnostic equipment in a diagnostic center costs more than exceeds one million five hundred dollars (\$1,500,000), the costs of the equipment, studies, surveys, designs, plans, working drawings, specifications, construction, installation, and other activities essential to acquiring and making operational the equipment shall be included. The capital expenditure for the equipment shall be deemed to be the fair market value of the equipment or the cost of the equipment, whichever is greater..."

In Section Q, page 114, the applicant projects that the total cost of the proposed medical diagnostic equipment which costs \$10,000 or more, and the cost of the addition to the medical clinic to house the scanner exceeds the statutory threshold of \$1,500,000. Therefore, Orthopaedics East and Sports Medicine Center qualifies as a diagnostic center, which is a new institutional health service, and which requires a Certificate of Need (CON).

Patient Origin

The 2022 SMFP defines the service area for a fixed MRI scanner as "the same as an Acute Care Bed Service area as defined in Chapter 5 and shown in Figure 5.1...Counties with at least one licensed acute care hospital that are not grouped with another county are single county service areas." Therefore, for the purpose of this review, the fixed MRI service area is a multicounty service area that consists of Pitt, Green, Hyde and Tyrrell Counties. Facilities may also serve residents of counties not included in their service area.

In Section C, page 32, the applicant provides the assumptions and methodology used to project its patient origin. On page 32, the applicant states:

"OrthoEast projects the fixed MRI scanner patient origin based on its historical mobile MRI scanner patient origin."

The applicant's assumptions are reasonable and adequately supported.

Analysis of Need

In Section C, pages 35-45, the applicant explains why it believes the population projected to utilize the proposed services needs the proposed services, as summarized below.

- The 2022 SMFP need methodology determined a need for one fixed MRI scanner in the Pitt/Greene/Hyde/Tyrrell County service area (page 36).
- The number of weighted procedures performed on the existing fixed and mobile MRI scanners located in Pitt County has consistently grown over the last five fiscal years (pages 36-38).
- Based on OrthoEast's internal data, the facility experienced a 3-year (CY 2018 CY 2021) Compound Annual Growth Rate (CAGR) of 8.30% of weighted and

unweighted MRI procedures performed on the existing mobile MRI scanner and a 4-year (CY 2018 – CY 2022) CAGR of 6.56% (page 38).

- The existing mobile MRI scanner limits access to MRI services due to the location of the scanner and the limitations for obese and claustrophobic patients (page 39).
- The applicant is proposing to offer MRI services in a freestanding location which will provide services at a lower cost as opposed to MRI services performed in a hospital, which can incur hospital-based costs (pages 40-41).
- The projected population growth in the service area, particularly among the age cohort more likely to utilize healthcare services, drives the need to increase access to MRI services. Additionally, the health status and risk factors of Pitt County residents supports the need expand MRI capacity (pages 41-45).
- OrthoEast's support of physicians and referring providers from Pitt County and surrounding counties (page 45).

Projected utilization is reasonable and adequately supported based on the application, exhibits to the application, written comments, responses to comments, and information publicly available during the review and used by the Agency, including, but not limited to, the bullets points listed below:

- The 2022 SMFP identifies the need for one additional fixed MRI scanner in the Pitt/Greene/Hyde/Tyrrell County service area.
- Historical utilization and MRI use rates of the existing MRI scanners in Pitt County.
- Population growth, particularly among the elderly is occurring in the service area.
- The applicant uses clearly cited and reasonable historical and demographic data to identify the population to be served, its projected growth, and the need for the proposed services.
- A letter from Eastern Radiologists expressing their support for the proposed project. See Exhibit I.2.

To estimate the number of MRI scans performed during CY 2022, the applicant annualized the actual utilization for the initial nine months of 2022. OrthoEast experienced a 3-year (CY 2018 – CY 2021) CAGR of 8.30% of unweighted MRI scans performed on the existing mobile MRI scanner and a 4-year (CY 2018 – CY 2022) CAGR of 6.56%.

Step 2: Project fixed MRI scanner utilization for the first three years of the project.

The applicant projects utilization using one third of the historical 3-year CAGR of 6.56%. The applicant states that using a CAGR of 2.19% is conservative and reasonable based on OrthoEast's plan to expand the scope of services and the addition of two new surgeons. The following table illustrates projected utilization.

Step 3: Project utilization of patients previously not accommodated by OrthoEast

Step 4: Project adjusted fixed MRI scanner utilization

The applicant projects adjusted fixed MRI scanner utilization using the historical five-year average weighting ratio of 1.011 and projects that it will remain constant through the third operating year. The applicant projects that OrthoEast will perform 3,605 weighted MRI scans by the third operating year. Step 5: Project OrthoEast MRI service market share in Pitt County

To project OrthoEast's market share in Pitt County, the applicant begins with the Pitt County market share using Pitt County's five-year (FY 2017 - FY 2021) average MRI use rate of 193.5. The projected Pitt County population was multiplied by the average use rate to project the number of Pitt County procedures. The applicant states that using the 5-year average MRI use rate is conservative considering that actual Pitt County MRI use rate was 222.1 in 2021. The applicant projects that OrthoEast will have a 10.61% market share by the third operating year. The applicant states that the projections are conservative and reasonable because OrthoEast would have an inventory of one MRI scanner out of the 9.52 Pitt County inventory which would result in an MRI use rate of 10.50% (1/9.52).

Projected utilization is reasonable and adequately supported based on the application, exhibits to the application, written comments, responses to comments, and information publicly available during the review and used by the Agency, including, but not limited to, the highlighted points listed below:

- There is a need determination in the 2022 SMFP for a fixed MRI scanner in the Pitt/Greene/Hyde/Tyrrell County service area. The proposed project will meet that need determination by developing a fixed MRI scanner in Pitt County.
- Population is growing in Pitt County, particularly among the 65+ age group, the primary users of imaging services. There is a projected 2.8% annual growth rate from 2022 to 2026.
- To project utilization the applicant utilized an MRI use rate per 1,000 people of 193.5 which is conservative as it is below the Pitt County MRI use rate in the most recent full year of MRI utilization.
- The methodology and assumptions utilized by the applicant were reasonable, conservative and well supported. The applicant's projected total unweighted Pitt County MRI procedures combined with its projected market share of those MRI procedures combined with projected number of recaptured procedures is reasonable.
- MRI scans performed in a freestanding facility are generally less costly than MRI scans performed in a hospital licensed facility.

• The applicant's expansion of services and the MRI physician/provider referral base.

Access to Medically Underserved Groups

In Section C, page 50, the applicant states:

"Patients obtain access to OrthoEast MRI services through physician/provider referral, and OrthoEast does not discriminate based on income, race, ethnicity, creed, color, gender, age, physical or mental handicap, religion, national origin, sexual orientation, or any other factor that would classify a patient as underserved."

The applicant provides the estimated percentage for each medically underserved group, as shown in the following table.

- The 2022 SMFP identifies the need for one additional fixed MRI scanner in the Pitt/Greene/Hyde/Tyrrell County service area.
- Aging and growth of the population in the service area.
- MRI use rates of the existing MRI scanners in Pitt County.
- Historical utilization of the two existing fixed MRI scanners located at Greenville MRI.

Step 3: Project interim year 2023 volume

The applicant states that following Greenville MRI's expanded hours of services beginning in March 2021, the facility experienced an increase in scans in 2022. In March, June, July, and August, the facility performed more than 900 scans per month. The applicant assumes that 900 scans per month is the maximum sustainable number on the existing scanners and expects it will perform an average of 900 scans per month or a total 10,800 unweighted scans in 2023.

The average monthly scans increased by 4.136%. The applicant projects that the average monthly scans will increase by 4.136% from interim year (2023) through the first full project year (2024). The applicant projects that Greenville MRI will perform 11,248 unweighted scans and 12,948 weighted scans in the first project year. See calculation below. Totals may not foot due to rounding.

Furthermore, maintaining the status quo would not address the growing need for MRI services as the population grows and the limitations of the existing mobile MRI scanner.

Develop the Proposed Diagnostic Center in Another Service Area Location-The applicant considered developing the MRI scanner in another area in Pitt County, or in Greene, Hyde, or Tyrrell Counties. However, the applicant determined that Greenville was the best location because the city is the hub of Pitt County healthcare infrastructure. The applicant states that Greenville has the only acute care hospital and ambulatory surgery center in Pitt County and OrthoEast serves residents of Pitt County and surrounding counties.

Acquire Different MRI Equipment-The applicant is proposing to acquire a 1.5T MRI scanner. The applicant considered acquiring a 3.0T MRI scanner, however, it was determined to be a more costly alternative.

On page 64, the applicant states that its proposal is the most effective alternative because the proposed MRI scanner will increase access to convenient, high quality and cost-effective freestanding MRI services.

The applicant adequately demonstrates that the alternative proposed in this application is the most effective alternative to meet the need based on the following:

• Developing the proposed fixed MRI scanner expands access to a cost-effective alternative for MRI services in the Pitt/Greene/Hyde/Tyrrell County service area.

- Maintaining the status quo would not address the need in the 2022 SMFP for an additional fixed MRI scanner in the service area.
- The applicant provides reasonable information to explain why it believes the proposed project is the most effective alternative.
- The application is conforming to all other statutory and regulatory review criteria.

Status Quo-Doing nothing would not meet the need for one additional fixed MRI scanner in the Pitt/Greene/Hyde/Tyrrell County service area identified in the 2022 SMFP. Furthermore, maintaining the status quo would not address the need to expand MRI capacity at Greenville MRI.

Locate an MRI in Another Service Area County-The applicant considered developing the MRI scanner in another county in the service area. However, this alternative was dismissed because Green, Hyde or Tyrrell do not have the necessary population base to support a fixed MRI scanner.

Build a New Freestanding Diagnostic Center in Pitt County-The applicant dismissed this alternative as not cost-effective. Additionally, building a new freestanding diagnostic center would not allow for the sharing of staff and existing infrastructure.

On page 72, the applicant states that its proposal is the most effective alternative because it would meet the identified need and respond to the projected growth in the community while minimizing capital costs.

The applicant adequately demonstrates that the alternative proposed in this application is the most effective alternative to meet the need based on the following:

- Maintaining the status quo would not address the need in the 2022 SMFP for an additional fixed MRI scanner in the Pitt/Greene/Hyde/Tyrrell County service area.
- The applicant's proposal will expand MRI capacity as a response to the projected growth in the community.
- The applicant provides reasonable information to explain why it believes the proposed project is the most effective alternative.
- The application is conforming to all other statutory and regulatory review criteria.

- The applicant does not anticipate any change to the payor mix because MRI services is the only service component offered by Greenville MRI and will not change upon project completion.

Facilities may also serve residents of counties not included in their service area.

However, four of the fixed MRI scanners in Pitt County are owned and operated by ECU Health Medical Center. Therefore, the application is conforming to this criterion.

COMPARATIVE ANALYSIS

Pursuant to G.S. 131E-183(a)(1) and the 2019 State Medical Facilities Plan, no more than one fixed MRI scanner may be approved for Pitt County in this review. Because the two applications in this review collectively propose to develop two additional fixed MRI scanners to be located in Pitt County, all the applications cannot be approved for the total number of fixed MRI scanners proposed. Therefore, after considering all the information in each application and reviewing each application individually against all applicable statutory and regulatory review criteria, the Project Analyst conducted a comparative analysis of the proposals to decide which proposal should be approved.

Below is a brief description of each project included in this review.

Q-12286-22/ Orthopaedics East and Sports Medicine Center / Acquire no more than one fixed MRI scanner pursuant to the 2022 SMFP need determination

Orthopaedics East and Sports Medicine Center, Inc. and Orthopaedics East Properties, hereinafter referred to as "the applicant" or "OrthoEast", proposes to add one fixed MRI scanner to its existing medical clinic located at 810 WH Smith Boulevard in Pitt County, pursuant to the 2022 SMFP need determination. The applicant is proposing to add an addition to the medical clinic to house the fixed MRI scanner.

Q-12294-22/ Greenville MRI / Acquire no more than one fixed MRI scanner pursuant to the 2022 SMFP need determination

Greenville MRI, LLC, hereinafter referred to as "the applicant or Greenville MRI," proposes to add one fixed MRI scanner pursuant to the 2022 SMFP need determination for a total of three MRI scanners at Greenville MRI, a physician practice located at 2101 W. Arlington Boulevard in Pitt County.

Conformity with Statutory and Regulatory Review Criteria

An application that is not conforming or conforming as conditioned with all applicable statutory and regulatory review criteria cannot be approved.

Both applications are conforming to all applicable statutory and regulatory review criteria. Therefore, regarding this comparative factor, the applications submitted by **OrthoEast** and **Greenville MRI** are equally effective alternatives.

Scope of Services

Generally, the application proposing to provide the broadest scope of services is the more effective alternative with regard to this comparative factor. With regard to scope of services, both applications submitted are in response to the 2022 State Medical Facilities Plan (SMFP) which includes a need determination for one fixed MRI scanner. Both applicants propose to acquire and operate a fixed MRI scanner in a freestanding outpatient setting. Therefore, regarding this comparative factor, the applications submitted by **OrthoEast** and **Greenville MRI** are equally effective alternatives.

Historical Utilization

Generally, regarding this comparative factor, an existing provider with higher historical utilization rates is the more effective alternative based on an assumption that that provider has a greater need for the proposed fixed MRI scanner in order to serve its projected patients. Each of the applicants have a history of providing MRI services in Pitt County. The following table illustrates historical utilization of each applicant as provided in the 2022 SMFP representing FY2020 reported utilization.

OrthoEast has historically provided MRI services on a leased mobile MRI scanner. **Greenville MRI** owns two fixed MRI scanners. The 2022 SMFP identifies **OrthEast's** MRI scanner as a leased mobile MRI scanner that is not included in the Pitt County inventory of fixed MRI scanners. **OrthoEast** does not own a fixed MRI scanner. Therefore, there is no historical fixed MRI utilization to compare. Thus, the result of this analysis is inconclusive.

Geographic Accessibility (Location within the Service Area)

The following table illustrates where in the service area each applicant proposes to develop its proposal.

Each application is proposing to locate the fixed MRI scanner in Greenville. Per Google Maps the locations are less than a mile apart (4 min drive). Thus, with respect to geographic accessibility, **OrthoEast** and **Greenville MRI** are equally effective alternatives.

Access by Service Area Residents

The 2022 SMFP defines the service area for a fixed MRI scanner as "the same as an Acute Care Bed Service area as defined in Chapter 5 and shown in Figure 5.1...Counties with at least one licensed acute care hospital that are not grouped with another county are single county service areas." Therefore, for the purpose of this review, the fixed MRI service area is a multicounty service area that consists of Pitt, Green, Hyde and Tyrrell Counties. Facilities may also serve residents of counties not included in their service area.

The following table illustrates access by service area residents during the third full fiscal year following project completion.

As shown in the table above, Pitt County residents are projected to represent a significant portion of each applicant's total utilization. **OrthoEast** is projected to serve the highest percentage of service area residents. Therefore, regarding projected service to residents of the service area, **OrthoEast's** proposal is the more effective alternative.

Access by Underserved Groups

Underserved groups are defined in G.S. 131E-183(a)(13) as follows:

"Medically underserved groups, such as medically indigent or low income persons, Medicaid and Medicare recipients, racial and ethnic minorities, women, and handicapped persons, which have traditionally experienced difficulties in obtaining equal access to the proposed services, particularly those needs identified in the State Health Plan as deserving of priority."

For access by underserved groups, applications are compared with respect to two underserved groups: Medicare patients and Medicaid patients. Access by each group is treated as a separate factor.

Upon project completion **OrthoEast** will have one fixed MRI scanner and **Greenville MRI** will have a total of three fixed MRI scanners. It is important to note that both applicants include "professional fees" in their pro formas. Each applicant states in their application that "professional fees" are not billed to the patient. Only the technical component is billed to the patient.

Projected Medicare

The following table compares projected access by Medicare patients in the third full fiscal year following project completion of each facility using the following metrics: Medicare dollars and Medicare dollars as a percentage of total gross revenues.

As shown in the table above, **Greenville MRI** projects the largest dollar amount of Medicare revenue, an average of \$1,672,601 per scanner. **OrthoEast** projects the highest Medicare revenue as a percent of gross MRI patient revenue in the third full fiscal year following project completion. Therefore, with respect to Medicare, the applicants are equally effective.

Projected Medicaid

The following table compares projected access by Medicaid patients in the third full fiscal year following project completion of each facility using the following metrics: Medicaid dollars and Medicaid dollars as a percentage of total gross revenues.

As shown in the table above, **Greenville MRI** projects the largest dollar amount of Medicaid revenue, an average of \$440,772 per scanner. **Greenville MRI** projects the highest Medicaid revenue as a percent of gross MRI patient revenue in the third full fiscal year following project completion. Therefore, with respect to Medicaid, **Greenville MRI** is the more effective alternative.

Competition (Access to a New or Alternate Provider)

Generally, the application proposing to increase competition in the service area is the more effective alternative with regard to this comparative factor. The introduction of a new provider in the service area would be the most effective alternative based on the assumption that increased patient choice would encourage all providers in the service area to improve quality or lower costs in order to compete for patients. Although, **OrthoEast** does not own a fixed MRI scanner, both applicants are existing providers of MRI services in the service area of Pitt, Green, Hyde and Tyrrell Counties; therefore, neither of the applicants would qualify as a new or alternative provider in the service area. Thus, with regard to this comparative factor, the proposals are equally effective.

Projected Average Net Revenue per MRI Procedure

Upon project completion **OrthoEast** will have one fixed MRI scanner and **Greenville MRI** will have a total of three fixed MRI scanners. It is important to note that both applicants include "professional fees" in their pro formas. Each applicant states in their application that "professional fees" are not billed to patient. Only the technical component is billed to the patient.

The following table compares the projected average net revenue per weighted MRI procedure (scan) for the third year of operation following project completion for both of the applicants, based on the information provided in the applicants' pro forma financial statements (Section Q). Generally regarding this factor, the application proposing the lowest average net revenue per MRI scan is the more effective alternative since a lower average may indicate a lower cost to the patient or third-party payor.

As shown in the table above, **OrthoEast**, projects the lowest average net revenue per MRI scan in the third full fiscal year following project completion. Therefore, with respect to projected average net revenue per MRI scanner, **OrthoEast** is the more effective alternative.

Projected Average Operating Expense per MRI Procedure

Upon project completion **OrthoEast** will have one fixed MRI scanner and **Greenville MRI** will have a total of three fixed MRI scanners. It is important to note that both applicants include "professional fees" in their pro formas. Each applicant states in their application that "professional fees" are not billed to patient. Only the technical component is billed to the patient.

The following table shows the projected average operating expense per weighted MRI scan in the third full fiscal year following project completion for each facility. Generally, the application projecting the lowest average operating expense per MRI scan is the more effective alternative with regard to this comparative factor to the extent it reflects a more cost-effective service which could also result in lower costs to the patient or third-party payor.

As shown in the table above, **OrthoEast** proposes a lower average operating expense per weighted MRI scan. Therefore, regarding average operating expense per MRI scan, the proposal by **OrthoEast** is the more effective alternative.

SUMMARY

The following table lists the comparative factors and indicates whether each application was more effective, less effective or equally effective for each factor. The comparative factors are listed in the same order they are discussed in the Comparative Analysis which should not be construed to indicate an order of importance.

The **OrthoEast** and **Greenville MRI** applications are conforming to all applicable statutory and regulatory review criteria, and thus both applications are approvable standing alone. However, collectively they propose a total of two fixed MRI scanners in Pitt, Green, Hyde and Tyrrell Counties, but the need determination is for only one fixed MRI scanner in the Pitt, Greene, Hyde and Tyrrell County service area. Therefore, only one fixed MRI scanner can be approved.

As shown in the table above, **OrthoEast** was determined to be a more effective alternative for the following factors:

- Access by Service Area Residents
- Projected Average Net Revenue per MRI procedure
- Projected Average Operating Expense per MRI procedure

As shown in the table above, **Greenville MRI** was determined to be a more effective alternative for the following factors:

• Access by Medicaid Patients

DECISION

Each application is individually conforming to the need determination in the 2022 SMFP for one additional fixed MRI scanner in the Pitt, Greene/Hyde/Tyrrell County fixed MRI scanner service area as well as individually conforming to all review criteria. However, G.S. 131E-183(a)(1) states

that the need determination in the SMFP is the determinative limit on the number of fixed MRI scanners that can be approved by the Healthcare Planning and Certificate of Need Section.

Based upon the independent review of each application and the Comparative Analysis, the following application is conditionally approved as submitted:

• Q-12286-22/ Orthopaedics East and Sports Medicine Center / Acquire no more than one fixed MRI scanner pursuant to the 2022 SMFP need determination.

And the following two applications are denied:

• Q-12294-22/ Greenville MRI / Acquire no more than one fixed MRI scanner pursuant to the 2022 SMFP need determination

The application submitted by **OrthoEast** (**Project ID #Q-12286-22**) is approved subject to the following conditions:

- 1. Orthopaedics East and Sports Medicine Center, Inc. (hereinafter certificate holders) shall materially comply with all representations made in the certificate of need application.
- 2. The certificate holders shall acquire no more than one fixed MRI scanner to be located at Orthopaedics East and Sports Medicine Center.
- **3.** Upon completion of the project, Orthopaedics East and Sports Medicine Center shall be licensed for no more than one fixed MRI scanner.
- 4. Progress Reports:
 - a. Pursuant to G.S. 131E-189(a), the certificate holders shall submit periodic reports on the progress being made to develop the project consistent with the timetable and representations made in the application on the Progress Report form provided by the Healthcare Planning and Certificate of Need Section. The form is available online at: <u>https://info.ncdhhs.gov/dhsr/coneed/progressreport.html</u>.
 - b. The certificate holders shall complete all sections of the Progress Report form.
 - c. The certificate holders shall describe in detail all steps taken to develop the project since the last progress report and should include documentation to substantiate each step taken as available.
 - d. The first progress report shall be due on August 1, 2023.
- 5. The certificate holders shall not acquire as part of this project any equipment that is not included in the project's proposed capital expenditures in Section Q of the application and that would otherwise require a certificate of need.
- 6. shall develop and implement an Energy Efficiency and Sustainability Plan for the project that conforms to or exceeds energy efficiency and water conservation standards incorporated in the latest editions of the North Carolina State Building Codes.

- 7. No later than three months after the last day of each of the first three full fiscal years of operation following initiation of the services authorized by this certificate of need, the certificate holders shall submit, on the form provided by the Healthcare Planning and Certificate of Need Section, an annual report containing the:
 - a. Payor mix for the services authorized in this certificate of need.
 - b. Utilization of the services authorized in this certificate of need.
 - c. Revenues and operating costs for the services authorized in this certificate of need.
 - d. Average gross revenue per unit of service.
 - e. Average net revenue per unit of service.
 - f. Average operating cost per unit of service.
- 8. The certificate holders shall acknowledge acceptance of and agree to comply with all conditions stated herein to the Agency in writing prior to issuance of the certificate of need.
