## Two compete to develop dental surgical facility serving western North Carolina

**RALEIGH** – Two applicants have filed competing Certificate of Need applications with the North Carolina Department of Health and Human Services to develop a dental outpatient surgical facility in Asheville or Greensboro.

The 2016 State Medical Facilities Plan identifies a need for one dental surgical facility to serve Region 4: <u>HSA</u> <u>I and HSA II</u>, which includes Alamance, Alexander, Alleghany, Ashe, Avery, Buncombe, Caldwell, Caswell, Catawba, Cherokee, Clay, Cleveland, Davidson, Davie, Forsyth, Graham, Guilford, Haywood, Henderson, Jackson, Macon, Madison, McDowell, Mitchell, Polk, Randolph, Rockingham, Rutherford, Stokes, Surry, Swain, Transylvania, Watauga Wilkes, Yadkin and Yancey counties. The proposals are as follows:

- Surgical Center for Dental Professionals of Asheville proposes to develop a facility with two operating rooms and two procedure rooms in Asheville. The project is expected to cost \$3.7 million and to be completed in January 2018.
- Valleygate Dental Surgery Center of the Triad proposes to develop a facility with two operating rooms and two procedure rooms in Greensboro. The project is expected to cost \$3.2 million and to be completed in February 2018.

Two public hearings for these projects will be held:

- <u>August 10, 2016</u> at 10 a.m. in the Horseshoe Room, 4<sup>th</sup> floor, Guilford County Administration Building, 301 West Market Street, Greensboro.
- <u>August 12, 2016</u> at 10:30 a.m. in the Lord Auditorium, Buncombe County Pack Memorial Library, 67 Haywood St., Asheville.

Anyone may file written comments concerning the proposals. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5:30 p.m. on August 1st.
