PUBLIC NOTICE

Five Compete for Operating Rooms in Wake County

RALEIGH — Five applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop operating rooms in response to a need determination in the 2019 State Medical Facilities Plan for two operating rooms in Wake County.

- Wake Spine and Surgery Center proposes to develop a new multi-specialty ambulatory surgery center in Raleigh with one operating room and three procedure rooms. The project is expected to cost \$5.7 million and would be completed in October 2021.
- Triangle Orthopaedics Surgery Center proposes to add two operating rooms at its existing ambulatory surgery center in Raleigh by converting two procedure rooms to operating rooms for a total of four operating rooms upon project completion. The project is expected to cost \$5.7 million and would be completed in January 2021.
- Duke University Health System proposes to add two operating rooms to an approved multi-specialty ambulatory surgery center in Cary for a total of three operating rooms and five procedure rooms upon project completion. The project is expected to cost \$6 million and would be completed in July 2022.
- WakeMed Cary Hospital proposes to add one operating room for a total of 11 shared operating rooms and two dedicated C-Section operating rooms at the hospital upon project completion. The project is expected to cost \$2.3 million and would be completed in October 2020.
- Rex Hospital proposes to develop two additional operating rooms at the existing hospital in Raleigh. The project is expected to cost \$789,000 and would be completed in January 2022.

A public hearing for these projects will be held Oct. 17 at 9:00 a.m. in conference room 104, Brown Building, Dorothea Dix Campus, 801 Biggs Drive in Raleigh.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5:30 p.m. on Oct. 1.
