PUBLIC NOTICE

Two Applicants Compete for Fixed MRI Scanner in Cumberland County

FAYETTEVILLE, N.C. — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop one fixed MRI scanner in response to a need determination in the 2024 State Medical Facilities Plan.

The applicants propose two projects:

- Carolina Imaging LLC of Fayetteville, Novant Health Inc. and Novant Health-Norfolk LLC propose to develop one fixed MRI scanner at Carolina Imaging of Fayetteville, an existing diagnostic center. The project is expected to cost \$2.5 million and would be completed in September 2025.
- Cumberland County Hospital System Inc. proposes to develop one fixed MRI scanner in a medical office building to be constructed on the main hospital campus of Cape Fear Valley Medical Center in Fayetteville. The project is expected to cost \$7.2 million and would be completed in January 2026.

A public hearing for these projects will be held April 16 at 11 a.m. in room three of the Cumberland County Historic Courthouse, 130 Gillespie St. in Fayetteville.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on April 1.
