PUBLIC NOTICE

Two Compete for Acute Care Beds in Mecklenburg County

CHARLOTTE — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to acquire up to 89 acute care beds in Mecklenburg County pursuant to the need determination in the 2024 State Medical Facilities Plan.

The applicants propose two projects:

- The Presbyterian Hospital and Novant Health Inc. propose to develop 80 additional acute care beds at Novant Health Presbyterian Medical Center in Charlotte. The project is expected to cost \$104 million and would be completed in January 2030.
- The Charlotte-Mecklenburg Hospital Authority proposes to develop 89 additional acute care beds at Carolinas Medical Center in Charlotte. The project is expected to cost \$120 million and would be completed in April 2027.

A public hearing for these projects will be held Dec.19 at 11 a.m. in Community Room B of the Charlotte Mecklenburg Library – Allegra Westbrooks Regional Branch, 2412 Beatties Ford Road in Charlotte.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Dec 2.
