## **PUBLIC NOTICE**

### **Three Compete for Operating Rooms in Mecklenburg County**

**CHARLOTTE, N.C.** — Three applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop operating rooms in Mecklenburg County in response to a need determination in the 2025 State Medical Facilities Plan for five operating rooms.

The applicants propose:

- The Charlotte-Mecklenburg Hospital Authority proposes to develop five additional operating rooms at Carolinas Medical Center. The project is expected to cost \$21.7 million and would be completed in April 2027.
- Novant Health Matthews Medical Center LLC and Novant Health Inc propose to develop two additional operating rooms at Novant Health Matthews Medical Center. The project is expected to cost \$3.3 million and would be completed in January 2028.
- The Presbyterian Hospital and Novant Health Inc propose to develop two additional operating rooms at Novant Health Presbyterian Medical Center. The project is expected to cost \$45.6 million and would be completed in January 2031.

A public hearing for these projects will be held August 19 at 10 a.m. in Community Room B of the Allegra Westbrooks Regional Library, 2412 Beatties Ford Road in Charlotte.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on July 31.
