PUBLIC NOTICE

Two Applicants Compete for Acute Care Beds in Alamance County

BURLINGTON, N.C. — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop acute care beds in response to a need determination in the 2025 State Medical Facilities Plan for 46 acute care beds in Alamance County.

The applicants propose two projects:

- Alamance Regional Medical Center Inc. proposes to develop a new acute care hospital — Cone Health Mebane Hospital — in Mebane, with 46 acute care beds. The project is expected to cost \$250.3 million and would be completed in April 2029.
- Alamance Health Company LLC, Duke University Health System Inc. and Novant Health Inc. propose to develop a new acute care hospital — Duke Novant Mebane Hospital — in Mebane, with 46 acute care beds. The project is expected to cost \$225 million and would be completed in July 2029.

A public hearing for these projects will be held June 18 at 10:30 a.m. in Meeting Room A of the May Memorial Library, 342 S. Spring St. in Burlington.

Anyone may file written comments concerning these proposals. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on June 2.
