Dear Ms. Hubard:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of **June 30**, **2020**, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(5). Therefore, you may proceed to repair and upgrade the medical center's roof and facility as necessary.

However, you need to contact the Agency's Construction and Acute and Home Care Licensure and Certification Sections to determine if they have any requirements for the proposed repairs.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

RE: Request for Exemption to Certificate of Need Review for Roof Replacement and Upgrade / New Hanover County

Dear Ms. Frisone,

New Hanover Regional Medical Center is planning to replace and upgrade a large portion of the medical center's facilities' roof due to damage incurred by Hurricane Florence. NHRMC has been involved in extensive and lengthy discussions with the Federal Emergency Management Agency for federal disaster relief in completing the roof replacement and repair.

Pursuant to NCGS § 131E-184(a)(4): The Department shall exempt from certificate of need review a new institutional health service if it receives prior written notice from the entity proposing the new institutional health service, which notice includes an explanation of why the new institutional health service is required, for any of the following:

(5) To replace or repair facilities destroyed or damaged by accident or natural disaster.

Based on the project description and pursuant to NCGS § 131E-184(a)(4), the project is exempt from Certificate of Need review. This letter serves as notification of our intent to proceed with this project. We would appreciate your written confirmation that this project is exempt from Certificate of Need review.
