The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of October 1, 2020, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(9). Therefore, you may proceed to offer, develop, or establish the above referenced project without a certificate of need.

The Charlotte-Mecklenburg Hospital Authority is planning to upfit and operate a 30,000 square foot physician office building located at 16633 Birkdale Commons Parkway in Huntersville, NC. A third-party developer is constructing the building and the associated parking. There will be no new institutional health services offered or developed in the new building without first obtaining the necessary certificate of need approval. The estimated cost of the upfit of the medical office building is greater than \$2,000,000.
