Therefore, you may proceed to acquire without a certificate of need the GE CT simulator to replace the existing GE CT simulator (Model # 2377708-43). This determination is based on your representations that the existing unit will be sold or otherwise disposed of and will not be used again in the State without first obtaining a certificate of need if one is required.
