Dear Ms. Gunter:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that the above referenced project is exempt from certificate of need review in accordance with G.S. 131E-184(a)(7). Therefore, you may proceed to acquire without a certificate of need a mobile MRI scanner from MedQuest to temporarily replace the fixed MRI scanner approved pursuant to Project ID# 7324-05 until the fixed MRI scanner is repaired. This determination is based on your representation that once the fixed MRI scanner is repaired the mobile MRI scanner from MedQuest will be immediately removed from the State and will not be used again in the State without first obtaining a certificate of need if one is required.

It should be noted that the Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this office and a separate determination.
