Dear Ms. Heath:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that the project described above is exempt from certificate of need (CON) review in accordance with G.S. 131E-184(a)(8). Therefore, the above referenced business may proceed to acquire the health service facility identified above without first obtaining a CON. The Agency's determination is limited to the question of whether the above referenced business would have to obtain a CON if the current owners of the health service facility do in fact sell it to the business listed above. Note that pursuant to G.S. 131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

If the business listed above does acquire the facility, you should contact the Agency's & *(Section Name)* Section to obtain instructions for changing ownership of the existing facility.

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination regarding whether a certificate of need would be required. Re: Prior Written Notice of Proposed Acquisition

Dear Ms. Mitchell and Mr. Yakaboski:

Our law firm represents Solis North Carolina Diagnostic Imaging & Breast Center Management, Inc. ("Solis") and, on its behalf, we are writing to provide prior written notice of a proposed transaction involving Solis' acquisition of the Carolina Breast Imaging, LLC ("CBI") diagnostic center in Greenville, Pitt County, North Carolina. We are requesting that the Healthcare Planning and Certificate of Need Section (the "Agency") confirm that this transaction is exempt from review pursuant to N.C. Gen. Stat. §131E-184(a)(8).

You may recall that CBI received CON approval for operation of its diagnostic center in 2016 (Project ID # Q-11111-15/FID # 150501). As you know, the CON Law exempts certain otherwise reviewable events from review, including the acquisition of a health service facility, along with the equipment owned by the health service facility at the time of the acquisition. See N.C. Gen. Stat. §131E-184(a)(8). Under N.C. Gen. Stat. §131E-176(9b), a diagnostic center is a "health service facility." Solis will be acquiring the CBI diagnostic center (and its equipment) as an existing "health service facility." The center will remain in operation after the proposed transaction and will continue to operate in accordance with the conditions on its CON.

Based on the foregoing information, we hereby request the Agency confirm that this transaction is exempt from CON review under N.C. Gen. Stat. §131E-184(a)(8). CBI is represented by Ward & Smith, P.A., and counsel for CBI has authorized submission of this letter and will receive a copy as well. Solis and CBI anticipate closing this transaction in July 2023 and will appreciate advance receipt of the Agency's response.
