Dear Mr. Pile:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that the project described above is exempt from certificate of need (CON) review in accordance with G.S. 131E-184(a)(8). Therefore, the above referenced business may proceed to acquire the health service facility identified above without first obtaining a CON. The Agency's determination is limited to the question of whether the above referenced business would have to obtain a CON if the current owners of the health service facility do in fact sell it to the business listed above. Note that pursuant to G.S. 131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

If the business listed above does acquire the facility, you should contact the Agency's Acute and Home Care Licensure and Certification Section to obtain instructions for changing ownership of the existing facility.

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination regarding whether a certificate of need would be required. Dear Ms. Mitchell:

On behalf of ProMedica Skilled Nursing and Rehabilitation and its affiliated hospice entity, In Home Health, LLC d/b/a ProMedica Hospice (Raleigh) as set forth in <u>Attachment A</u> (the "Licensed Hospice Agency"), this correspondence is to notify the North Carolina Division of Health Service Regulation, Healthcare Planning and Certificate of Need Section of its intent to transfer the operations of the Licensed Hospice Agency to Curo Health Services, LLC (the "Proposed Transaction"). The closing of the Proposed Transaction is scheduled to occur on or about June 1, 2023.

Pursuant to the terms of the Proposed Transaction, the Licensed Hospice Agency will continue operating in the same manner. The services offered by the Licensed Hospice Agency will not change and the geographic service area will remain the same. We request the Department's confirmation that this acquisition is non-reviewable because it does not constitute a new hospice office, but rather the acquisition of an existing health service facility as provided in the NC Certificate of Need (CON) law under NC General Statute 131E-184(8).

In addition to this notification, the parties will file the appropriate state licensure application to reflect the change of ownership. Therefore, please confirm that this proposed hospice acquisition is exempt from CON review because it does not constitute a new institutional health service.




