To Whom It May Concern:

We represent the above referenced license holders (the "<u>Licensees</u>"), and this notice is to advise you of an upcoming change of control of the indirect equityholders of the Licensees, several entities up the corporate chain from the Licensees. Copies of the current licenses for the Licensees are attached as <u>Appendix A</u>.

The Licensees are currently indirectly owned, in part, by Envision Healthcare Corporation ("<u>EHC</u>", and together with certain of its affiliates, "<u>Envision</u>"). With the support of Envision's existing equityholders and holders of a substantial majority of Envision's debt, on May 15, 2023, Envision filed for relief under Chapter 11 of the United States Bankruptcy Code, 11 U.S.C. §§ 101 1532, in the Bankruptcy Court for the Southern District of Texas ("<u>Bankruptcy Court</u>"). As part of this bankruptcy, Pacific Investment Management Company, LLC ("<u>PIMCO</u>") and other creditors (collectively, with PIMCO, the "<u>AmSurg 2Ls</u>"), which are the current holders of certain debt of AmSurg, LLC ("<u>AmSurg</u>"), an indirect subsidiary of EHC, will become the indirect owners of AmSurg through Ambulatory TopCo, LLC ("<u>New Owner</u>") (the "<u>Restructuring</u>"). The Restructuring, which remains subject to Bankruptcy Court approval, is expected to be consummated in the fourth quarter of 2023.

The AmSurg 2Ls fully support the Restructuring and have committed funds and agreed to extinguish debt, among other forms of support, in order to best position AmSurg's financial strength for future success. New Owner is expected to be governed by a board of directors, a majority of which is expected to be selected by PIMCO, but the specific post-emergence structures of AmSurg and New Owner have not yet been

determined. However, in all proposed structure options, the change of control will result in an indirect change of ownership of the Licensees. The final structure is expected to be determined on or about the end of October 2023. Structure charts depicting the high-level, indirect ownership structure options of the Licensees are set forth on <u>Appendix B</u>.

The Restructuring is not expected to result in any change to the Licensee's direct owner, federal tax ID number, facilities, management or operations. Services provided by the Licensee will remain the same and continue in the ordinary course.

We believe that the above-mentioned Restructuring is not a "<u>new institutional health service</u>" within the meaning of N.C. Gen. Stat. § 131E-176(16) which would require a certificate of need ("<u>CON</u>") review and approval, because the direct owner of each Licensee will not change. Based on that statutory definition and multiple previous CON Section determinations, a change in ownership or control of an indirect owner of a health service facility is a not new institutional health service which requires a CON.

However, even if the Healthcare Planning and Certification of Need Section (the "<u>CON Section</u>") were to conclude that the Restructuring is a reviewable acquisition of an existing health service facility, then please accept this letter as a notice of exemption pursuant to N.C. Gen. Stat. § 131E-184(a)(8). As you are aware, N.C. Gen. Stat. § 131E-184(a)(8) provides that upon receiving prior written notice from an entity that it will "acquire an existing health service facility, including equipment owned by the health service facility at the time of the acquisition." the CON Section "shall" exempt such project from CON review. Each of the Licensees above is an existing health service facility within the meaning of the CON law. See N.C. Gen. Stat.§ 131E-176(9b).

We request that you provide a letter or e-mail confirming that our interpretation of the CON law and applicable rules is correct and that this proposal is not a new institutional health service, or in the alternative, that the proposed transaction is exempt from CON review pursuant to N.C. Gen. Stat.§ 131E-184(a)(8).






Before Reorganization: Raleigh Endoscopy Center, Raleigh Endoscopy Center-North, Raleigh Endoscopy Center-Cary




After Reorganization Option 1**




After Reorganization Option 2**




Before Reorganization: Guilford Endoscopy Center




After Reorganization Option 1**






Before Reorganization: The Surgical Center of Morehead City
