RE: No Review Determination - UNC Health Endovascular Center

Dear Ms. Bradford:

On behalf of UNC Faculty Physicians ("UNCFP"), this letter serves as notice to the Department of Health and Human Services, Division of Health Service Regulation, Certificate of Need Section ("Agency") that it intends to acquire, renovate, and continue to operate an existing vascular access practice at 2214 Nelson Highway, Chapel Hill, NC, 27517. The practice, previously owned and operated by Carolina Vascular Access Holdings, LLC, will now be owned and operated by UNCFP. The practice, previously operated as Carolina Vascular Access, will now be operated as UNC Health Endovascular Center.

UNCFP intends to renovate the space, which includes the minor upfit of two existing unlicensed procedure rooms. UNCFP does not believe the project constitutes a "new institutional health service" as that term is defined in N.C. Gen. Stat. § 131E-176(16) as procedure rooms are not regulated by Certificate of Need law, and none of the services to be provided in the practice, including in the unlicensed procedure room space, will be a new institutional health service. Further, the capital expenditure to renovate this space will be well under the cost threshold of N. C. Gen. Stat. § 131E-176(16)(b).

For these reasons, UNCFP does not believe that this change in ownership structure and minor renovation of space within an existing physician practice requires a certificate of need. We respectfully request written confirmation from the Agency that the project as described herein does not implicate CON review and does not require a CON.
