Liberty Commons Nursing & Rehabilitation Center of Alamance County LLC d/b/a Liberty Commons Nursing & Rehabilitation Center of Alamance County, is a licensed nursing facility located in Alamance County at 791 Boone Station Drive, Burlington, NC, 27215. The license details are as follows:

Currently, Liberty Commons of Alamance is licensed for a total of 170 beds, comprising 122 skilled nursing facility ("SNF") beds and 48 assisted living ("AL") beds, of which the latter are presently inactive. Our facility intends to optimize the utilization of these beds to better serve our residents and community.

Specifically, we plan to reconfigure rooms 401-412 from private rooms duly certified as Medicare and Medicaid SNF beds to semi-private rooms, also certified as Medicare and Medicaid SNF beds. These 20 beds will be designated for a Special Care Unit. Additionally, rooms 601-610, currently configured as semi-private rooms, will be converted into private rooms, maintaining their certification as Medicare and Medicaid SNF beds. There will be no change in the license capacity of the facility.
