Dear Ms. Hickman:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that the project described above is exempt from certificate of need (CON) review in accordance with G.S. 131E-184(a)(8). Therefore, the above referenced business may proceed to acquire the health service facility identified above without first obtaining a CON. The Agency’s determination is limited to the question of whether the above referenced business would have to obtain a CON if the current owners of the health service facility do in fact sell it to the business listed above. Note that pursuant to G.S. 131E-181(b): “A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need.”

If the business listed above does acquire the facility, you should contact the Agency’s Acute and Home Care Licensure and Certification Section to obtain instructions for changing ownership of the existing facility.

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination regarding whether a certificate of need would be required. If you have any questions concerning this matter, please feel free to contact this office.

Dear Ms. Bradford and Mr. McKillip:

We are writing on behalf of CaroMont Serious Illness Partners, LLC. Pursuant to N.C.G.S. § 131E-184 (a)(8), CaroMont Serious Illness Partners, LLC hereby gives prior written notice of its plan to acquire the existing licensed hospice inpatient, hospice residential and hospice home service facility, which is currently owned and operated by Hospice of Gaston County, Inc. and known as Robin Johnson House-Gaston Hospice (“Robin Johnson House”), including any equipment owned by Robin Johnson House at the time of acquisition. Robin Johnson House is an existing licensed health service facility that is located at 5005 Shepherds Way Drive, Dallas, NC, 28034.

Robin Johnson House is a hospice inpatient and hospice residential facility, as defined in N.C.G.S. § 131E-176 (13b) and (13c), and offers hospice home care services, as defined in N.C.G.S. § 131E-176 (13a). All three of these hospice type entities are included within the definition of health service facility in N.C.G.S. § 131E-176 (9b). Pursuant to N.C.G.S. § 131E-184 (a)(8), the Agency shall exempt from certificate of need review acquisition of an existing health service facility if it receives prior written notice from the entity proposing to acquire the existing health service facility.

CaroMont Serious Illness Partners, LLC anticipates completing the acquisition sometime in 2024. CaroMont Serious Illness Partners, LLC will become the licensed owner and operator of the existing hospice inpatient and residential facility and hospice home care agency and will apply for

a newly issued license at the appropriate time when the transfer will become effective. CaroMont Serious Illness Partners, LLC wishes to acquire Robin Johnson House as part of an effort to include several hospice entities under a new umbrella organization to enhance its services and seek to accomplish efficiencies of operation.
