Good afternoon, Azzie,

Following up on my previous email, we're eager to discuss with you some ideas we have to enhance our treatment offerings and serve current demand for services. Below, I've outlined these ideas for your initial review:

Idea 1: Given that demand/need for treatment services often fluctuates between adolescents and adults, we're interested in having the flexibility to adjust the usage of our 52 licensed beds as

needed. Adolescents and adults wouldn't be mixed within each unit, but rather we'd have the ability to flip the age group of a particular unit as needed to support the necessary demand for services at any given time. Would your department consider allowing this?

Idea 2: We'd flip one of our adolescent residential/inpatient units to general mental health services rather than eating disorder treatment. Would this require special approval from the State under our CON or would we be able to make this switch internally since we are already licensed for the beds we'd utilize?

Idea 3: We'd flip one our current units to a week-long intensive program where parents/children actually stay overnight on unit. Parents and children would share a bedroom, and communal bathrooms/showers would be available on unit as well. We'd add this suite to our existing PHP license and would love your thoughts on the parent/room accommodations.

We'd love to chat with you further about these ideas and what might be needed for further exploration/implementation. Please let me know a convenient time for you, and I can arrange a call to discuss in more detail.
