Dear Mr. Thomas:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that the project described above is exempt from certificate of need (CON) review in accordance with G.S. 131E-184(a)(8). Therefore, the above referenced business may proceed to acquire the health service facility identified above without first obtaining a CON. The new operator of the facility will be A Plus Home Care Agency, LLC. The Agency's determination is limited to the question of whether the above referenced business would have to obtain a CON if the current owners of the health service facility do in fact sell it to the business listed above. Note that pursuant to G.S. 131E-181(b): *"A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."*

If the business listed above does acquire the facility, you should contact the Agency's Adult Care Licensure Section to obtain instructions for changing ownership of the existing facility.

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination regarding whether a certificate of need would be required. 
Our office is counsel for A Plus Home Care Agency, LLC (“A Plus”). A Plus has contracted to purchase the Fremont Rest Center facility (“Facility”) from the current owner and will become responsible for the day to day operations of the facility.

This letter constitutes prior written notice by A Plus of its intent to acquire the real estate of the Fremont Rest Center facility and become the property owner.

Pursuant to N.C. Gen. Stat. § 131E-184(a)(8) the acquisition of an existing health service facility exempts the new institutional health service from certificate of need review.

The acquisition of the Facility is scheduled to take place by April 18, 2025. If for any reason this transaction is delayed or does not occur, our office will notify you of any changes at that time.
