	This REQUIREMENT is not met as evidenced by: Based on resident interview, staff interview, and record review the facility failed to notify a resident in advance of receiving a new roommate for 1 of 1 residents (#43) reviewed for receiving a new roommate. The findings included: Resident #43 was admitted to the facility on 3/31/15 with diagnoses including cerebral palsy. The most recent Minimum Data Set (MDS) indicated the resident was cognitively intact and had no barriers with communication. During an interview on 10/27/15 at 10:25 AM the resident stated that no one told her she would be receiving a new roommate. She stated she had not had a roommate since she was originally admitted to the facility, and she did not know she was getting a roommate until staff began preparing the room for another resident. She stated she was not happy about this. Interview on 10/28/15 at 3:00 PM with the Director of Social Services (DSS) revealed she did not recall providing notice to Resident #43 that she would be receiving a new roommate. The DSS further stated that the facility tried to notify all residents of changes in room or roommate, but that sometimes this task might "fall through the cracks." She then stated she thought it was possible the Assistant Social Worker may have notified the resident, but she was not sure. She further revealed that there was no documentation in Resident #43 "s medical record to indicate if notice was provided by any staff regarding the new roommate. Record review on 10/28/15 at 3:10 PM revealed no documentation in Resident #43 "s medical record to indicate if notice was provided by any staff regarding the new roommate. Interview on 10/28/15 at 3:40 PM with the facility Administrator revealed that it was her expectation that all residents receive notice from staff prior to receiving a new roommate or room change.
