We were previously managed by Wake Forest University Baptist Medical Center and as of May 1 owned by HMC/CAH, Consolidated, Inc. HMC is a health care system specializing in the ownership of Critical Access Hospitals. My hospital has an average daily census of 10, 8 of which are swing bed patients. Like many Critical Access Hospitals, swing bed patients allow us to succeed and thrive financially. Based on market data we will be submitting a CON to replace this aging facility that was originally built in 1952 with an endowment and Hill Burton Funds. I support the notion that the CON methodology for bed need as it relates to Critical Access Hospitals take in to consideration swing beds. This will allow us to continue our mission of serving our community and recapture market share that has left the community due to an aging facility. Elderly patients have a difficult time navigating the tertiary care hospitals in Winston Salem and are better served at their local community hospital. Consideration of our total average daily census, including swing beds, is a superior method to allocate bed need than to consider only an acute care census.
