**STATEMENT OF REQUESTED ADJUSTMENT**

Raleigh Radiology, LLC (“Raleigh Radiology”) requests the following change to the *2020 State Medical Facilities Plan (SMFP)* to address a special need for Magnetic Resonance Equipment (“MRI”) in Wake County by modifying Table 17E-3 as follows:

**Table 17E-3: Fixed MRI Scanner Need Determination**  
(Scheduled for Certificate of Need Review Commencing in 2020)

It is determined that the service areas listed in the table below needs an additional fixed MRI scanner.

\*\*\*    Provided that in response to this need, a scanner should be located in a freestanding multimodality imaging center that has an ACR accredited freestanding fixed MRI in Wake County; a sustained four-year history of exceeding the Wake County MRI Planning Threshold; at least four years of CPT evidence of sustained performance of all types of MRI scans for patients referred by primary care, internal medicine, and other specialties; a history of low charges; and, the applicant must not own a fixed MRI.

## REASONS FOR THE PROPOSED ADJUSTMENT

Wake County is falling behind other North Carolina population centers in access to MRI service and a key Wake County outpatient MRI provider faces insurmountable obstacles to sustaining value. The busiest freestanding imaging center MRI provider in Wake County is Raleigh Radiology. However, it is at the mercy of a third-party vendor that owns the MRI and controls the staff,

Although the SMFP permits a provider with a busy mobile MRI to convert it to a fixed, the SMFP must first show a need in the county, and the provider must compete with other applicants.

### **Statement of Adverse Effects on Providers and Consumers if the Adjustment is Not Made**

#### **Wake County MRI Access Lowest among Major Population Centers**

According to Chapter 17 of the *Draft 2020 State Medical Facilities Plan* ("SMFP"), Wake County has less access to MRI facilities than other North Carolina major metropolitan counties, even after considering placeholders. Mecklenburg County, with a similar population and demographics, has almost 20% more fixed equivalent magnets per capita; Durham and Forsyth have more than twice as many. The State Demographer predicts that population in Wake County will grow faster than in any of these other counties through 2024. Table 1 shows the fixed equivalent magnets per capita in 2019 and 2024, with the projected population increase. Column h compares the county by dividing each county's fixed equivalents (Column b) by the Wake County value in the same column.



Wake County is unique, having the lowest per capita supply of MRI units in the state. **Wake has half the access of Durham County.**

If the 2019 Wake County need is awarded to a freestanding center, the ratios will remain unbalanced. Mecklenburg would still have 14 percent more fixed equivalent MRIs per capita than Wake.

Because of its limited supply of MRI relative to the population, Wake County is more dependent on the mobile vendors than any other large urban county in the state.

### **Wake County Dependence on Alliance Mobile MRI**

To compensate for its MRI shortfall, Wake has become dependent on “mobile units,” most of which are owned by Alliance Healthcare Services. Compared to other urban counties Wake County has the lion’s share of Alliance-owned and operated MRIs. Wake has 8 times as many Alliance-owned fixed equivalent magnets as Mecklenburg.

In fact, Alliance owns 30 percent of the fixed equivalent MRIs in freestanding centers in Wake County. Alliance owns almost 44 percent fixed magnets operating in freestanding centers in Wake County.<sup>1</sup> Though a reasonable arrangement for start-ups, it is not a good permanent solution. The magnets are subject to Alliance terms that make it almost impossible to sustain a patient-centered price and services model. One provider, Raleigh Radiology, has been particularly hamstrung by the arrangement.

## Grandfathered “Mobile” Fixed Unit Impact

Alliance has an unusual Certificate of Need (“CON”) arrangement. It owns rights to operate 26 “mobile” MRI scanners anywhere in North Carolina. By virtue of a 1993 loophole, the state permits Alliance to operate these mobile units as “fixed” units. They do not move. They are located inside buildings. Alliance must provide the equipment and the staff. With no other options, Raleigh Radiology accepted this option. Today, the same Alliance-owned MRI has been in the building for 11 years at Raleigh Radiology Blue Ridge.

DHSR permits this arrangement because Alliance Healthcare Services obtained rights to the mobile MRI equipment before North Carolina statute required a CON to acquire an MRI. In fact, Alliance Healthcare Services has rights to 34 mobile North Carolina MRI units, 26 of which have grandfathered status. When a provider has need, Alliance can bring a mobile from its Grandfathered stable. This increases the fixed MRI unit count in the county and slows the rate at which the SMFP methodology shows a need.

## Unintended Consequence

Raleigh Radiology does not own an MRI scanner.<sup>2</sup> To many patients and payers, Raleigh Radiology is the provider of choice. Raleigh Radiology pays Alliance over \$1M annually for the MRI service at Raleigh Radiology Blue Ridge. This is significantly more than the cost Raleigh Radiology would incur if it financed, acquired, and staffed its own unit. In fact, Raleigh Radiology costs would drop by at least \$350,000 each year if the practice owned the scanner directly, a savings of \$80 per scan based on current volume. Raleigh Radiology could pass this per scan savings to uninsured, further reducing their cost.

How did we get here? The Alliance arrangement was the only MRI option available to Raleigh Radiology in 2005. The *2005 SMFP* showed a need for one MRI scanner in Wake County, but Raleigh Radiology did not have the history to compete for it. The only way for this large, value conscious radiology practice to offer MRI services was the Alliance mobile contract. In 2005, Alliance Healthcare Services and Kings Medical were the only contract providers not owned by a health care system that could offer full time MRI service at a fixed location. Kings has since sold its units to hospitals.

Having this monopoly, Alliance can keep increasing the lease price. Raleigh Radiology asked Alliance to consider selling the MRI unit, but it declined. In any event, the limited number of MRI CON opportunities in Wake County keeps the Alliance unit value so high, that the combined price to acquire both the CON rights and new MRI equipment make purchase financially infeasible. The contract is up for renewal again at the end of 2020. At that time, should Raleigh Radiology wish to increase hours of service in order to improve patient access, it is likely Alliance will increase the contract cost even more. This arrangement runs counter to the SMFP goal of reducing the cost of service. Raleigh Radiology is the only provider in Wake County with an Alliance fixed that does not also own at least one MRI.

Why Raleigh Radiology Blue Ridge? The 11-year old Alliance equipment has fully depreciated, does not have the latest technology improvements, and has begun to break down. It quenched (shut down absolutely) two times within the last month. However, Alliance chose to repair, rather than replace the equipment.

Value is critical. This lease arrangement is operationally cumbersome and difficult to cost justify. The cost for lease renewals increases annually by the CPI (historically 1.5 – 2%); the equipment continues to age; and Raleigh Radiology has no control over staffing.

People who staff the MRI work for Alliance Healthcare Services, which means they rely on Alliance for training and work the hours that Alliance sets. This produces:

- Unnecessary overtime expense and inflexible staff schedules; and,
- Less flexible patient schedules and longer than necessary patient waits for scans.

### **Impact on Wake County Consumers**

Wake County's uninsured and underinsured persons need a Raleigh Radiology owned MRI. Raleigh Radiology is the competitive pace setter, offering the lowest comprehensive MRI prices and extended hour schedules. Only single specialty, closed panel vendors offer lower prices. Raleigh Radiology does not own an MRI and thus is entirely at the mercy of an outside vendor. When a stop action event occurs, as it did in June 2019, Raleigh Radiology has no back up, except to rely on Alliance to find a mobile. Because Alliance mobiles are booked, its inventory for last minute mobiles is limited to leftovers. Both of Raleigh Radiology in house Alliance MRIs are full. Adding overtime adds to the cost. The Alliance lease agreements provide less flexibility with operating hours than an owned scanner. When staff work for the provider, it can run the scanner as often as needed.

The Proposed 2020 MRI Policy and Methodology adversely affect both Raleigh Radiology and Wake County. As written, the Proposed 2020 SMFP will sustain Wake County access barriers and tie Raleigh Radiology to a costly MRI lease that runs counter to value and customer service.. Following the June 2019 total shutdown of the MRI equipment, Alliance eventually provided a mobile unit to cover the period of repairs – but that unit had its own problems.

During the shutdown, Raleigh Radiology had to recall patients to correct machine image problems and arranged to send others elsewhere at the last minute. In short, Raleigh Radiology is the only freestanding imaging center in the state that is incapable of managing the quality of its entire MRI service line.

Without the proposed adjusted need determination, Raleigh Radiology's value service is at risk. Alliance can keep raising prices and decide when to upgrade equipment. Without this proposed special need change in the 2020 SMFP fixed MRI need in Wake County, the service will stay at risk.

In summary, failing to approve this petition would have unacceptable adverse effects. It would:

- Contradict the SMFP's "Basic Principles" of encouraging safety and quality, access, and value;
- Leave Wake County with the lowest access to MRI among major metro areas in the state;
- Reduce competition;
- Restrict mechanisms for reducing MRI cost and upgrading equipment;
- Give the busiest freestanding imaging center in Wake County no control over MRI equipment or staff, and limited control over hours of service; and,
- Restrict hours of service for a unit the SMFP identifies as "fixed."

### *Accessibility to Traditionally Underserved Groups*

The CON statute and the SMFP Basic Principles favor service to traditionally underserved groups. Raleigh Radiology is a **safety net provider**. It accepts payment from Medicare, Medicaid, Veterans Administration, and State Employee Health Plan. Furthermore, it provides deep discounts to uninsured patients that could be deeper if it could eliminate the Alliance overhead cost. Insured patients with high deductibles and coinsurance already benefit from lower out of pocket costs with Raleigh Radiology because its contracts with the insurers are more competitive than other local providers. Major payers in the State are seeking to reduce further MRI payments. Raleigh Radiology will be better positioned to weather these reimbursement decreases and sustain this high-value MRI service if it owned its own scanner.

### *Declining Payments, Rising Costs*

Reimbursement for radiology procedures has been declining for years. Between 2018 and 2019, Medicare reimbursement for certain high-volume MRI procedures decreased by as much as 20 percent, and other payers followed suit.

During that same time, Raleigh Radiology's payment to Alliance increased by a two percent annual CPI factor, plus extra charges associated with schedule adjustments that Raleigh Radiology made to accommodate the increasing numbers of patients who were requesting services. While increased staffing would reasonably add some incremental cost, because the staff are contracted, each increased staff hour includes additional Alliance overhead and profit cost. Alliance charges an overtime premium, after the normal business day. If Raleigh Radiology controlled the staffing, it could organize shift coverage at less cost.

Raleigh Radiology schedule access is good today. The practice schedules 82 hours a week, well above what has been the 66-hour CON requirement for fixed MRI. Increased lease costs will challenge the schedule.

### *Four-Year History of Scans Exceeding MRI Thresholds*

Raleigh Radiology Blue Ridge MRI history speaks for itself. In the last 12 months, Wake County residents accounted for approximately 80 percent of its MRI scans. As illustrated in the following tables, Raleigh Radiology is the county's low-cost provider and it has weathered the obstacles to increase MRI service to Wake County year after year. Raleigh Radiology Blue Ridge MRI exceeded the SMFP threshold for a fixed scanner in each of the last four years. Table 3 shows the annual adjusted MRI scans for the last four full reported fiscal years.



### Value Provider

Advanced capabilities among Raleigh Radiology professionals, sub-specialty reads, the radiologists' involvement in continuous training, and commitment to American College of Radiology accreditation assure high quality services. The combination of low cost to patients and commitment to quality makes Raleigh Radiology the highest-value multimodality-radiology provider in Wake County. The practice saves patients hundreds of dollars for the same scan.

Data from the Blue Cross, online Cost Evaluator tool for the same procedure, confirm that Raleigh Radiology is the best value. Raleigh Radiology MRI scans cost less than at least five other Wake County providers. For example, consider an MRI spine w/o contrast charges for all providers. Provider A was \$819, Provider B, \$825; Provider C, \$898; Provider D, \$1,011; Provider E \$1,318 and Raleigh Radiology was \$814. The most expensive freestanding center charges 62 percent more. These comparisons involve only freestanding radiology practices. Hospital-based providers have much higher costs. See Attachment A for supporting data.

This chart compares Global payments—the payments include both the MRI scan and the physician fee.

Patient concerns motivate Raleigh Radiology decisions. Recognizing the increasing number of patients who have high deductible and co-payments, Raleigh Radiology developed payment plans and discounts to make it possible for people to get the diagnostic information they need for treatment planning at affordable rates.

## **Statement of Alternatives Considered and Found Not Feasible**

Raleigh Radiology considered and rejected these alternatives:

- Maintain the Status Quo;
- Risk an application for the Wake County MRI Need in the 2019 SMFP;
- Ask for a Larger Need Determination;
- Cancel or Reduce the Alliance contract; or
- Wait for a change in the SMFP MRI Methodology

### **Maintain the Status Quo**

Raleigh Radiology is operating under the status quo at two busy sites and finds it cost prohibitive and less than optimal for patient care. The present arrangement limits service. Alliance owns the equipment, controls the staff, selects the upgrades, and controls the image production. Raleigh Radiology must work through this third party to set technical quality and performance standards. Raleigh Radiology cannot perform routine equipment maintenance, plan to replace the machine, or control the repair schedule when the equipment fails.

Already high leasing and service fees increase annually. All of this amounts to a less than optimal experience for patients and should not be occurring in Wake County, one of the state's showcase technology centers, where highly trained physicians provide tertiary referral services. Raleigh Radiology's full schedules and the Proposed 2020 SMFP structure could have the net effect of driving patients out of the county for MRI services. Without change, a value provider like Raleigh Radiology will face increasing lease costs until the lease is unsustainable. A provider not so constrained, would purchase an MRI.

Raleigh Radiology is the only freestanding radiology practice in the state that cannot control the quality of any MRI unit located inside its buildings. MRI is a standard imaging modality. The status quo is not a reasonable alternative.

### **Pursue 2019 Need**

Raleigh Radiology tested this alternative path at great cost. The CON review criteria favor hospitals and new providers over an existing provider that offers low charges to working and insured individuals, but has lower percentages of Medicare and Medicaid patients. In 2016, Raleigh Radiology's CON application offered the lowest net revenue and the lowest cost, but the state rejected the application in favor of a new applicant whose parent company has many MRI's. The chosen applicant proposed a new location. Raleigh Radiology contested this decision at great cost. The issue remains unresolved. Counting on this alternative in a competitive environment would not be prudent. It would not guarantee award to an existing provider seeking replacement of an MRI. It will not address the imbalance in Wake County. It will not assure focus on Raleigh Radiology's particular dilemma.

## **Ask for a Larger Need Determination**

If the sole criteria for need were performance of its two scanners, Raleigh Radiology would ask for two additional MRI scanners in Wake County, one each for Blue Ridge and Cary, which has a similar Alliance lease. However, Raleigh Radiology fears that the SHCC would view such a request as too ambitious. Rather than risk rejection, Raleigh Radiology is making a more conservative request, one special need MRI with appropriate conditions to provide relief for the older scanner at Blue Ridge.

At current MRI growth rates, and because of the structure of the methodology, it will be years before the SMFP provides another fixed MRI need in Wake County.

## **Wait for a Change in the Methodology**

Methodology changes involve months of debate and staff analyses of statewide impact. It would be inequitable to force Wake County to live with restricted access while this occurs.

## **Pursue a Special Need Determination**

Just adding one more scanner to Wake County will not solve the problem. As history demonstrates, without specific limits on the fixed scanner need, the CON review process does not favor MRI replacement, even when the provider is a demonstrated leader in providing value and low cost for the working population. A large portion of the working population has insurance, which in the past meant well served. However, today's outpatient insurance structure means that the people most likely to need an MRI struggle with high deductibles and copayments.

In 2015, the SHCC approved a Raleigh Radiology petition to remedy the situation with a need for one more fixed MRI in Wake County, but Raleigh Radiology was an unsuccessful applicant. Traditional comparative review for new fixed scanners does not accommodate this situation. As such, a special need determination for a replacement scanner is appropriate. This solution would also provide relief for Wake County, which is currently underserved by MRI units.

**To address the inequities, Wake County needs another fixed scanner specifically targeted to replace equipment at a provider with a history of low charges that does not have ownership of a fixed MRI, provides a full suite of MRI services, and has a demonstrated history of exceeding the Wake County MRI threshold, as reported in the SMFPs.**

This is not an unusual request. SMFPs have many precedents for including a special need targeted to providers who have demonstrated capacity on mobile units. The methodology for cardiac catheterization lets an applicant apply to replace a mobile with a shared fixed unit if the existing service demonstrates a history of only 16 percent of the state determined capacity of a fixed unit (240/1,500). The 2016 SMFP identified a special need uniquely targeted to a replacement MRI for a community hospital with a similar Alliance arrangement. This prompted additional debate and Policy TE-3 was a follow up to that 2016 special need. TE-3 allows hospitals with an emergency room but no owned MRI, to apply for one fixed MRI.

## EVIDENCE OF NON-DUPLICATION OF SERVICES

A special need in Wake County would involve no duplication of MRI services in Wake County. Wake County is underserved, as demonstrated on pages 2 and 3 of this petition.

## EVIDENCE OF CONSISTENCY WITH NORTH CAROLINA STATE MEDICAL FACILITIES PLAN BASIC PRINCIPLES

### Safety and Quality

This basic principle notes:

*"...priority should be given to safety, followed by clinical outcomes, followed by satisfaction."*

*"...As experience with the application of quality and safety metrics grows, the SHCC should regularly review policies and need methodologies and revise them as needed to address any persistent and significant deficiencies in safety and quality in a particular service area."*

Providing an option for an established, ACR accredited provider to reduce the MRI deficit in Wake County would meet the safety and quality principle.

### Access

This basic principle notes:

*"...The first priority is to ameliorate economic barriers and the second priority is to mitigate time and distance barriers."*

*"...The SHCC planning process will promote access to an appropriate spectrum of health services at a local level, whenever feasible under prevailing quality and value standards."*

MRI is a conventional diagnostic tool. With one more fixed MRI, Wake County would still not reach parity with Mecklenburg, whose population is about the same.

The proposed restrictions would assure that a historically underserved group -- outpatients with high deductible and copay insurance -- has affordable MRI access.

### Value

This basic principle notes:

*"The SHCC defines health care value as the maximum health care benefit per dollar expended."*

*"...Cost per unit of service is an appropriate metric..."*

*"...At the same time overutilization of more costly and/or highly specialized low-volume services without evidence-based medical indication may contribute to escalating health costs without commensurate population-based health benefit."*

The proposed changes will enable replacement of a more costly service without placing unnecessary pressure on a new health care provider to increase utilization. Restricting to an applicant with a sustained history of increasing volume will assure the highest impact on sustained value. Restricting the award to an applicant that does not own an MRI would assure sustained competition in the county.

## **CONCLUSION**

Raleigh Radiology is asking for a special need determination for one fixed MRI scanner in Wake County with restrictions on the applicant.

- An existing, freestanding imaging center, with an ACR-accredited freestanding fixed MRI, and a four-year continuous record of exceeding the Wake MRI threshold as represented in Table 17E;
- No ownership of an MRI, itself or through a commonly owned entity; and
- A demonstrated history of low patient charges and comprehensive scope of MRI scans.

There is precedent and the request is in keeping with the governing principles in the *State Medical Facilities Plan* of maximizing quality, access, and value.
