I hope this letter finds you well. As requested, we are providing insight into our community demographics, specific to Mecklenburg County, with a focus on Charlotte's Crescent zip codes. I am pleased to share with you our most recent demographic data. It is important to note that we are one of eleven providers that serve patients in Mecklenburg County and our admissions today represent a little over half the total annual admissions, therefore this data is only representative of the impact of VIA Health Partners in Mecklenburg County.

The data presented reflects a comprehensive analysis of the racial composition of hospice admissions from January 2021 to June 2024. This information is crucial for understanding the diversity within our community and guiding our current and future initiatives aimed at fostering inclusivity, equity and access to Palliative and Hospice Care.

Here is a summary of the key findings:

2. Trends and Comparisons:

- o African American Admissions are increasing
- o The "Unknown" category is significant and tends to be a minority demographic.
- In 2023, the first full post Covid year, admissions increased significantly, and VIA Health Partners expects to eclipse those admissions in 2024 projecting 526 admission in the Crescent.
