However, only one staff need be present during sleeping hours if specified by the emergency back-up procedures determined by the governing body.</p> <p>(d) In facilities which serve clients whose primary diagnosis is substance abuse dependency:</p> <p>(1) at least one staff member who is on duty shall be trained in alcohol and other drug withdrawal symptoms and symptoms of secondary complications to alcohol and other drug addiction; and</p> <p>(2) the services of a certified substance abuse counselor shall be available on an as-needed basis for each client.</p> <p>This Rule is not met as evidenced by: Based on observation and interviews the facility failed to ensure that one staff was present at all times when any adult client is on the premises. The findings are:</p> <p>Observation at 9:00AM on 8/27/18 when entering the facility for the annual survey revealed: -The facility had three current clients and a capacity of 6. -The facility was located next door to a sister facility. V 290	<p>Continued From page 2</p> <p>facility for "Meaningful Days". This was similar to one on one services in which she would take those clients into the community for different activities. She provided this service 7 days a week for two hours per day. When she worked with the clients from the sister facility, the staff member of the sister facility and those clients would be on site at her facility to provide supervision.</p> <p>Interview on 8/27/18 with the House Manager revealed:</p> <ul style="list-style-type: none"> <li>-The two facilities side by side would assist each other with supervision.</li> <li>-There were occasions when one staff would take two clients out and take the client who didn't want to go to the house next door. If the client refused to go then the staff and clients from next door would come to the facility and stay.</li> </ul> <p>Interview on 8/27/18 with the Operations Manager revealed:</p> <ul style="list-style-type: none"> <li>-The "Meaningful Day" service had to be provided by a staff member that did not operate the facility where the client lived according to the LME-MCO.</li> <li>-He felt that the benefit of having the facilities next door to each other was that they could interchange staff when necessary.</li> <li>-He acknowledged this arrangement was beneficial to staff and did not feel that any clients were opposed to going from house to house when needed.</li> </ul>	V 290
