The finding is:</p> <p>Observations conducted on 5/6/19 at 5:25 PM revealed all 5 clients residing in the home were seated at the dining table, each in their respective wheelchairs. On-going observations at 5:30 PM revealed clients #2 and #4 began feeding themselves the supper meal while client #3 was fed the supper meal by staff C and client #5 was fed by staff A. Continued observations during the supper meal revealed while clients #2, #3, #4 and #5 were eating their supper meal, client #1 was seated at the dining table, without her meal and unoccupied until all of the other clients had completed their meal and left the dining area. Further observations at 6:32 PM revealed staff A heated client #1's supper meal in the microwave and began feeding client #1.</p> <p>Interviews conducted on 5/6/19 at 6:30 PM with staff A and staff C revealed client #1 usually receives her meal after the other clients have eaten due to having 2 staff scheduled on second shift and 3 clients needing to be fed by staff. Continued review of the 4/19/19 POC for client #2 revealed no educational/pre-vocational/vocational objectives were included. Further review of the POC for client #2 revealed a Functional Skills Assessment dated 4/20/18 which documented client #2's skills in the area of education/pre-vocation/vocation include partial independence in performing the following skills, with verbal and/or physical prompts: attend to task, complete task, attend a group for at least 30 minutes, responds appropriately to instruction/verbal prompts, produces at least some acceptable work, follows one- and two-step directions and is highly motivated to work and produce.</p> <p>Interview conducted on 5/7/19 with the qualified intellectual disabilities professional (QIDP) verified client #2 did not have any current skill acquisition objectives in the area of education/pre-vocation.</p> <p>B. The POC failed to include objectives in the area of self-care and education/pre-vocation/vocation for client #4.</p> <p>Observations conducted in the group home during the recertification survey conducted on 5/6/19 and 5/7/19, revealed client #4 to be cooperative with verbal prompting. Review of the record for client #4 on 5/6/19 and 5/7/19 revealed a POC dated 1/11/19. Review of the POC revealed formal objectives to use signing abilities daily and to tolerate her daily routine to reduce target behaviors. Further review revealed additional needs identified in her POC as "NEEDS PRIORITIZED..." which includes increase communication skills, maintain/improve social skill abilities, and maintain gross motor functional abilities. Subsequent review of client #4's POC revealed a Functional Skills Assessment (CFA) dated 1/11/19. Review of the CFA indicated the following "Training Potential" needs: "Turn water on/off" and "Combs, brushes hair" and "Communicates socially-uses please, thank you, hi etc." and "Follows three step directives." Subsequent review of client #4's CFA in the area of vocational needs revealed partial independence and verbal and physical prompting needs for tasks such as "Attends tasks for at least 10 minutes" and "Attends learned task to its completion" and "Grasps concept of tool usage." Interview conducted on 5/7/19 with the home manager and the qualified intellectual disabilities professional (QIDP) verified client #4 could use more formal programs.	W 227

Observations conducted on 5/7/19 at 7:40 AM revealed client #2 was sitting at the dining table where he was assisted by staff to serve himself his breakfast meal consisting of a sausage biscuit pre-cut by staff into bite-sized pieces. Client #2's place setting for the breakfast meal was observed to include a high-sided scoop dish, regular cups and a spoon.</p> <p>Review of the record for client #2, conducted on 5/6/19 and 5/7/19, revealed a physician's order dated 5/2/19 prescribing a bite-sized diet consistency for client #2. Continued review of the record for client #2 revealed a plan of care (POC) dated 4/19/19 which included a Functional Skills Assessment (CFA) dated 4/20/18.
