V 118	<p><b>27G .0209 (C) Medication Requirements</b></p> <p><b>10A NCAC 27G .0209 MEDICATION REQUIREMENTS</b></p> <p>(c) Medication administration:</p> <p>(1) Prescription or non-prescription drugs shall only be administered to a client on the written order of a person authorized by law to prescribe drugs.</p> <p>(2) Medications shall be self-administered by clients only when authorized in writing by the client's physician.</p> <p>(3) Medications, including injections, shall be administered only by licensed persons, or by unlicensed persons trained by a registered nurse, pharmacist or other legally qualified person and privileged to prepare and administer medications.</p> <p>(4) A Medication Administration Record (MAR) of all drugs administered to each client must be kept current. Medications administered shall be recorded immediately after administration. The findings are:  Review on 9/14/21 of client #1's record revealed: - 26 year old female admitted 4/22/19. - Diagnoses included Schizoaffective Disorder, bipolar type; Intellectual/Developmental Disability, mild; Seizure Disorder; Morbid Obesity and Borderline Diabetes. - Physician's order signed 10/21/20 for Nizoral Shampoo 2% (antifungal used to treat dandruff) to scalp twice weekly, leave on for five minutes then rinse.  Review on 9/14/21 of client #1's MARS for July - September 2021 revealed: - Transcription for Nizoral Shampoo 2% to scalp twice weekly. - Staff initials that Nizoral Shampoo was used only once weekly 8/15/21 - 9/11/21. - No documented explanation for the omissions.  Observation at 2:50 pm on 9/14/21 of client #1's medications on hand revealed: - Nizoral Shampoo 2% "Use as a shampoo to scalp twice a week, leave on for 5 minutes then rinse" dispensed by the pharmacy 8/01/21.
