The findings are:</p> <p>Review on 1/26/22 of facility records revealed there was no CLIA certificate.</p> <p>Review on 2/1/22 of client #9's record revealed: -34 year old male admitted 1/10/22. -Diagnoses included Stimulant Use Disorder - Cocaine (Severe), and Depression. -UDS report signed/dated 1/10/22 by client #9 and Staff #1. -UDS results were negative for marijuana, methamphetamine, amphetamine, benzodiazepines, cocaine, opiates/morphine, oxycodone, phenylcyclohexyl piperidine (PCP).</p> <p>Interview on 1/26/22 the North Carolina Division of Health Service Regulation CLIA Section staff stated the facility did not have a CLIA certificate.</p> <p>Interview on 2/1/22 the House Manager (HM) #2 stated: -He was the 2nd shift HM. -He had performed client UDS. -Typically a UDS was done on admission and any time a client had been reported for drinking alcohol.</p>	V 105
