The findings are:</p> <p>Observation on 4-19-22 at approximately 1:00 pm revealed: -Staff #1 opening the facility door to let surveyor in. -Staff #2 pulling into the driveway with fast food in his hands.</p> <p>Interview on 4-19-22 with Client #1 revealed: -There were usually two staff working. -It was "not often" that one staff was there by themselves.</p>	V 296

V 296	<p>Continued From page 2</p> <p>Interview on 4-19-22 with Client #2 revealed: -Staff will run down to the nearby gas station to get a drink. -They are only gone for a few minutes. -It does not happened a lot.</p> <p>Interview on 4-19-22 with Staff #1 revealed: -It was her fourth day at the facility. -it was two staff working, but Staff #2 had gone for a few minutes. -"We are not supposed to leave." -This was the first time Staff #2 had left her by herself.</p> <p>Interview on 4-19-22 with Staff #2 revealed: -He had left to get lunch for staff. -He left one staff by themselves for a "couple of minutes." -"As far as lunch, I didn't see a problem, but as to school, we all go together, or whenever one kid needs to go somewhere."</p> <p>Interview on 4-19-20 with the Associate Professional revealed: -They were aware that Staff #2 had left the facility and would be addressing that issue with him. -He might have been trying to take advantage of the fact that Staff #1 was new. -They would make sure all staff knew that they should not leave during their shift.</p>	V 296
