## 10A NCAC 14D .0203 DESIGN AND CONSTRUCTION

- 4 (a) Any adult day care program intending to provide overnight respite services for the first time shall meet the
- 5 applicable requirements of the North Carolina State Building Code. All new construction, additions and renovations
- 6 to existing buildings shall meet the requirements of the North Carolina State Building Code. All applicable volumes
- 7 of The North Carolina State Building Code, which is incorporated by reference, including all subsequent
- 8 amendments, may be purchased from the North Carolina Department of Insurance Engineering Division for
- 9 \$653.25.
- 10 (b) Each facility in which overnight respite services is provided shall be constructed, equipped and maintained to
- provide the services offered.
- 12 (c) Any existing building converted from another use that the adult day care program intends to use for overnight
- 13 respite services shall meet all the requirements contained in this subchapter and the requirements for a certified adult
- 14 day care program as specified in 10A NCAC 06R.
- 15 (d) For any overnight respite care services program that was terminated by DHSR pursuant to Section 1(c) of S.L.
- 16 2011-104, if the space remains terminated for at least 60 days, the space shall meet all applicable requirements for a
- 17 <u>new service facility prior to again being allowed to offer services.</u>
- 18 (e) Any existing adult day care program intending to offer overnight respite care services that is planning new
- 19 construction, remodeling or physical changes done to the facility shall have drawings submitted by the owner or his
- 20 or her appointed representative to the Construction Section for review and approval prior to commencement of the
- 21 work.
- 22 (f) If the building to be used for overnight respite care services is two stories in height, it shall meet the following
- 23 requirements:
- 24 (1) construction, shall not exceed the allowable area for occupancy in the North Carolina State
- 25 Building Code;
- 26 (2) residents shall not be housed on any floor above or below grade level; and
- 27 (3) required resident facilities shall not be located on any floor above or below grade level.
- 28 (g) The basement and the attic shall not to be used for storage or sleeping.
- 29 (h) The ceiling shall be at least seven and one-half feet from the floor.
- 30 (i) Steps between levels are not permitted.
- 31 (j) The door width shall be a minimum of two feet and six inches in the kitchen, dining room, living room,
- 32 bedrooms and bathrooms.
- 33 (k) All windows shall be maintained operable.
- 34 (1) The local code enforcement official shall be consulted before starting any construction or renovations for
- 35 <u>information on required permits and construction requirements.</u>
- 36 (m) The building shall meet sanitation requirements as determined by rules adopted by the Commission for Public
- 37 Health.

1	(n) The building shall have current sanitation and fire and building safety inspection reports which are maintained
2	in the facility and available for review.
3	(o) A complete fire alarm system with pull stations on each floor and sounding devices which are audible
4	throughout the building shall be provided. The fire alarm system shall be able to transmit an automatic signal to the
5	local emergency fire department dispatch center, either directly or through a central station monitoring company
6	connection. The fire alarm system shall be installed in accordance with National Fire Protection Association
7	(NFPA) 72, which is incorporated by reference with all subsequent amendments and can be obtained from the
8	National Fire Protection Association, 1 Batterymarch Park, Quincy, MA 02269 at the cost of \$79.00.
9	(p) The facility shall be equipped with a wet pipe sprinkler system in accordance with NFPA 13, which is
10	incorporated by reference with all subsequent amendments and can be obtained from the National Fire Protection
11	Association, 1 Batterymarch Park, Quincy, MA 02269 at the cost of \$79.00.
