RE: Proposed Amendment of Acute and Home Care Licensure and Certification Rules

10A NCAC 13B and 10A NCAC 13C

GS 150B-21.2 requires a rule-making body to notify certain individuals of its intent to adopt a permanent rule. It also requires notification of the date, time and location of the public hearing on the rule and any fiscal note that has been prepared in connection with the proposed rule.

Session Law 2015-241, HB97, s.12A.15(a) known as the "Health Care Cost Reduction and Transparency Act Revisions" requires the N.C. Medical Care Commission to adopt rules to implement the provisions of the section of the Session Law. This law revised G.S. 131E-214.13 to require annual data reporting. Temporary rules were promulgated by the agency in response to these statute changes that became effective 3/31/16. These proposed rules are part of the process of making these permanent rules replace the temporary rules in accordance with G.S. 150B-21.1(d)(5). Accordingly, the Commission has submitted form OAH 0300 to the Codifier of Rules, Office of Administrative Hearings, indicating its intent to proceed with the following rule-making actions:

10A NCAC 13B Licensing of Hospitals

10A NCAC 13B .2102 Reporting Requirements (Amend)

10A NCAC 13C Licensing of Ambulatory Surgical Facilities

10A NCAC 13C .0206 Reporting Requirements (Amend)

The Office of State Budget and Management reviewed the rule change and in accordance with G.S. 150B-21.4, determined the rule change has little to no impact on state or local governments and no substantial economic impact; therefore, a fiscal note is not required.
