RE: NC Register Republication Proposed Readoption 10A NCAC 13P Emergency Services and Trauma Rule

GS 150B-21.2 requires a rule-making body to notify certain individuals of its intent to adopt a rule. It also requires notification of the date, time and location of the public hearing on the rule and any fiscal analysis that has been prepared in connection with the proposed rule. The proposed rule readoption is a result of the periodic review of the Subchapter 10A NCAC 13P rules, thereby necessitating all rules determined as "Necessary With Substantive Public Interest" be readopted.

The North Carolina Medical Care Commission has determined there is a substantial change following the comment period for one of the proposed readoption rules published as a repeal in 30:24 of the NC Register on June 15, 2016. GS 150B-21.2(g) requires a rule-making body to republish a rule in the NC Register and accept comments if the rule differs substantially from the text of the proposed rule in the NC Register.

Therefore, the North Carolina Medical Care Commission has submitted form OAH 0300 to the Codifier of Rules, Office of Administrative Hearings, indicating its intent to proceed with the following rule-making action:

Republish the following rule:

10A NCAC 13P .0203 Spec

Special Situations

(Readopt with Substantial Changes)

The fiscal analysis approved by the Office of State Budget and Management on April 25, 2016 in accordance with accordance with G.S. 150B-21.4 was revised to reflect the substantial change text to rule 10A NCAC 13P .0203. These revisions were approved by the Office of State Budget and Management on September 14, 2016 identifying no change in fiscal impact; therefore no fiscal note is needed for this rule.
