RE: Proposed Readoption of Jails, Local Confinement Facilities Rules – 10A NCAC 14J

GS 150B-21.2 requires a rule-making body to notify certain individuals of its intent to adopt a rule. It also requires notification of the date, time and location of the public hearing on the rule and any fiscal note that has been prepared in connection with the proposed rule. These rules are being readopted as a result of the periodic review of the Subchapter 10A NCAC 14J rules, thereby requiring rules determined as "Necessary With Substantive Public Interest" be readopted.

With input from stakeholders, 32 rules are proposed for readoption with substantial revisions for the operation, design, and construction of county government owned and operated jails and district jails. One rule is *proposed for readoption as a repeal because it is duplicative and not necessary.

The North Carolina Department of Health and Human Services/Secretary has submitted form OAH 0300 to the Codifier of Rules, Office of Administrative Hearings, indicating its intent to readopt the following 33 rules:

10A NCAC 14J .0101-.0103, .0201, .0203, .0204, .0301-.0303, .0402-.0405, .0501, .0601, .0702, .0705, .0904, .1001, .1002, .1201-.1203, .1207, .1210, .1212-.1215, .1218, .1219, .1225, and .1226.

In accordance with G.S. 150B-21.3A(d)(2), a fiscal analysis was prepared for the rules with substantive change. In accordance with G.S. 150B-21.4, the Office of State Budget and Management approved of the fiscal analysis for these rules on September 19, 2017, and approved the revised version of the fiscal analysis due to rule typographical changes on October 25, 2017.
