Ms. Gurlitz, thanks so much for returning my call yesterday. I really appreciate the jail and detention branch taking a more proactive role in revising the standards. Yesterday we discussed section .0600-Supervision more specifically on page 2 line 18 where it reads "*When an officer is assigned to supervise inmates as required by ..... as we discussed the county board of commissioners by NC statute are responsible for funding the jail and the Sheriff is responsible for the operations. My suggestion would be under this revision of the standards should the BOC not fund the required positions to satisfactory comply with this standard that when a ROD is sent from your section to the county that the county IE: County manager, Chairman of the Board be the one responsible to reply to the ROD with their corrective action plan for that particular standard rather than the Sheriff/Jail Administrator.*

Having been a Jail Administrator myself and now working for an Criminal Justice A/E firm I honestly think you will get a much better response and accomplish what you are needing to accomplish should they be the one to have to reply with the corrective action plan rather than the Sheriff or JA who have no authority to create or add new staff positions.
