RE: Proposed Temporary Adoption of Rules for the Licensing of Adult Care Homes of Seven

or More Beds and the Licensing of Family Care Homes

GS 150B-21.1 requires a rule-making body to notify certain individuals of its intent to publish a temporary rule on the Office of Administrative Hearings website. It also requires notification of the date, time and location of the public hearing on the rules.

The N.C. Medical Care Commission has submitted form OAH 0700 to the Codifier of Rules, Office of Administrative Hearings, indicating its intent to adopt the following rules with temporary procedures for infection control practices due to COVID-19:

The public hearing is scheduled for November 4, 2020 at 10:00 a.m. by teleconference using the phone number 1-877-848-7030 and Access Code: 5133201. Ms. Nadine Pfeiffer, DHSR Rule-Review Manager, is accepting public comments on these rules from October 23, 2020 through November 16, 2020. Comments can also be made on the teleconference public hearing. The proposed effective date of these temporary rule adoptions is December 30, 2020.
